

## Reset Recovery House Rules

- 1. Zero Tolerance** for drug or alcohol use. (No engaging in illegal substance manufacturing, possession and/or distribution will be tolerated.) Random drug testing is mandatory.
- 2. Zero Tolerance** for stealing. (Taking food from others without permission is considered stealing. We encourage community cooking, meal planning and sharing dinner time together. This is to assist in developing a family like structure.)
- 3. Zero Tolerance** for destruction of House or other residents' property.
- 4. Zero Tolerance** for sexual activity between residents.
- 5. Zero Tolerance** for physical confrontation or verbal confrontation with any staff or resident.
- 6.** Any resident who is on prescribed medications must immediately inform the house manager, the house manager must approve all medication. All medications must be taken as prescribed.
- 7.** As a member of a recovering community, based on the principles of honesty, trust and helping to create a safe and sober environment, we request any resident who knows that another resident has violated any rules of the home report the behavior to staff.
- 8.** Any visitor to the property will be asked to leave immediately if staff or residents suspect any use of illegal or illicit drugs, including alcohol. Residents who have been asked to leave due to their own breach of rules will not be permitted back on the property.
- 9.** All residents must attend a minimum of one support group per week.
- 10.** Residents must have a sponsor/mentor within the first month and must commit to meetings with that sponsor/mentor as often as the sponsor/mentor requires.
- 11.** Residents must attend a mandatory House Meeting one time a week, every Sunday at 6:30 P.M.
- 12.** Residents must be willing to submit to a drug/alcohol urine screen upon the request of the manager.

- 13.** We request that a resident commit to a 6 month stay.
- 14.** Residents' rooms must be clean at all times. (Residents' beds are to be made when the residents are not in the bed.)
- 15.** Residents must sleep at the house each night unless prior arrangements have been made with staff.
- 16.** Residents are not permitted to have overnight guests. All visitors to the property must be approved by staff and must be off the property by 10:00 PM.
- 17.** There is absolutely no loitering in the front of the property.
- 18.** There will be no borrowing or lending between residents.
- 19.** Residents must be employed, enrolled in out patient treatment or enrolled in school within the first 30 days of living at the house.
- 20.** Residents not employed or in school must be off the property by 9 AM daily and return after 4 PM.
- 21.** Residents will participate in ongoing mandatory house chores.
- 22.** Residents must submit a weekly time management-planning schedule for the week. This will include a job search journal if the resident is currently seeking employment. This is due by the weekly house meeting.
- 23.** Because this is a sober living environment and we are to be working as a family unit, new applicants will be interviewed by residents and staff at house meetings.
- 24.** Rent is due on the first of every month. Late fees of \$25 will begin on the 3<sup>rd</sup> of the month, unless prior arrangements are made with the House Manager in advance.
