NO CHILDREN UNDER 18 YEARS ARE PERMITTED WITHOUT ADULT.

ALL PERSONS SHOULD SHOWER BEFORE ENTERING THE POOL.

NO GLASS ALLOWED IN POOL OR ON POOL DECK



NO PROFANE OR OFFENSIVE LANGUAGE

NO SPITTING OR BLOWING NOISE IN THE POOL

RESIDENTS AND GUEST MUST CLEAN UP AFTER USE

GATE SHOULD BE CLOSED AT ALL TIMES—DO NOT PROP THE GATE OPEN

- If you have lost your card there is a \$35 replacement fee
- Pool opening at the end of May pending repair of the water problem and approval of Dekalb County inspector.

SBHA COLLECTION POLICY

The Collection Policy has been adopted by the Stonebreeze Board of Directors to establish a systematic, non-discriminatory, procedure for the collection of dues, and if necessary, any special assessments payable to the Association. The policy also includes the assessment of late fee, code violation fines, return check service charges, and



legal fees associated with the collection of funds on behalf of the Stonebreeze Homeowners Association (SBHA). If you are not able to pay your dues all at once, owners should contact a board member to establish a payment plan to avoid collection procedures.

Annual Due Dates. dues are payable in one installment on or before March 31st. A late fee of \$40 will be assessed.

 Accounts two years or more past due will be sent to collection.
