- The Core Dividend Strategy includes individual holdings from the firm's Dividend Equity and Dividend Growth Strategies
- Top-down approach that emphasizes sector selection based on economic and market cycles
- · The portfolio includes low correlated securities
- The portfolio manager has 17 years of experience in dividend equities and 28 years in asset management







The Russell 1000 Index is constructed to provide a comprehensive and unbiased barometer for the large-cap segment. During 2015, the Strategy's benchmark was the Russell 1000 Value. Index.
