Reports:

Mayor Hardin reported that she would like the Depot sidewalks salted and sanded. Daryl will be putting up a barricade at the north sidewalk of the Depot due to the ice.

Gerlach will be following up next month with the bids for the fire station gutters and floor waxing. He mentioned that he would like the snow removal to start earlier and continue on until cleared and before it freezes. Frett agreed that it is easier to move snow while it is soft.

Daryl reported that there were issues at the water tower due to the extreme cold weather. Daryl and James Connolly, the water operator believes that building a structure around the boxes will help keep it warm and prevent this from happening in the future.
