Mayor Hardin discussed various grants that the town can apply for. The ECIA community catalyst grant would be to help with the old restaurant renovations that is located downtown. The CDBG is available to help purchase new lamp posts for downtown. The RCTP grant is for street projects. For all of these grants, a city match would be required.

A motion to apply for all of the grants was made by Jebsen with a second by McDermott. All ayes.

Reports:

Jebsen reported that for the disc golf to begin, the town will have to have the land surveyed West of the depot. At that time, he is requesting a survey of the lot abutting his property to be completed as well. He will pay for his portion of the surveying bill.

Daryl brought up where we are getting our diesel fuel and mentioned that the company will be changing hands. Gerlach brought in the bid for gutters for the fire station and will take care of scheduling the work.

McDermott mentioned there were complaints about sidewalks not being shoveled in town. This issue has been resolved because the home ownership has changed hands.
