Clean Up Days is scheduled for May 15<sup>th</sup> & 16<sup>th</sup> from 8-5 on both days. Republic Services has cancelled all Clean Up services for the month of April due to Covid-19. Council noted a possibility for May Clean Up to be cancelled as well, but will wait and see.

A motion to give the City Clerk her pay raise after the 90 day time period was approved by McDermott with a second by Frett. All ayes. Mayor Hardin noted the wage will be evaluated again in 90 days.

A motion to approve the purchase agreement of the Old City Hall building was made by Gerlach with a second by McDermott. All ayes. There will be a Special Meeting held April 16<sup>th</sup> in regards to this.

Reports – Jerry reported that a curb box broke and during repair a lead pipe was found and was replaced. The culvert east of town was also dug up and cleaned out. Gerlach commented on the maintenance shed clean up and questioned why it was done on a weekend and not during the week. Further discussion led to wanting an accounting of city workers tasks completed during the week. McDermott reported that the sidewalk on the North part of the Catholic church needs repaired. Mayor Hardin stated that the city will pay for the cement and the church would have to do the labor. Mayor Hardin noted that Doug Goodall's reports are available to read.

At 6:18 p.m. a motion to adjourn was made by Simmons with a second by McDermott. All ayes.
