The city clerk will be looking into refinancing the USDA loan. In regards to the ECIA grant, the clerk will also be scheduling work on Main street to begin in June of 2021.

### Reports:

Tom reported that the city should consider getting a generator for the lagoon. With the recent storm, some towns were without one and we could avoid this issue if we had one in place. He also reported that there's uneven pipe sizes being used for storm water. This should be addressed as well to prevent a larger problem in the future. Daryl is getting estimates for grinding of the trees that fell during the storm. He mentioned the transmission in the truck needs repaired and will follow up with the company the replaced it. He also said the skid loader needs new tires. McDermott mentioned that the storm drain is plugged by Casey's. Daryl will be checking all storm sewers in town.
