A public hearing date is set for March 10th, 2021 to approve entire Fiscal Year 2022 budget.

There has been no follow up with the Dewitt library.

Greg Gannon from the LincolnWay Community Foundation spoke on behalf of the Foundation. He gave an overview of their organization and some financial goals they would like to meet with the help of the Delmar community. This will be voted on during next month's meeting.

All council members and the mayor have been assigned new individual city emails for correspondence.

The new Clinton County Sheriff, Bill Greenwalt and Sergeant Jessup Schroeder attended the council meeting. The sheriff spoke briefly on goals that he has and also passed out contact information for his department.

Tim Carlson attended the meeting and requested clarification on the city building permit and its limitations.

## Reports:

Daryl reported that the maintenance department will be purchasing new tires for the mule and also a grease gun. He was asked to remove mounds of snow at Casey's and asked the council for their input. The council decided that it should be done because it is a hazard to drivers.

Frett mentioned concern with the bus barn wear and tear on the alley way and usage of Grossman Hall parking lot when backing the buses out. He also mentioned different vehicles that are without license plates or in front yards of houses.

McDermott mentioned visibility concerns in regards to the snow and street corners in town.

Gerlach mentioned that council members should be the last people called to remove snow from streets. Daryl said	1

Jebsen reported that the city has a generator to sell. He requested that Daryl get the information needed from it so	) it
