A motion to send a letter to cease ownership of rooster/chickens within 14 days due to violating permit ordinance at Weimerskirk's was made by Frett with a second by McDermott. All ayes.

A motion was made for the city to cease pool filling by the fire department was made by McDermott with a second by Frett. All ayes.

A motion was made for city maintenance to clean Hemphill ditch with skid loader by McDermott with a second by Mangler. All ayes.

A motion was made to get a quote from Don Kunde to re-dig Richland ditches if \$15,000 or less from the top down to fix the waterflow issues by Gerlach with a second by Frett. All ayes.

LouAnn Eberhart on behalf of Delmar Development requested to place/replace three Hometown Pride signs located by Depot shed (north), Norton Park, and pickleball court. A motion was made by Frett to approve with a second by Gerlach. All ayes.

Reports:

Gerlach had received a verbal complaint, Mayor informed we need written to address any issues. Taliaferro reported noxious weeds in Ingersoll's property after the city had to mow due to Ingersoll's not following the grass cutting ordinance.
