Seth reported that the wastewater is running fine and that he will be moving forward with a smoke test throughout the sewer system in the next few weeks.

Dawn reported that there is a dead tree in the alley on city property that needs to be taken down. Brad will look into getting bids for this.

Dave mentioned that the mud jacking that has been done looks good.

Steve reported that the sidewalk in front of the mural wall is finished.
