The council reviewed the updated work that has been done on the employee handbook.

Mayor Hardin would like Dan to get bids for work to be done on Richland Street regarding the curb and gutter.

Reports:

Mayor Hardin asked that the council consider looking into hiring a different city attorney.

Gerlach asked that new lights be put up at the fire station entry doors. Dan will get options for them.

Jebsen asked that since wi-fi will be put up at the depot for security cameras, that the depot would have 'guest-access' to it.

Dan mentioned different issues that the city shed has and was instructed to get bids and bring them to next months meeting.

Seth reported that everything is running smoothly regarding the sewer and that he will be starting the DNR permit process soon.
