Mayor Hardin reported that the city is going to be offering an opportunity for the residents to have a flag placed in their yard during, and removed after, for the 5 official holidays for a cost of \$45.00 per year. This is available to anyone living in town. She also mentioned that the Labor Day Car Show went well. Jebsen reported that the mural wall project will be started the week of the 26th and may need lane or road closures during that time. He also reported that the 'grant street project' will probably not happen this year. Daryl reported that Triple J will providing estimates for the water and sewer extension south of town. They will also be looking at issues with Well #1 and Well #3. He will be taking the old city truck to the 64 Auction sale. Dan reported he would like to move the compost pile, get safety/city shirts for the maintenance workers and provide more tools for the department. McDermott reported that she was asked if the city needs more sand for the winter. Daryl thought the city was set for now. Sparky mentioned that a citizen wants to paint the fire hydrant next to their house and wanted to get the council's thoughts on the matter. Frett inquired about the new city truck.
