Green Belt Proposal at Jealott's Hill

What is it about?

Please come to our public meeting to hear guest speakers Richard Knox-Johnston, Chairman of the London Green Belt Council, and Chris Turrell, Executive Member for Planning and Transport Bracknell Forest Council, talk about the proposed housing development at Jealott's Hill, the importance of protecting the Green Belt, and to contribute your views to a discussion about the impact of the development on Bracknell's Metropolitan Green Belt. The meeting will be chaired by John Hudson, CPRE Berkshire Chairman, and there will be opportunities for Q & As.

Why is CPRE Berkshire organising this meeting? CPRE Berkshire is a registered charity which campaigns to promote, enhance and protect the county's countryside, the Green Belt and many rural areas for everyone's benefit, wherever they live.

We believe this proposal goes against the primary aim of Green Belt policy to prevent urban sprawl; threatens its 'openness'; and goes against the current national policy guidance which states that only in 'exceptional circumstances' should there be changes to the Green Belt boundaries.

We recognise and acknowledge Bracknell Forest

Council's previous commitment to protecting the Green Belt and acknowledge their efforts to focus housing development on brownfield sites. However, this new proposal for an inappropriate development of 4,000 homes at Jealott's Hill sited in Green Belt land is not acceptable. The proposal clearly states that in order to build these houses, land at Jealott's Hill will be removed from the Green Belt designation and the Green Belt boundary redefined. If this goes ahead, it will be an irreversible loss.
