Let us hope this is the last time we have to go through that and by the summer we can all be together with our extended families and loved ones.


We now know that the Council is planning to produce their Submission Draft of the Local Plan in late March and this will be the subject of a public inquiry later in 2021. See http://democratic.bracknell-forest.gov.uk/mglssueHistoryHome.aspx?lld=98106.

We are certain this draft WILL include the infamous policy LP7 which is designed to enable the development of the Syngenta site with between 3,500 and 4,000 houses over a 25 year period. It is clear from recent documents published by the Council, as part of the plan evidence base build up, that none of the land at Jealott's Hill (the Syngenta site) is required to meet the Council's identified need for housing in the period 2020-2037.

We need to fight this plan at the Public Inquiry if we are to stop this development. We will be up against a swathe of legal and professional planning advisors who will represent the Council, Syngenta and various other interested parties, all of whom stand to gain massively should this development go ahead.

Where are we now

- 1. We believe that between £80,000 and £100,000 could, in total, be required to fight this attempt to extinguish such a valuable piece of the Green Belt in Warfield.
- 2. This initial appeal is for a funding level of £25,000 which will be needed to obtain preliminary legal and planning guidance which must be committed to over the coming 3 months.
- 3. We have a bank account with Barclays in Windsor. Details are on the "Donate" page of our website (https://savejealottshill.com/donate).



Use of Funds

- 1. We will use funds collected only for very specific and clearly identified purposes.
- 2. The Committee members will not take any remuneration or fees for their services from the funds collected although properly vouched and approved expenses solely and necessarily incurred in pursuit of the campaign may be reimbursed if they were approved by the Committee in advance.
- 3. Proper accounting records will be maintained and regular reports will be issued and published on the website to account for income and expenses.
- 4. The constitution of the campaign provides that the Committee may only commit to expenses if it has sufficient funds on hand to meet the expenses. The committee is not empowered to run up any debt which exceeds the available funds.
- 5. At the end of the campaign if any funds remain unspent, these will be contributed to local charities and accounted for with the names of the charities in the final accounting.

The Committee anticipates expenses for

- 1. Professional fees for a Barrister to provide the following services:
 - (a) An assessment of the Submission Draft of the BFC Local Plan as it relates specifically to the Jealott's Hill proposal referred to in the consultation draft as Policy LP7.
 - (b) Counsel's Opinion as to the likelihood of success in a challenge to Policy LP7 at the Examination by the Planning Inspectorate.
 - (c) Preparation of the necessary "proofs" which Counsel will require in order to support the campaign case at the Examination in the form of expert evidence from appropriate professional consultants.

- (d) Represent the Campaign at the Examiner hearing when any and all matters affecting Policy LP7 are considered.
- 2. Professional fees for such consultants and/or other expert witnesses as may be deemed necessary by Counsel.
- 3. Incidental expenses associated with preparation of the case including secretarial, copying and other clerical tasks.
- 4. Should funds allow, it may be advisable to retain a Solicitor to handle instructing Counsel and preparation of the proofs etc and to attend the Examination hearings.
- 5. In all cases the committee will seek to agree, where possible, a set fee for the services provided above so that there is, as much as possible, certainty as to the final costs in each case.

What We Need from You

- 1. We need your financial support if we are to procure professional advice and representation at the forthcoming examination of the BFC Draft Development Plan by the Planning Inspectors.
- 2. Tell your friends and family about the fundraising campaign, and ask for their financial help, whether they live locally or further afield.
- 3. Spread the word among any local bodies with whom you are associated and whose members might be, in some way adversely, affected by this development when, for example, lanes and public rights of way or bridleways for horse riding are extinguished by the development.

- 5. Actively engage with the upcoming consultation to be run by the Council when the Draft Plan is published. We will help you with this by providing grounds for objection and wordings once the draft is released for consultation.
- 6. When you submit an objection to LP7 ask to be heard by the Inspector at the inquiry.
