

Origin: Detachment Executive Committee

Submitted by: Detachment Judge Advocate PNC Jeff Frain Squadron 27

WHEREAS, The Detachment of Arizona, Sons of The American Legion is structurally modeled after The American legion Department of Arizona with regards to operational functionality, where possible; and

WHEREAS, The Detachment of Arizona, Sons of The American Legion operates as a program and subsidiary of the Corporation: The American Legion Department of Arizona, Inc. and follows their corporate guidelines; and

WHEREAS, The Corporation: The American Legion Department of Arizona, Inc. has requested the following changes to abide by their financial and accounting procedures; now, therefore, be it

Resolved, by the members of The Sons of The American Legion Detachment of Arizona in regular meeting assembled at Dead Horse Ranch State Park, Arizona, April 20th, 2024, that the constitution of The Sons of The American Legion Detachment of Arizona Article 10 Section 4 be stricken as current and replaced with the following:

"Article 10 - Section 4

The annual Detachment budget for the following fiscal year is prepared by the Detachment Finance Officer and the Detachment Adjutant and submitted to the Detachment Finance Committee. A Detachment Finance Committee meeting on the budget is to occur no less than two weeks before Detachment State Convention.

The Detachment Finance Committee is responsible for deliberation and approval of the submitted budget proposal. If the budget proposal is rejected it is sent back to the Finance officer and Adjutant for revisions and resubmittal to the Finance Committee.

After approval by the Detachment Finance Committee the budget will be presented before the Department Finance Committee at State Convention by the Detachment Finance Officer and/or the Detachment Adjutant for Department Finance Committee review before being submitted to the Detachment Executive Committee.

The Detachment Executive Committee is responsible for deliberation and final budget approval (pending final approval of the Legion DEC).

The Finance Committee will meet in advance of the Detachment Executive Committee meetings of Detachment State Convention, Detachment Fall Conference and Detachment Camp Out to review report by the Detachment Finance Officer and/or the Detachment Adjutant (report as approved by the Department Adjutant Corps and/or the Department Finance Committee and/or the Department Finance Committee Chairman) and forward report to the Detachment Executive Committee on current financial state of the Detachment.

An annual report on Detachment Finances (report as approved by the Department Adjutant Corps and/or the Department Finance Committee and/or the Department Finance Committee Chairman) shall

be given to the body at Detachment State Convention by the Detachment Finance Officer and/or the Detachment Adjutant.

Special Finance Committee meetings may be called by the Detachment Commander, the Detachment Adjutant, the Detachment Finance Officer or the Detachment Finance Committee Chairman as needed. The Department Adjutant Corps and/or the Department Finance Committee Chairman also may call a Detachment Finance Committee meeting to relay Department request to Detachment."

Also be it resolved, by the members of The Sons of The American Legion Detachment of Arizona in regular meeting assembled at Dead Horse Ranch State Park, Arizona, April 20th, 2024, that the Bylaws of The Sons of The American Legion Detachment of Arizona Article 6 Section 1 be stricken as current and replaced with the following:

"Article 6 - Section 1

All non-budgeted Detachment expenses or Detachment line-item budget overrides of \$750.00 or under may be approved by the Detachment Finance Officer and/or the Detachment Adjutant. All non-budgeted Detachment expenses or Detachment line-item budget overrides over \$750.00 but under \$1250.00 must be approved by the Detachment Finance Committee in meeting, by a majority roll call vote of all Detachment Finance Committee members in attendance. All non-budgeted Detachment expenses or Detachment line-item budget overrides in excess of \$1250.00 must be approved by the Detachment Finance Committee in meeting, by a majority roll call vote of all Detachment Finance Committee members in attendance and forwarded to the Detachment Executive Committee for meeting and then requires approval by a majority roll call vote of all Detachment Executive Committee members in attendance (if situation warrants, Detachment non-budgeted expenses or line-item budget overrides may also be approved by the Department Adjutant Corps and/or the Department Finance Committee and/or the Department Finance Committee Chairman). Such overrides shall be reported by the Detachment Finance Officer and/or the Detachment Adjutant to the Department Finance Committee at next meeting of said Committee (Fall conference, Detachment Campout or State Convention)."

Above changes take effect immediately upon passage, pending review and approval of the Department Executive Committee.

Resolved, by the members of The Sons of The American Legion Detachment of Arizona in regular meeting assembled at the El Conquistador hotel, Tucson Arizona, June 22nd, 2024, that the Constitution of the Detachment of Arizona have added to article III (Organization), a new section reading, "The Detachment Executive Committee has the power to divide the Detachment no less than three (3) Areas for the purpose of administration. And if desired the Detachment Executive Committee has the power to divide the Detachment into Districts for the purpose of administration. If the Detachment Executive Committee decides to use Districts, then the Detachment shall be divided into no less than five (5) Districts, and However, the Executive Committee may divide the Detachment into as many Districts and Areas as they deem necessary for effective administration. The Number and boundaries of said Districts and Areas may be increased or decreased within these limits by a majority vote of the Executive Committee, but no such changes shall be made without notice to the Squadrons concerned nor without affording such Squadrons an opportunity to be heard; nor shall such changes be made less than thirty (30) Day immediately preceding the time for the holding of the Detachment Convention.".
