The information gathered at your initial appointment will be analyzed, researched and consolidated and the **findings and recommendations will be presented to you at your next visit, one to two weeks after your initial appointment.** Here the most effective treatment plan will be discussed and refined to specifically fit your needs.

Recommendations may include additional testing, dietary, lifestyle, detoxification programs, herbs and supplements. Naturopathic Care is a financial investment; therefore, your budget is always considered when recommending additional resources and regimens.

After the follow up visit, it is strongly encouraged that patients return for bi-weekly or monthly follow ups until health concerns are adequately managed. This is the best way to ensure that your health goals are being met. **Visits scheduled in intervals longer than 90 days may be required to schedule two consecutive appointments in order to accommodate the time necessary to get up to speed and back on track.**
