Certification in EMDR Agreement

This is an agreement between Anchored Soul Counseling, LLC and _____ for Certification in EMDR. This agreement is for 20 hours toward becoming certified in EMDR. Certification consultation hours (20) are in addition to basic consultation hours (10), which must be completed before beginning certification consultation. Each consultee needs to have a clinical caseload to be in the certification track, have malpractice insurance and maintain proper licensure and supervision according to your professional state board.

Payment: It will be agreed that a fee of \$120 per meeting (1-hour block) will be charged and paid at the scheduled consultation meeting. A signed authorization must be kept up to date and all fees will be charged to the card on file at the time in which services are rendered. No other form of payment is accepted at this time.

Late Notice and Cancellation: All consultation sessions missed without notice or missed with less than 24 hours notice will result in a fee at the amount of the full consultation session rate of \$120.

Consultation: Each consultation will be ½ group and ½ individual with two consultees each time, unless an individual is set up in advance. If you did not train with EMDR Consulting, please note I can only certify trained consultees who hold an EMDRIA approved EMDR Basic training certificate. Approved EMDRIA consultees trained by other EMDRIA approved groups than EMDR Consulting may mean more consultation hours outside of the required 20 hours due to needed additional instruction which differs from other training. Additionally, 20 hours is required from EMDRIA as a minimum requirement. Work produced will need to meet the standard requirements for certification level. If additional hours are required, the agreement will need to be amended to include those hours.

Braiden Green, LPC-S will evaluate the consultee in various areas listed on the Addendum that the consultee will demonstrate EMDR Basic Training Skills in order to be certified. Anchored Soul Counseling, LLC and

The goals are for the consultee to know all aspects of the protocols and application of EMDR as the EMDR Institute and EMDRIA recommend.

The consultee will do the following:

1. Read EMDR Basic Principles, Protocols, and Procedures by Francine Shapiro and be familiar with the basic AIP model, the 8-phase protocol and other protocols.
2. Exercise good clinical judgment and reasoning when utilizing EMDR.
3. Accept feedback in a professional manner from Braiden Green, LPC-S.
4. Will be prepared with real life examples for consultation meetings in an organized manner to utilize time well.
5. Will prepare a live session example of an EMDR session using the 8-step protocol and all safety measures as outlined in the Basic Training to demonstrate fidelity of the EMDR Model. This must be done before or around the 5th meeting.

Braiden Green, LPC-S will do the following:

1. Give feedback on fidelity to the EMDR model with consultees.
2. Enhance the consultee's growth.
3. Will present each phase for clarification and review
4. Will convey any new information from EMDRIA and EMDR Institute.
5. Evaluate consultee and make recommendations for further study or knowledge including feedback from the videoed, live presentation.
6. Support consultee in problems as they arise and assist them in problem solving as problems arise.
7. Help consultee know ethical and legal issues, guideline and teach these to consultees as needed.
8. The hours accrued will be good for the duration of the agreement.
