

The Things You Should Know Before

Hiring a Tax Preparer

During tax season, Arizona's Department of Revenue urges taxpayers to do their homework when selecting a tax preparer. Your tax return is ultimately your responsibility, no matter whether you prepare it yourself or hire an accountant.

Tax preparation services were used by over half of tax filers in 2021, according to the IRS. Although most tax preparers are proficient and qualified, there have been cases where fraudulent returns have been submitted or fraudulent tax refunds have been promised due to unwarranted changes to the tax return.

Is there anything I should know before hiring?

Are the training and certifications of the preparer up to date?

What is the preparer's experience with tax returns?

Review their past performance and business practices by checking their reviews and history. You can also check with your state's board of accountancy for CPAs. Check with the State Bar Association for attorneys. Ask about service fees and costs. Do not hire tax preparers whose fees are based on their clients' refunds and avoid preparers boasting about higher refunds.

Choose a tax preparer who is available all year long. You can contact the tax preparer after tax season if you have questions about the return.

During an examination by ADOR or the IRS, will the preparer explain how the return was prepared?

Any refund should be deposited into your account, not the preparer's.

Taxpayer responsibilities:

You should receive a copy of the entire return, including copies of all schedules, especially itemized deductions or credits.


Make sure you understand your return and ask for explanations of any deductions, credits and wages you claim.

Make sure the preparer signs the return and lists their preparer tax identification number (PTIN).

Verify that numbers and schedules on the tax return match those on the tax preparer's source documents before signing and submitting the return.

For a more accurate and faster return, ask the preparer to electronically file your return. Tax preparers who do taxes for more than ten clients must use electronic filing.



Colorectal Cancer Awareness

According to the CDC: Regular screening, beginning at age 45, is the key to preventing colorectal cancer (cancer of the colon or rectum). If you're 45 to 75 years old, get screened for colorectal cancer regularly. If you're younger than 45 and think you may be at high risk of getting colorectal cancer, or if you're older than 75, ask your doctor if you should be screened.

Fast Facts

- Among cancers that affect both men and women, colorectal cancer is the second leading cause of cancer deaths in the United States.
- Every year, about 140,000 people in the United States get colorectal cancer, and more than 52,000 people die of it.
- Precancerous polyps and colorectal cancer don't always cause symptoms, especially at first. If you have symptoms, they may include blood in or on the stool, abdominal pain that doesn't go away, or losing weight and you don't know why. If you have any of these symptoms, see your doctor.
- There are several screening test options. Talk with your doctor about which is right for you.
- Only about two-thirds of adults in the United States are up-to-date with colorectal cancer screening.

Types of Screening Tests for Colorectal Cancer

Several tests can be used to screen for colorectal cancer, but the most important thing is to get screened, no matter which test you choose.

The tests can be divided into 2 main groups:

Stool-based tests: These tests check the stool (feces) for signs of cancer. These tests are typically done at home, so many people find them easier to have done, but they need to be done more often

- Highly sensitive fecal immunochemical test (FIT) every year
- Highly sensitive guaiac-based fecal occult blood test (gFOBT) every year
- Multi-targeted stool DNA test (MT-sDNA) every 3 years

Visual (structural) exams: These tests look at the structure of the colon and rectum for any abnormal areas. This is done either with a scope (a tube-like instrument with a light and tiny video camera on the end) put into the rectum, or with special imaging tests.

- Colonoscopy every 10 years
- CT colonography (virtual colonoscopy) every 5 years
- Flexible sigmoidoscopy every 5 years

If you are a patient of Mariposa Community Health Center, you can call (520)281-1550 and ask about getting screened or speak with your provider at your next wellness visit.



SCV35 is officially a 1:1 School District

Santa Cruz Valley USD has officially moved into the digital age for all students preK through 12. Thanks to an Emergency Connectivity Fund (ECF) grant, 3000 Chromebooks recently arrived at the District warehouse for processing. The District has placed a priority on the elementary grade levels which are currently operating a 3:1 ratio. This shipment will bring that ratio to 1:1 meaning one Chromebook for every student. While the Chromebooks will remain in classrooms, this provides tremendous flexibility to staff for creating personalized lessons and learning opportunities and also taking advantage of new flexibility associated with instructional time.

When Steve St. Coeur, the district's Technology Coordinator, brought news of the ECF to the District Administration, it raised an immediate question of sustainability. However, reducing the replacement cycle to only two fiscal years makes planning easier.

After distributing the first 1103 Chromebooks to the elementary sites the District will use the remaining new Chromebooks to replace all student devices more than two years old.

This means all students will have an identical, touch screen model with no replacements needed until 2027. District Instructional Specialist Alex Palumbo explained, "Having all of the students working on the same, touch screen device makes instruction easier and more efficient for the teacher. Our intent here is to remove as many barriers as we can to allow for a more personalized and competency-based approach to student learning." -Shannon Enciso/Communication Specialist
