
#### Innovative Programs That Change Lives

# SOSA Summit Makes Debut in Nogales, Arizona

The first annual S.O.S.A Summit, which stands for Santa Cruz County Overcoming Substance Abuse, took place on January 14, bringing together community leaders, educators, law enforcement agencies, government officials, and advocates. Ms. Yara Castro, Director of Rural Health Strategies at Mariposa Community Health Center, coordinated the event with the help of SEAHEC and the Santa Cruz County School Superintendent's Office. This collaborative event aimed to foster a common vision to combat substance abuse and build a stronger, healthier community through prevention, treatment, and recovery.

This year's keynote speakers, Ari Sloane, and Jason Bentley, delivered a compelling presentation on the Struggle Well Program, an initiative focused on helping individuals and communities turn adversity into post-traumatic growth. Their message inspired participants to approach challenges with adaptability and strength. The summit also featured ten breakout sessions covering topics ranging from building resilience to analyzing local substance abuse statistics. The day included testimonials from individuals in recovery as well as a drumming session led by Mr. Gustavo Lozano of BorderBeatz.

Over eighty attendees left the summit equipped with new tools, connections, and a shared commitment to overcoming substance abuse in Santa Cruz County.


There is no doubt that our young scholars' values and skills will serve them well in their future endeavors. As we look towards the future, our excitement is heightened for the great accomplishments ahead.

#### Are you considering weight loss drugs?

Did you know? According to the International Food Information Council (IFIC)

1. 4 in 10 Americans are currently trying to lose weight.

More Americans believe that what and how much they eat, and drink has the biggest impact on their body weight compared to when, why, and where they eat and drink.

2. 3 in 10 Americans say they have heard "a lot" about prescription drugs for weight loss.

3. More than 4 in 10 Americans are interested in taking a prescription drug for weight loss; among those who have heard about prescription drugs for weight loss, most report hearing an equal amount of positive and negative information.

4. Nearly half of Americans think that taking a prescription drug for weight loss would increase their water intake, healthfulness of food choices, as well as their fruit and vegetable consumption.

#### What can you do?

1. First and foremost: Talk to your primary health care physician (PCP) about weight loss options for YOU. It is important to consider your entire health profile, including your medical history, current medications & their potential side effects, your mental health and lifestyle factors.

2. Medication is just another tool in the toolbox not the solution. Weight loss medications are most effective when combined with making healthy lifestyle changes.

3. Consider changing your eating to a healthier, affordable and sustainable diet for you.

4. Be active: Remember when you start eating less than you used to this can cause your metabolism to slow down. To increase our metabolism exercise is the key.

5. Serving sizes: Consider watching your serving sizes. Portion and serving sometimes are used interchangeably. Your serving sizes are within your hand size to make things easier. Your portion size is what you would like to serve yourself. 6. Choose water as your main drink. Skip all the sugary drinks.

7. Add more fiber to your diet. Having more veggies with your meals, have a fruit as a snack, go for whole grains, add nuts and seeds to your diet. And, add more fiber: Choose one of these to have daily, flax seeds meal, chia seeds, hemp seeds and Metamucil no sugar added.

8. Have a protein food with each of your meals. Add a protein food examples like nuts and seeds or nut butters added to your snack option. Protein tends to add fullness and satiety.

9. Mind State: How are you with flexibility, resilience, addressing problems as they come and solving them, dealing with food noise during your weight loss journey? Find a therapist to help you. 10. Do you have a goal?
