### **Range Regulations**

Please check the calendar and email for upcoming events that may affect the range. Thank You.

The Three Rivers Chapter operates its ranges for the safe enjoyment of target shooting by its members. The range safety committee, its range officers under the direction of the chapter president, and the board of directors are responsible for the safe operation of the ranges.

#### **Hours**

- 1. Range hours: Monday thru Friday: 9:00 am to 7:00 pm or sunset, whichever occurs earlier Saturday: 9:00 am to 6:00 pm or sunset, whichever occurs earlier Sunday: Noon to 5:00 pm or sunset, whichever occurs earlier
- 2. Other planned activities on the grounds may necessitate occasional range closures. Please check your email..
- 3. A range officer or board member may determine to close the ranges at any time for safety reasons and will give as much notice as is practical. Such notice may be limited to the posting of a written or verbal notice.
- 4. Compliance with any such notice is mandatory and non-compliance may result in temporary or permanent loss of range privileges.

#### Rules

- 1. Safety is paramount!
  - a. A Range Officer is the authority in safety enforcement and may eject a shooter from the range for cause if he/she is not a member, feels that the individual has created an unsafe condition on the range or refuses to abide by the officers request to correct the problem.
  - b. Fully automatic weapons not allowed.
  - c. Weapons should not be taken from their cases unless you are within a safe shooting location.
  - d. Keep all guns unloaded, pointed in a safe direction down range and finger off the trigger until you are prepared to fire.
  - e. Ear and eye protection must be worn by everyone that is in or near the shooting range. However, do not wear hearing protection when moving forward of the shooting line.
  - f. It is the shooter's responsibility to be aware of and adhere to all posted safety signs and rules.
  - g. A loaded firearm shall never be left unattended.
- 2. Target holders are furnished by the League.
  - a. You may choose to use your holders if you wish.
  - b. Firing your weapon into the trees, at the ground, at or near the water is not permitted.
  - c. Cross-range firing is not permitted.
  - d. Firing over the berm is not permitted.
  - e. State and Federal laws apply to our league property.
- 3. All ranges are only to be utilized for members over the age of 21.
- 4. A spouse of a member may shoot if they have a family membership together.
  - a. A family membership is defined as a member and spouse living at the same address.b. Children under the age of 18 years are not permitted to shoot any firearm on League property unless they are supervised by a
  - b. Children under the age of 18 years are not permitted to shoot any firearm on League property unless they are supervised by a parent or are a class participant during one of our age appropriate supervised workshops
  - c. Anyone between the ages of 18-21, except veterans of the armed services, must be supervised by a parent or range officer.
  - d. If any individual, between 18 and 21, wants to shoot on a regular basis, he or she must purchase a student or adult membership. (see membership guidelines).
  - e. All other individuals under the age of 21 and are not firing are not allowed on the firing range and must not advance beyond the shooting range parking lot.
- 5. Members may be asked to present their membership cards at the range.
- 6. If you encounter a dangerous situation or vandalism, leave the area and call a board member.
  - a. Personal descriptions, license numbers or any other information are valuable in identifying the individual.
- 7. Members range privileges are subject to cancellation for rule violations, unsuitable behavior or safety incidents. Reimbursement will be sought for any willful damage to the League's property.
- 8. Persons other than the shooter must remain behind the bench until it is their turn to fire. Spectators must be behind the boundary markers of the parking lot.
- 9. Horse play, drugs, alcohol or persons under the influence are prohibited from the range.
- 10. Parents are expected to supervise their under age children at all times.
- 11. Holstered and/or concealed weapons are not permitted outside of the pistol range or on the grounds unless they possess a valid Iowa carry permit or by law enforcement officers.
- 12. Armor piercing, incendiary, tracer, chemical and explosive projectiles, or devices designed to fire or propel explosive, incendiary or chemical projectiles are prohibited.
- 13. Range etiquette: "If you brought it in, take it out." Police your brass, shells, cans, etc.
- 14. Vehicles are prohibited from driving on private property west of Range parking lot.
