BOARD MANAGEMENT POWERS OVER "TRIBAL COUNCIL"

(Supporting Documents Attached)

HISTORY OF NONPROFIT CORPORATION

On May 16, 2015, Fred Simon held a family meeting of individuals who had been vetted for membership on his "Tribal Registry," his sole Intellectual Property. A "Tribal Council" was "elected" (comment: without any authority for such an election, nor following any legal guidelines). An agreement was made to "re-organize" the Lac Noir Tribe (see handwritten notes dated 5/16/15)

On 6/06/2015, the "Tribal Council" agreed to follow the "draft constitution" which Fred Simon has developed. Officers were elected: Fred Simon (Chief), Belinda Brooks (Asst), Belinda Smith (Secretary), Ruby Gray (Treasurer). It was motioned and voted that a non-profit would be formed to "re-establish tribe of Natchitoches" and that Fred Simon's address was to be used for the "headquarters" and that Fred Simon would be in charge of the non-profit. The name of the tribe would be "Lac Noir Black Lake Tribe of Louisiana" (see handwritten notes dated 6/06/15).

Articles of Incorporation were notarized on 11/18/2015, signed by sole Incorporator Fred D. Simon, with initial Directors: Belinda Brooks, Ruby Gray, Belinda Smith. Corporation name: Lac Noir Black Lake Tribe of Native Americans of Louisiana ("Lac Noir"). Corporation main address: 305 Third Street, Pioneer, LA 71266.

On June 17, 2016, Fred Simon filed for a sole proprietorship Business, with the Louisiana Secretary of State for the name of "Natchitoches Tribe of Louisiana" for his "Tribal Registry" functions. On that date, Fred Simon agreed to license the use of his Business name of "Natchitoches Tribe of Louisiana" ("NT") to the nonprofit corporation (See "State of Louisiana Name Change Amendment "Date Amendment Adopted 6/17/2016; Manner of Adoption "No shareholders, unanimously approved by Directors").

On January 1, 2017, a combined meeting was held with Tribal Council, Board Members of "Lac Noir" Nonprofit Corporation, and Fred Simon, also representing the "Tribal Registry." Ruby Gray resigned as Treasurer. The Board members accepted the appointment of Peggy Smith for Treasurer, which also included "Lac Noir" Board membership. On February 13, 2017, the Tribal Council accepted resignation of Ruby Gray and the appointment of Peggy Smith.

Nonprofit Corporation name change on 7/20/2018: "Lac Noir" to "Natchitoches Tribe of Louisiana;" Board members and Officers remained the same as shown on State filed document dated 8/13/2018. Belinda Brooks (Vice-President), Peggy Smith (Treasurer), Belinda Smith (Secretary). Corporation main address: 305 Third Street, Pioneer, LA 71266

The corporation received the IRS 501(c)(3) Letter of Determination, dated 10/23/2018 in name of Natchitoches Tribe of Louisiana. Corporation address: P.O. Box 85, Campti, LA 71411-0000

Conflicts within the Board began after 501c3 status was obtained and Belinda Brooks resigned to form another tribe: "Butte Tribe of Bayou Bourbeaux." That tribe was incorporated on 4/06/2019. After that time, much disinformation was given out to the vetted individuals on the "Tribal Registry" including falsehoods about the credibility of the "Tribal Registry" to actually "prove" genealogy history. The Corporate FaceBook account was taken over by the Butte Tribe and they integrated some of the individuals on the "Tribal Registry" into their tribe.

Changes were made in Board members and reflected on Louisiana State Domestic Corporation Annual Report dated 1/12/2019: Fred Dale Simon (President), Janette Nelson (Vice-President), Belinda Smith (Secretary), Peggy Smith (Treasurer). Corporation main address: 305 Third Street, Pioneer, LA 71266. This composition remained throughout years 2020, 2021, 2022, and 2023.

In January, 2024, conflicts again occurred in the "Tribal Council" who were now told that they were a "separate 501c3) nonprofit" that had total control over their membership and authority to change the "constitution" in a manner which suited their wishes. Individuals on the "Tribal Council" claimed that they owned the "Tribal Registry" and were creating conflict to cause Corporate officers to resign. The Board Vice-President Janette Nelton resigned in early 2024, due to this conflict. This state of disruption continued throughout the year. The corporate secretary Belinda Smith was released on 12/10/2024 due to negligence in keeping accurate Board minutes. She was replaced by Kenneth Rachal, Sr., who was rejected by the "Tribal Council" as the first indication that the "Tribal Council" were not following corporate management any longer.

Changes made in Board members in 2024 (after corporation conflict caused by committee members of "Tribal Council") and reflected on Louisiana State Domestic Corporation Annual Report dated 1/12/2025: Fred Dale Simon (President), David Stevenson (Vice-President), Kenneth Rachal, Sr. (Secretary), Peggy Smith (Treasurer). Corporation main address: 305 Third Street, Pioneer, LA 71266

The State of Louisiana summary on Natchitoches Tribe of Louisiana, a Non-profit corporation, Charter number 42013374N, in good standing since 1/12/2016 to date of last annual report of 1/28/2025 show the same current Officers.

In year 2025, the "Tribal Council" continues to reject Corporate leadership, leading to situation where the Non-profit 501c3 status is threatened by "out-of-mission" fundraising activities. This has led to situation wherein the bank accounts have been comprised, and the Corporation had to close accounts. The current financial situation is dire.

MANAGEMENT BOARD

The Directors/Officers of the Non-profit Corporation of Natchitoches Tribe of Louisiana have always been the same officers who have handled the legal affairs of the "Tribal Council" which indicates that the "Tribal Council" functions under the legal authority of the Non-profit Corporation. As stated above, the very first Officer to ever be rejected occurred in December, 2024. All current board members and officers, including President Fred Simon, are being rejected by the "Tribal Council" who continue to spread false information.

There are two addresses of record for the Non-profit Corporation. Louisiana State prohibits the use of P.O. Boxes for corporate primary offices. That State address has always been the residence address of Fred Dale Simon. This address is not always appropriate for certain business nor convenient for the Treasurer. The second address of record is: PO Box 85, Campti, LA 71411. This is the address of record used for IRS 501(c)(3) business as well as the "Tribal Registry" members' (i.e., citizens of future Federal Tribe) enrollment. This address has been in use for corporate business since 2018, as shown on the Form 990-N.

All funds for "Tribal Registry" processes are directed to the support of the 501c3 nonprofit corporation. Fred Simon receives no income or salary for his continued volunteer work on the "Tribal Registry" despite what falsehoods are told.

Peggy Smith has been the Treasurer of the Non-profit Corporation, officially legally, since January 1, 2017. The 2nd address of record for the Non-profit Corporation was chosen for her convenience for bank duties. That P.O. Box is near her residence, which remains publically available through Louisiana State Annual Report: 140 Cox Street, Campti, LA 71411.

INVALIDITY OF CONSTITUTIONS

The "draft constitution" of 2015 was never ratified by the vetted individuals in the "Tribal Registry". The subsequent "re-edited" constitution of 2016 was never ratified by vetted individuals in the "Tribal Registry." A more complete historical discussion is found in the document posted on <u>https://natchitochestribeoflouisiana.org/</u> under section called: "Transparency: Application In Progress for 25 CFR Part 83" in the download "Governing Document."

This current discussion is focused upon the "illegality" of the behavior of the "Tribal Council" which is contrary to any truth being given to either of those constitutions as being formal legal documents of a Tribal Nation.

<u>*"Article IV Section 3:*</u> Tribal Council representatives shall be elected by voting members of each distinct family unit, the Chairman (Primary Chief) and Vice-Chairman will be appointed by the Tribal Council. All elected or appointed officials must be voting members of the Tribe."

ILLEGAL: "Distinct Family Units" have never been identified for voting purposes. There are more than a thousand members who have never been contacted nor given the right to vote for which of their family unit members they want to "govern" them. No methods have ever been set up by how the family unit can "give directions" to their "tribal representatives." Therefore, all current tribal council members are only people who live in the area and who are already in close relationships with each other. The current "Tribal Council" is more of a "cult" than a "Tribal Nation".

Nonprofit corporation difference (Louisiana Nonprofit Corporation Law RS 12:217): A nonprofit corporation Board, without members, is not voted upon by anyone but themselves. Once an incorporator (ie. Fred Simon) has appointed the Directors of the Board of the corporation, it is the duty of the Board to "recruit" more Board members, to "re-elect" themselves and to continue the mission of the non-profit with ByLaws, which change according to the needs of the nonprofit corporation. It is the responsibility of the Directors to appoint the Officers of President, Secretary, and Treasurer. The reports of the Officers are the manner in which Directors make their decisions.

The "Tribal Council" has always been under the direction of the Officers of the legally incorporated nonprofit organization. The funds used to support the activities of the "Tribal Council" have always come from the nonprofit corporation. The current illegal activities of the "Tribal Council" has forced a financial "shut-down" of the nonprofit organizaton until this conflict has been settled.

"<u>Article IV Section 4</u>: Tribal elections and appointments will be conducted by secret ballot and voting results shall be certified by an independent organization."

ILLEGAL: There have been no elections involving the entire vetted membership of the "Tribal Registry" which has involved the use of an "independent organization."

"Article IV Section 6 (F): The Tribal Council shall establish a Tribal Election Board, and appoint voting members, which shall be responsible for: Maintenance of a list of qualified voters."

ILLEGAL: There is not a "list of qualified voters" which can be used for this election process. This entire section suggests that the "Tribal Election Board" has the right to determine who will be allowed to vote. Perhaps this is why this "cult" has prohibited the active involvement of all vetted "Tribal Registry" members from participating.

These same issues exist in the 2016 constitution as well: 4.03, 4.04, 4.06(F)

EPILOGUE

The "Tribal Council" has never been more than a "committee" and holds no legal power to act as a nonprofit corporation Board of Directors. It cannot fund raise nor handle funds on its own as it does not have 501(c)(3) standing. It has always, since November 18, 2015, been under the legal umbrella of the Nonprofit Corporation. That legal protection is now being threatened, to the extent that a total restructuring of the 501c3 nonprofit corporation of the Natchitoches Tribe of Louisiana has to be undertaken in order to protect EVERYONE, including the individuals of the "Tribal Council."

In the final word, it appears that the strength of Chief Fred Simon has always been the guiding light of this organization. When his light and strength wavered due to medical problems, people with "personal agendas" attacked. He is still recovering from open heart surgery, throat surgery, and multiple other issues which he wanted to keep private. But, his very safety net of the legal nonprofit corporation is now being threatened. If this does not stop, there will be lawsuits brought against possible innocent people who have followed a wrong guide.





Section 3. Tribal Council representatives shell be elected by voting members of each distinct family unit, the Chairman (Primary Chief) and Vice-Chairman will be appointed be the Tribal Council. All elected or appointed officials must be voting members of the Tribe.

Section 4. Tribal elections and appointments will be conducted by secret ballot and voting results shall be certified by an independent organization.

Section 5. All election results and appointments will be published within ninety (90) days of the closing of each election or appointment.

Section 6. The Tribal Council shall establish a Tribal Election Board, and appoint voting members, which shall be responsible for;

A. Ensuring fairness and uniformity in Tribal elections.

B. Giving advance notice of elections, reasons for elections.

C. Publishing of results of elections and appoints.

D. Certification of candidates for Tribal office, both elected and appointed.

E. Appointment of independent organization for the mediation and disposition of election disputes.

F. Maintenance of a list of qualified voters.

ARTICLE V

Rights of the People

Section 1. This Constitution shall have no effect with regard to rights, protections and benefits to which Tribal members may otherwise be entitled by the Constitution of the United States of America.

Section 2. There shall be no official religion of the Tribe and no requirement concerning religious affiliation shall be established by the Tribe. The right of Tribal members to freely exercise their religious beliefs shall not be abridged by this Constitution or any action by the Tribal Chairman or Tribal Council.

ARTICLE VI

Powers and Organization of the Tribal Government

Section 1. Subject to any and all enactments of laws of the United States of America and upon approval of this Constitution by the Secretary of the Interior, the Tribal government shall be comprised of two (2) branches, an Executive division, comprised of the offices of Tribal Chairman and Vice-Chairman, and a Legislative division, comprised of the Tribal Council.

Section 2. The Tribe reserves for itself the power to establish, and upon approval by a majority of Tribal Council representatives, a Judicial division at any time subsequent to the effectuation of this Constitution.

Section 3. The Tribal Chairman, Vice-Chairman, Tribal Council representatives, Judges and Treasurer shall be deemed officers of the Tribe.

Section 4. Financial agreements into which the Tribal Council enters shall be binding against the Tribe throughout the term of repayment of any lawful debt of the Tribe.

- D. Members exhibiting destructive behaviors to themselves or others and are required by NTL Council to be screened for illegal drug use and/or psychiatric evaluation. If positive results occur from these screenings, members must undergo required treatment by qualified physicians or rehabilitation facilities at their own expense. If such members refuse screening and/or treatment, voting privileges will be denied. If members participate in the required screenings and/or completes treatment requirements, voting rights will be reinstated.
- 4.02 Upon approval of this Constitution by the Secretary of the Interior all elections will be made by membership mail-in ballots.
- 4.03 NTL Council representatives shall be elected by voting members of each distinct family unit. The Council Chairman NTL Primary Chief (NTL-PC) and Vice-Chairman NTL Vice-Chief (NTL-VC) will be appointed by the NTL Council. All elected or appointed officials must be voting members of NTL.
- 4.04 NTL elections and appointments will be conducted by secret ballot. Voting results shall be certified by an independent organization.
- 4.05 All election results and appointments will be published within ninety (90) days of the closing of each election or appointment.
- 4.06 NTL Council shall establish a NTL Election Board and appoint voting members responsible for:
 - A. Ensuring fairness and uniformity in NTL elections.
 - B. Giving advance notice of elections and reasons for elections.
 - C. Publishing of results of elections and appointments.
 - D. Certification of candidates for NTL office, both elected and appointed.
 - E. Appointment of independent organizations for the mediation and disposition of election disputes.
 - F. Maintenance of a list of qualified voters.

ARTICLE V

Rights of the People

- 5.01 This Constitution shall have no effect with regard to rights, protections and benefits in which NTL members may otherwise be entitled by the Constitution of the United States of America.
- 5.02 There shall be no official religion of NTL and no requirement concerning religious affiliations shall be established by NTL. The right of NTL members to freely exercise their religious beliefs shall not be abridged by this Constitution or any action by the NTL-PC or NTL Council.

ARTICLE VI

Powers and Organization of the NTL Government

- 6.01 Subject to any and all enactments of laws of the United States of America and upon approval of this Constitution by the Secretary of the Interior, the NTL government shall be comprised of two (2) branches:
 - A. Executive division, comprised of the offices of NTL-PC and NTL-VC,
