RE: Response to “Notice of Impeachment Proceeding Charges”

Since January, 2017, Peggy Smith has been the duly elected Treasurer of the Nonprofit Corporation Natchitoches Tribe of Louisiana (formerly “Lac Noir”). The Board replies to this charge from a Committee (the “Tribal Council”) which serves solely at the pleasure of the Board of Directors.

Issue: “R.S. Section 12:226(A): Relation of directors and officers to corporation and members; liability of officers and directors; A. Officers and directors shall be deemed to stand in a fiduciary relation to the corporation and its members and shall discharge the duties of their respective positions in good faith and with that diligence, care, judgment, and skill which ordinarily prudent men would exercise under similar circumstances in like positions.”

Under the “authority” of R.S. Section 12:226(A), you make a “veiled” accusation that the Board members of the Natchitoches Tribe of Louisiana, via a “gross neglect of duties” of the Board Member and Treasurer Peggy Smith, have not performed the duties that you list in this letter: “attend meetings, read board reports, stay informed about the organization’s activities, ensure that the organization has adequate resources, make short-term and long-term strategic plans for the organization, seek advice from experts, and provide proper financial oversight.”

Firstly, R.S. Section 12:226(A) addresses “shares” and “memberships”. The Nonprofit Corporation Natchitoches Tribe of Louisiana is a “non-share, non-membership” organization. This section of the law does not apply to the Nonprofit Corporation.

You do not identify the source of your claims that neither the Board of the Corporation nor Peggy Smith have not performed their/her duties. This Nonprofit Corporation has been the legal umbrella cover for all volunteer activities (performed by “tribal council” volunteer committee under the direct authority of the Officers of the Nonprofit Corporation, as required by Louisiana Nonprofit Corporation Law) since its formation in January, 2016. If this is your claim, that the volunteer-created Constitution by the “tribal council” has legal authority to replace the Louisiana State Nonprofit Corporation Laws authority over the duly formed Natchitoches Tribe of Louisiana Nonprofit Corporation, then you must specify that is your intent. The Board DENIES THE ALLEGATIONS and stands in support of its duly elected Treasurer.

You were elected to the committee called the “Tribal Council” in February, 2018. You played no role in the Corporation name change which occurred on July 23, 2018, with the State of Louisiana, from “Lac Noir” to “Natchitoches Tribe of Louisiana” which is the only legal owner of this name. You have no authority to speak for any Officer or Board member of the legal Nonprofit Corporation. The right to use the name of Natchitoches Tribe of Louisiana resides solely in the rights permitted to the committee, as it functions within the legal guidelines of the Nonprofit Corporation.

On August 31, 2018, the City Bank account was opened by the members of the Board of Directors, in the name of the Nonprofit Corporation Natchitoches Tribe of Louisiana. All financial matters of the Nonprofit Corporation have occurred under the authority of this bank account since then. You played no role in the legal aspects of this bank account and have no legal authority over the actions of the Nonprofit Corporation Treasurer, Peggy Smith.

A review of history: On July 15, 2025 Fred Simon and this Board replied to your illegal attempt to remove him from office. After receiving that letter, you then sent registered letters to Peggy Smith, Treasurer, and Kenneth Rachal, Secretary, both Corporate Officers (those letters being dated as June 2025). On June 26, 2025, you attempted illegal action to remove Peggy Smith as Treasurer with our CPA Thomas, Cunningham, Broadway & Todtenbier.

The Board of directors considers your actions to be harassment of the Corporate Officers and illegal and shall take necessary action against you as well as any co-conspirators.

Any attempt by your “Security Officer Monty Trichell” to contact Peggy Smith for Accounting Records is illegal and will result in law enforcement being contacted.

As to any claim that such records may be “public disclosure” records, please read the following excerpt from letter sent on September 27, 2024, by Vincent Trombatore to David Stevenson concerning a Public Records Request.

TROMBATORE LAW FIRM, LLC Attorney and Counselor at Law 16068 Lamonte Drive, Hammond, Louisiana 70403:

“The Natchitoches Tribe of Louisiana, as a private nonprofit entity organized under the laws of the State of Louisiana, is not subject to the Louisiana Public Records Law, La. R.S. 44:1, et seq. This law applies to public bodies and government entities, whereas the Tribe, being a private

nonprofit, does not fall within the scope of entities obligated to comply with public records requests under this statute. Louisiana's Public Records Law explicitly applies to documents that are "used, being in use, prepared, possessed, or retained [...] by any public body". Nonprofit corporations, even those receiving state and federal grants and donations, are not classified as public bodies under this definition. Therefore, the internal communications and records of the Natchitoches Tribe of Louisiana, such as those from the executive meeting in question, are considered private and proprietary."

In addition to the rejection of your claims of authority over the Nonprofit Corporation's Treasurer, we further state: As the designated "Leader" of your followers, you are hereby instructed to shutdown the illegal Facebook page "The Natchitoches Tribe of Louisiana" and the website "NTL-Tribe.org" in which you have installed yourself as the only contact for any public inquiry.

As the self-designated "Leader" you will be held responsible for all illegal acts of your group. Duly noted and documented slander, false information of fraud, request for donations for a lawyer, and more has damaged and caused harm to our Tribe and several Tribal Members. Your actions or non-actions will determine your status with our Tribe.

On the date of December 10, 2024, multiple individuals, including yourself, were suspended from the committee called the "Tribal Council." On December 28, 2024, elected Board members and Officers of the Nonprofit Corporation Natchitoches Tribe of Louisiana were rejected by you and your followers as having any legal authority over your actions. As of that date, the committee called the "Tribal Council" ceased to have any legal standing as a committee. In light of the dissolution of the committee called the "Tribal Council," you are considered a general public individual. All public disclosure documents of any public individual can be viewed/downloaded at: www.natchitochestribeoflouisiana.info

See below for Louisiana State certification that there is no organization named "Natchitoches Tribe of Louisiana" which is an unincorporated association. There is no separate financial legal standing for the entity, which you claim to represent as having authority to impeach the Treasurer of the Nonprofit Corporation Natchitoches Tribe of Louisiana.

The Board of Directors of the Nonprofit Corporation Natchitoches Tribe of Louisiana agree to the foregoing statements and fully support Peggy Smith. Furthermore, if you persist in illegal financial dealings, using the name of Natchitoches Tribe of Louisiana, for any purpose related to donations, grants, fundraising, and attempted banking activities, the official Nonprofit Corporation Natchitoches Tribe of Louisiana will file charges with all appropriate Federal and State agencies to stop public deception.




