DOCUMENTS OF COPYRIGHT & TRADEMARK NAME

On November 18, 2015, Fred Simon, as the “sole incorporator” formed the first Board of Directors of the non-membership Nonprofit Corporation ““Lac Noir Black Lake Tribe of Native Americans of Louisiana” (hereinafter “Lac Noir”).

On June 17, 2016, Fred Simon applied for “Business Legal Name” of “Natchitoches Tribe of Louisiana” (hereinafter “NTL”) and gave Name License use to “Lac Noir” nonprofit corporation.

On July 20, 2018, “Lac Noir” filed for name change to “NTL” Non-profit Corporation.

On October 23, 2018, IRS gave tax-exempt 501(c)(3) status to Natchitoches Tribe of Louisiana (hereinafter “501c3 NTL”).

On April 18, 2019, Vice-President Janette Melton filed for copyright protection of the “Seal of the Natchitoches Tribe of Louisiana” under the name of 501c3 NTL (the only legal organization in Louisiana State with the name of “Natchitoches Tribe of Louisiana”).

On January 12, 2019 and on 1/12/2020, Janette Melton is listed on State Corporation annual reports as being the Vice-President, showing that her filing of the copyright protection was performed under the duties of her official position during the year 2019. Rights and Permissions belong to the organization “Natchitoches Tribe of Louisiana.”

On July 19, 2022, the Trademark name of “Natchitoches Tribe of Louisiana” was filed.

The State of Louisiana shows continued corporation standing since January 12, 2016, to present for NTL.

Fred Simon retains ownership of the name Natchitoches Tribe of Louisiana, which he uses as the name for his private intellectual property called the “Tribal Registry” in which vetted members are listed who have agreed to be part of the Federal Acknowledgment Application to the Bureau of Indian Affairs. They will not lose membership in the Tribal Register as a result of whether or not they participate in 501c3 NTL activities. This membership Tribal Registry is separate from the 501c3 NTL as defined in the ByLaws, Article 6, Section 3:

No Vetted and enrolled individual will lose the status of Tribal Register acceptance, which is not based upon “merit,” but solely upon being a descendant of the Natchitoches American Indian Tribe. Each enrolled individual has options or status in the 501c3 NTL nonprofit corporation activities: they may choose to participate in the 501c3 NTL nonprofit corporation activities; they may choose not to participate in the 501c3 NTL nonprofit corporation activities; they may not be able to participate in the 501c3 NTL nonprofit corporation activities; they may have never participated in the 501c3 nonprofit corporation activities.
