DEADLINE FOR COMPLIANCE: NOVEMBER 15, 2025

Attached are the complaints sent to WordPress (Attachment 1). All these issues identified in the complaints apply to you. In addition, the following demand is hereby incorporated into this Cease and Desist Directive: We, the Board of Directors of the Natchitoches Tribe of Louisiana, a Nonprofit Corporation (hereinafter NTL-NC), hereby notify you that your current use of the trademarked name "Natchitoches Tribe of Louisiana" and Tribal Seal on the website "ntl-tribe.org" constitutes a direct infringement upon the registered rights of NTL-NC.

"Natchitoches Tribe of Louisiana" Trademark name and copyright Seal are well-established Trademark name and copyright Seal exclusively owned by NTL-NC. Your unauthorized use of this Trademark name and copyright Seal is causing confusion among Natchitoches Vetted Tribal Members as the website "publicizes" an assumption that "www.ntl-tribe.org" is an approved and valid site for NTL-NC. This false use is a clear violation of Federal trademark and copyright law.

We hereby demand that you immediately cease and desist from all uses of the "Natchitoches Tribe of Louisiana" Trademark name and copyright Seal in any form, including but not limited to the website "www.ntl-tribe.org", and other business operations. Any prior verbal or written inferred authority for their use is hereby withdrawn, voided and revoked.

In addition, the following legal issues apply to your continued involvement in supporting the illegal take-over of the website www.ntl-tribe.org by Brett Anderson and his followers, calling themselves the Tribal Council.

LEGAL ISSUE (Attachment 2): The current Tribal Council has no legal standing for being an entity in the State of Louisiana. Without legal standing in the State of Louisiana, an entity cannot claim to be an IRS tax exempt entity. You are involved in the illegal requests for donations, made via the website www.ntl-tribe.org which is a violation of Oregon State laws regarding donations requested over state lines as well as the violation of illegal donation requests from an entity which does not have legal recognition as an IRS tax exempt entity.

A claim for "ignorance" of these legal facts is no excuse for participating in criminal activities. Furthermore, Brett Anderson was appointed by Belinda Brooks (a prior Corporation Vice-President) to the Tribal Council (a Corporation "committee") in February, 2018. He was not elected by Corporation rules. He knows all of the following history as Belinda Brooks "elevated" him to Head of Tribal Council without any voting by Board of Directors of NTL-NC. This legal issue has been addressed in the NTL-NC reply to Brett Anderson's false attempt to impeach Fred Simon. A "committee head" is not an Officer nor Board member of NTL-NC. LEGAL ISSUE (Attachment 3): The first legal entity (comprised of a few representatives of the "vetted individuals" of the Tribal Registry) was named the "Lac Noir Black Lake Tribe of Native Americans of Louisiana, a Nonprofit Corporation" It was legally formed in the State of

Louisiana on January 12, 2016, with Charter Number 42013374N (see Attachment 1 for this document).

Fred Simon filed for sole business owner, under his private social security number, of his Intellectual Property which he called the “Tribal Registry” and described as an “Indian Tribe” business, doing business as a Native American Tribe, under the name of “Natchitoches Tribe of Louisiana” on June 17, 2016.

LEGAL ISSUE (Attachment 4): Fred Simon gave name use license to “Lac Noir” on June 17, 2016 via Corporation Amendment. On July 20, 2018, the “Lac Noir” was officially name-changed to “Natchitoches Tribe of Louisiana Nonprofit Corporation (NTL-NC). This official name change document was filed, under threat of committing a crime, by Belinda Brooks, the same person who had promoted Brett Anderson to “Tribal Council” committee head in February, 2018, with the task of specifically “researching the power structures within the tribe.”

LEGAL ISSUE (Attachment 5): The Officers of NTL-NC were re-affirmed on August 13, 2018. At that time, there were only four (4) Board members, each holding an Officer Position: Fred Simon, Belinda Brooks, Belinda Smith, Peggy Smith. No “committee” heads are noted as holding any legal positions of NTL-NC.

On October 4, 2018, (without Board authority and unbeknown to Fred Simon and other officers) Belinda Brooks solely filed IRS Form 1023-EZ, making an error of marking wrong box of “unincorporated association” rather than “corporation.” That error has been rectified. All Grant Funds and Donations have been handled by NTL-NC Treasurer Peggy Smith, since August 13, 2018, through the only Bank Account set up under the authority of NTL-NC. Brett Anderson has never held any financial authority in NTL-NC. He has never been a signer on any bank accounts.

LEGAL ISSUE: In December, 2024, the Brett Anderson and the Tribal Council Committee refused to follow the instructions of the Board of Directors and Officers of NTL-NC. Their authority to function as a committee under the legal umbrella of NTL-NC was removed. Since then, the individuals who have remained under the control of Brett Anderson have taken over the Facebook and website www.ntl-tribe.org belonging to the legal authority of NTL-NC. Through these two communication venues, they have persisted in giving wrong information to vetted Tribal Registry members. They have allowed slanderous postings and have been denying access to vetted Tribal Registry members in opposition to their views. They have rejected all prior “Cease and Desist” letters sent by NTL-NC Board of Directors.

LEGAL ISSUE: Through the two communication venues (Facebook, www.ntl-tribe.org), this group have requested donations. The Board has received information that Bank accounts have been opened by this fraudulent group, grants applied for, and donations have been accepted. If this is true, all these financial activities are in violation of IRS laws as well as Louisiana State Chapter 12 Nonprofit Corporation Laws and violation of Oregon State laws regarding over-state-lines donations.

LEGAL ISSUE: The Board of Directors have taken multiple legal steps (required by State and IRS rules) to mitigate the damages being caused by a group of people who persist in denying the legality of the only legal corporation which provided liability coverage for volunteers since its founding on January 12, 2016. Tremendous financial harm has been done to NTL-NC. Its

Board continues in their efforts to counter-act fraudulent actions which could implicate **all volunteers** (including Brett Anderson and his followers) with IRS tax evasion charges.

LEGAL ISSUE: This is the **final ‘CEASE AND DESIST’ letter** that will be sent to you. **The deadline for your decision is 30 days from the date on this letter.** The NTL-NC’s next action will be lawsuits, including class action suits, and reports made to the Oregon Attorney General’s office to stop tax fraud on the public.

COMPLIANCE ACTIONS REQUESTED
By Deadline November 15, 2025

Number One. Transfer webmaster control of <https://ntl-tribe.org/> to Board of Directors of NTL-NC.

Number Two. Transfer control of all forward pointing domains (known and unknown) to website www.ntl-tribe.org (i.e., natchitochestribe.org; ntltribe.org) to Board of Directors of NTL-NC

Number Three. Transfer control of all known and unknown email addresses used for administrative purposes (i.e., ntl-tribe.org) to Board of Directors of NTL-NC.

Number Four. Identification of all donations, fundraising, and grant applications made since December, 2024, and handled under the Tribal Council, excluding the legal NTL-NC Treasurer's approval and record-keeping, and all records and documents relating to such financial transactions to be transferred to the Board of Directors of NTL-NC. Any such financial items not turned over will be immediately referred to the State Attorney General's office upon discovery of such withheld financial information.

Number Five. Cease and Desist all activities which are identified as “for and on behalf of” the Natchitoches Tribe of Louisiana immediately upon receipt of this letter. Proof of delivery of this notice to you will be from various means, as permitted by the Attorney General’s guidelines: registered mail, known e-mail addresses, posting on NTL-NC websites, social media posts and re-posts, telephone notification, etc.

Number Six. If you wish to remain engaged in legitimate activities on behalf of the legally identified NTL-NC (by both Louisiana Secretary of State and IRS 501c3 Letter of Determination), you are required to submit a Volunteer Application as described on website: <https://natchitochestribeoflouisiana.us>

You will be initiated into appropriate committees under the direction of the Board of Directors of NTL-NC as legally required by the State of Louisiana Nonprofit Corporation Laws. There is no timeline on this registration; however, if any activities are resumed by you outside of this legal process, you will be immediately reported to the Attorney General offices of Louisiana State and Oregon State for violation of Nonprofit Corporation law and public financial fraud laws.

RE: Violation of Nonprofit Corporation Name, Trademark, and Copyright

Dear People:

The WordPress complaint directions asked that we confirm that the website in violation is hosted by WordPress, see this link for proof: <https://wordpress.com/site-profiler/www.ntl-tribe.org>

This complaint is signed by e-signature by all the Board members of the legally registered Louisiana State Nonprofit Corporation named Natchitoches Tribe of Louisiana. Legal documents associated with the Corporate name, legal State filing reports, Trademark and Copyright are attached hereto.

The Board of Directors confirm that the individual, Brett Anderson, who identifies himself as the sole contact on the website in question, has never received authorization from the Natchitoches Tribe of Louisiana Nonprofit Corporation to use its name, identity, logo, or trademark, nor its

Nonprofit Corporation addresses in a manner to present himself as a representative of the Nonprofit Corporation. The documents attached are accurate, and under penalty of perjury, we affirm that we, the Board of Directors, are the only individuals authorized to act on behalf of the Nonprofit Corporation, which is the sole owner of the exclusive rights which are infringed by Brett Anderson and his associated group of individuals, termed herein as the “Tribal Council”.

This group of individuals (“Tribal Council”) have received acknowledgement by Fred Simon, genealogist researcher, that they are “family-related” (this process called being “vetted”). This “genealogy” relationship was recognized by the State of Louisiana under Fred Simon’s “business name” of Natchitoches Tribe of Louisiana and by acceptance of Louisiana State of his “genealogy” records. Those genealogy records are called the “Tribal Registry.”

In 2016, a formal Nonprofit Corporation was formed to carry out the process of developing a U.S. Bureau of Indian Affairs (BIA) Application for recognition as a Federally-Accepted Indian Tribe. Until that process is completed and acceptance is given by the BIA, the “Tribal Council” remains only a “committee” under the legal umbrella of the Nonprofit Corporation. When that “committee” functions in its legally defined manner, as a “committee,” there are limits to the permitted use of the Nonprofit Corporation’s name, copyrights, and logos.

There is a conflict occurring within the “vetted” members of the “Tribal Registry” whom have become confused by misinformation being given by the “Tribal Council” about the legal nature of this “tribe” of Native Americans and its relationship to the Nonprofit Corporation. The Nonprofit Corporation has begun legal actions, including this complaint, against this illegal group being lead by Brett Anderson.

In December, 2024, Brett Anderson began an opposition group to the Nonprofit Corporation, making false claims that he and his “Tribal Council” were the true “owners” of the Nonprofit Corporation. Despite “Cease and Desist” orders sent to him by the Board of Directors, and posting all legal documents via other websites, available to all “Tribal Registry” members, this “Tribal Council” persists in their opposition. This opposition was done primarily through a false FaceBook account, which had no real legal standing, but that FaceBook account had been started and maintained by one of followers of Brett Anderson.

The website in question was developed by Brett Anderson’s relative (his step-father, married to Brett’s mother who was a “vetted” member of the “Tribal Registry”) who, previously for years, had been fulfilling the directives of the President/Chief Fred Simon of the Nonprofit Corporation. In 2023, that website handling was assumed by a domestic partner (Phil Kneis) of another “vetted” member of the “Tribal Registry.” Sometime around July 1, 2025, Brett Anderson took charge, via this “new manager,” of the Nonprofit Corporation website www.ntl-tribe.org. The webmanager of that website WILL NOT RESPOND to any of the contacts from Fred Simon nor the Board of the Nonprofit Corporation. This website now erroneously refers to the Board Members of the Nonprofit Corporation as either “Council” members or as “Elders”

rather than acknowledging the actual legal structure of the Nonprofit Corporation which has been in existence and fulfilling all legal requirements since 2016.

The Board of Directors of the Nonprofit Corporation Natchitoches Tribe of Louisiana are now proceeding to filing formal complaints with all government agencies in order to stop this illegal use and that group's attempts to accept donations which they are not legally permitted to do. All Nonprofit Corporation bank accounts have been closed due to this group's illegal fundraising. We are attempting to stop these family-related individuals, who are engaging in uninformed and legally dangerous activities due to being wrongly lead by a powerful, yet uneducated, individual.

Please contact us with your decision on this matter as soon as possible to help us prevent IRS tax fraud from being perpetrated upon innocent family members.
