

CHARITABLE PROGRAM SERVICE AGREEMENT

Between Nonprofit Organization
and
Independent Business Provider

This Agreement is between:

Nonprofit Organization:

Natchitoches Tribe of Louisiana NonProfit Corporation (hereinafter NTL-NC),
a nonprofit corporation recognized as tax-exempt under 501(c)(3) tax-exempt status.

Service Provider:

Fred Dale Simon, DBA Natchitoches Tribe of Louisiana Tribal Registry, also known as
Natchitoches Tribal Registry, LLC, a for-profit business.

1. Purpose of the Program

The purpose of this Agreement is to support the charitable mission of the Nonprofit Corporation by allowing the Service Provider to donate services to members of the public while encouraging voluntary charitable contributions to the NTL-NC.

Nothing in this Agreement shall be interpreted as creating a commercial fundraising arrangement.

2. Description of Services

The Service Provider agrees to perform the following services:

Genealogy Research for the specific individual requesting such services through the use of official application forms provided by NTL-NC.

The Service Provider agrees that these services will be **provided without charge to the recipient**.

3. Voluntary Contributions

Recipients of the services may be informed that they **may make a voluntary charitable donation** to the NTL-NC.

However:

- Donations are **not required**
- Services will be provided **regardless of whether a donation is made**
- The donation is **not a fee for services**

4. Payment Handling

All donations must be made **directly to the NTL-NC** by one of the following methods:

- Check payable to the Natchitoches Tribe of Louisiana
- Online donation platform of the Natchitoches Tribe of Louisiana

At no time shall the Service Provider collect, deposit, or control donation funds unless specifically authorized in writing by the Nonprofit Organization.

5. No Private Benefit

The parties acknowledge that the NTL-NC must operate exclusively for charitable purposes consistent with the requirements of the Internal Revenue Service.

Therefore:

- The Service Provider receives **no compensation from donations**
- The Service Provider receives **no financial benefit from the program**
- The Service Provider may not claim ownership of donated funds

6. Independent Contractor Status

The Service Provider is an independent contractor.

Nothing in this Agreement creates:

- Employment
- Partnership
- Joint venture
- Agency relationship

7. Advertising and Public Statements

The Service Provider may state that it **supports the charitable program of the NTL-NC**.

However, the Service Provider may not:

- Represent itself as the nonprofit
- Collect donations in the name of the nonprofit without written permission
- Misrepresent the tax deductibility of donations

8. Liability and Insurance

The Service Provider shall be solely responsible for:

- Professional conduct
- Licensing requirements
- Insurance coverage
- Compliance with applicable laws

The Nonprofit Organization assumes no liability for the services provided.

9. Indemnification

The Service Provider agrees to indemnify and hold harmless the NTL-NC, its directors, officers, and volunteers from any claims arising from the services provided by the Service Provider.

10. Donation Acknowledgments

The NTL-NC will provide written acknowledgments of donations consistent with requirements of the Internal Revenue Service.

Donors must be informed when their contribution may not be fully tax deductible due to services received.

11. Term and Termination

This Agreement began on October 30, 2018, under verbal agreement, and has been in effect since then until November 19, 2025, the Dissolution Date of the 501c3 entity known as Natchitoches Tribe of Louisiana with EIN 81-2980752, granted IRS 501c3 status on 10/04/2018. The current NTL-NC has held legal Nonprofit Corporation status since January 01/12/2016, with Louisiana State Charter Number 42013374N and EIN 81-211798, and is the legal transferee of all assets of EIN 81-2980752. This Agreement shall be dated as beginning on November 19, 2025 and will remain in effect until terminated.

Either party may terminate the Agreement with **30 days written notice**.

The Nonprofit may terminate immediately if the program risks its charitable or tax-exempt status.

12. Compliance With Laws

Both parties agree to comply with:

- Federal charitable laws
- State fundraising laws
- Regulations governing charitable organizations

13. Entire Agreement

This document constitutes the entire agreement between the parties and may only be modified in writing.
