## **Objectives**

- Zero tolerance to violence against Healthcare workers and Healthcare institutions
- Hospital premises to be declared as "Safe zones"





In the event of an attack (physical, verbal or any other form) - CODE VIOLET Abort any ongoing threat and move to a safe place Stop all Outpatient and Inpatient services (Steth Down protest) Inform KGMOA Taluk convenor and Head of the institution File complaint to the authorities with the help of KGMOA Legal cell



Further actions as per KGMOA Taluk / DC / GB meetings

## Victim of assault

- Move to a safe place
- Stay calm and composed at all times
- Seek help from KGMOA and coworkers
- Contact PST KGMOA in case Taluk convenor not available
- Stick to the complaint and never back down under pressure





## Rapid Response Team

- Initiate swift response in the event of an assault
- Help in documentation (video) of the incident
- Provide moral support to the victim





#### **Head of the institution**

- Discussion with the mob to de-escalate the crisis
- Update PST KGMOA regarding the incident
- Arrange replacement for victim's remaining duty hours
- Receive complaint from the victim and handover the same to the Police with a covering letter and all the necessary evidence

#### Take proactive measures

- Form institutional level Rapid Response Team
- Display of laws and punishments with regard to Hospital attacks in institution premises

  WARNING
- Conduct periodic SECURITY AUDIT
- Ensure CCTV surveillance in high risk areas



#### KGMOA Taluk convenor

- Update PST KGMOA regarding the incident
- Coordinate protest activities at Institution and Taluk levels
- Help victim to file the complaint with due assistance from KGMOA Legal Cell
- Physically accompany the victim in all legal procedures





#### A victim of assault should

- File a complaint under the Kerala Healthcare Service Persons and Healthcare Service Institutions (Prevention of Violence and Damage to Property) Act 2012
- File a complaint under the Epidemic Disease Act (amended in 2020)
- Approach the Human Rights Commission
- If a lady is assaulted, approach the Women's Commission
- In case of Cyber bullying the Cyber Cell should be approached (criminal defamation as per section 499 of IPC or section 66 of IT Act)
- File a petition to be heard by the court, before the grant of bail to the culprit
