Elections & Nominations Announcement

Designated Directors shall serve a term of 1, 2 or 3 years.

Nominating by Committee: The President shall appoint a committee to nominate candidates for election to the board at least 90 days before the date of any election of Directors. The nominating committee shall make a report at least 60 days before the date of the election.

Members representing 5% of the voting power may nominate candidates for Directors by petition. On the timely receipt signed by the required number of Members, the Secretary shall cause the names of the candidates named on the it to be placed on the ballot along with the names of the candidates chosen by the nominating committee.

A Letter of Intent to Run for Election must be submitted directly to the Nominating Committee.
