Gerald Chase, had over 2,000 pairs of shoes donated by Pierce Footwear, located in Bend, Oregon. These shoes were created by its founder, George Pierce who turns waste into foam for shoes. American Veterans United Board Members, Clettus McDonell and Loren Manes made the round-trip trek from California to Oregon to pick up the shoes and then gave them to the

Foodbank of Santa Barbara County for storage. These shoes will be made available to AVU Members, veterans and their families.

George Pierce, CEO Founder is an entrepreneur and dedicated athlete. He has travelled nationally and globally competing in many duathlon and triathlon events over the past decades. In 2010, George suffered a life-threatening accident when he was struck by a car while cycling.

He sustained many serious injuries, including fracturing his neck and back in multiple places. On his road to recovery, George discovered that lacing shoes was incredibly difficult with his limited mobility. He was inspired to create a solution by designing a laceless performance shoe, and Pierce Footwear was born!

The largest outreach and ambassador group for the first shoes were the Special Olympics international athletes first fitting TEAM USA athletes in the Los Angeles games 2015, we custom fit 2,000 athletes in 2017 winter games, Gratz, Austria, and then 2019 7,000 athletes in the summer games held in Abu Dhabi and all 192 countries in the world were represented.

<u>Pierce Footwear</u> celebrates its first Veterans partnership with Cloverlane Foundation and Veterans Mobility Products to distribute best fitting sneakers to temporarily disabled Veterans and their families. These sneakers help Veterans stay physically active, more mobile and to keep exercising to receive the mental health benefits of movement.

Veteran Services / Benefits

California is home to 1.8 million veterans, representing eight percent of the total U.S. veteran population. California anticipates receiving an additional 30,000 discharged members of the armed services each year for the next several years – more than any other state. Historically, the largest demand for benefits and services for veterans occurs immediately after discharge and again as the veteran population ages and requires greater access to medical facilities and long-term care services.

With the substantial number of veterans under the age of 30 leaving the military after deployments to the wars in Iraq and Afghanistan, coupled with a considerably large population of Vietnam veterans who are now approaching a period in the their lives where they will need greater access to medical and long-term care, California is preparing for a sustained spike in earned services and benefits.
