Non-Peak Hours: Monday to Friday, 10 AM to 4 PM.

Membership Booking and Cancellation Policies:

Basic Members:

Advance Booking: 7 days.

Peak Hours: One booking per day; one-hour booking per day during non-peak

hours.

Cancellation and Refunds: No changes or refunds except under exceptional

circumstances with valid documentation.

Star Members:

Advance Booking: 14 days.

Peak Hours: Two bookings within a 14-day period.

Non-Peak Hours: One booking within a 14-day period.

Cancellation and Refunds: No modifications or changes except under exceptional

circumstances with valid documentation.

Gold Members:

Advance Booking: 14 days.

Peak Hours: One hour per day per booking.

Non-Peak Hours: Two hours per day per booking.

Peak and Non-Peak Hours: Two bookings within a 14-day period.

Cancellation and Refunds: No modifications or changes except under exceptional

circumstances with valid documentation.

General Terms:

- All bookings are subject to availability and membership tier restrictions.
- Bay Pickle reserves the right to modify terms and conditions without prior notice.
- Valid documentation is required for cancellations or changes due to exceptional circumstances.
- Members are required to be present on the day of the booking and cannot book on behalf of others.

Cancellation Policy for Court Booking (all to non-member & all members):

To cancel a pickleball court booking at Bay Pickle, we require written notice. If the cancellation is made less than 12 hours before the scheduled booking time, a doctor's note will be necessary to process the cancellation. In the event of a cancellation, rebooking is allowed, subject to availability. Your cooperation and understanding of our cancellation policy are greatly appreciated.

Weather Policy:

In the event of extreme weather conditions, Bay Pickle center will be closed, including the 24-hour access center, with all classes and events cancelled under the following circumstances:

- Typhoon Signal No. 8 or above
- Black Rainstorm Warning
- any extreme weather warning issued by the National Weather Service or relevant government department will result in the closure of our facilities

If you need to reschedule or book the court for another day, we will send out an email with instructions on how to rebook the court. Additionally, all classes and events will be canceled.
