- 1. Call to Order
  The meeting was called to order at 5:54 p.m.
- 2. Minutes of Previous Meeting January 4, 2024

  Motion to approve minutes by Sue Eberle. Second by Richard Flechtner. Approved.
- 3. Treasurer's Report (Bonnie Warren)
  We are down \$.79 from last year. Chamber dues were paid twice, in January and December. Book sales at Main from February through December totaled \$3,206.68. Book sale revenue at Vista was \$1,079.12. Book bundles at Vista came to over \$200. We will stick with the budget presented at the last meeting. If we are short, we can use Edward Jones funds. Our Edward Jones earnings last year came to \$15,088.
- 4. Community Conversation (Kevin Fahey and Michelle Mata) Library staff, Kevin and Michelle, reached out to FOL board members as part of a larger outreach initiative the library has conducted over the past month with local agencies. They are asking what more can the library do for the Friends and the Casa Grande community? They have made around twenty visits already and will see more groups. A summary of today's questions and responses follows:
  - How many of you have a library card? Everyone present (12).
  - What do you see families or community members struggling with in our community? Board
    members mentioned public transportation, things for families to do, educational deficits,
    the prohibitive cost of housing, the need for financial literacy, food insecurity, and that
    many community members are not aware of what resources are available.
  - Do you attend library programs? Almost all FOL board members get to programs.
  - How can the library partner with you? How can we better promote the FOL? The FOL board would like the city to keep the Friends in mind if there are any expansion plans. Amber has been great in partnering with the FOL.
  - How do you prefer to hear about library events, new programming, etc.? How do you
    prefer to hear about new things? Some members said they learn when going to the library.
    The weekly blasts are helpful because they contain the calendar for the month and flyers.
