White hate, White fear fueling White rage

WASHINGTON—No surprise: the number of reported hate crimes in the United States has reached the highest it's been in 12 years, the FBI recently reported.

The Justice Department and FBI are required by the 1990 Hate Crime Statistics Act to publish an annual report on hate crime statistics across the country, and this year, according to published reports, more than 10,000 people reported that they were victims of hate crimes in 2020, a number that has been steadily rising over the last decade. Attacks targeting Black people rose to 2,755 from 1,930.

This comes as no surprise because White people fear their very "whiteness" is in danger of eradication, and they are lashing out. There is a declining proportion of the population in the United States who identify themselves as White—their birthrate is declining while non-White birthrates and immigration rates are increasing. White people don't like the prospect of fewer privileges for themselves and are not taking it well.

For decades, going back to the 1960s and the infamous Counterintelligence Program (COINTELPRO), law enforcement strategists worried, and directed nearly all government resources into policing "Black extremists" as the greatest domestic terrorism threat. They did this while ignoring what is now seen as the grave danger from so-called "disaffected" Whites—radical right-wingers, members of Q-Anon, the Proud Boys, the Three Percenters, the Oath Keepers, and other so-called "sovereign citizens" who either don't recog-

nize the authority of the federal government, or who want certain states or counties to secede from the union to form a nation by and for White people, first and foremost.

In order to ensure equality for all Americans

regardless of their racial or ethnic backgrounds, Black leaders—preachers, politicians, the educated class—have convinced the masses that if White people begin to show some human kindness, that will constitute evidence that the work

has begun to completely rebuild most major institutions in this country because those institutions are fundamentally biased.



Twenty years have passed since jumbo jets flew into New York City's World Trade Center on September 11, 2001. In horror, the world watched the implosion of the twin towers followed by reports of passenger planes striking the Pentagon outside of Washington, D.C., and going down in Pennsylvania.

On that day 3,000 people perished, changing reality for Americans and millions around the world in different ways. 9/11 was so momentous an event that many who lived it remember what they were doing and where they were that Tuesday at 8:46 a.m. Eastern Standard Time when tragedy struck.

The hours, days, weeks, and months after the attack brought stories of "the best" of America surfacing and praise for fire fighters, police and EMT profes-

als who were injured, died, and lost colleagues answering the call to save lives in New York. It also left many Americans crying for blood and a president vowing to give them blood.

September 11, 2001, was an emotional and unifying event for a country divided after the controversial election of Republican George W. Bush over Democratic Party candidate and former vice-president Al Gore in November 2000. With Mr. Bush ostensibly declared president by a Supreme Court decision to stop a vote recount in Florida, a state politically controlled by Mr. Bush's brother, and a Gore concession, many were bitter and angry. "Hail to the thief!" had been chanted at Mr. Bush during his inauguration months before 9/11 happened and galvanized the nation.

The 20-year mark for 9/11 warrants a look at America and the world. Analysts say America must come to grips with herself, ugly truths behind 9/11, bloody U.S. foreign policy, deceit and a loss of freedoms at home and abroad.

"The tragedy of 9/11 is a tragedy on many levels," said Mauri Saalakhan, of the Aafia Siddique Foundation, a Muslim human rights group. "It's a tragedy for this nation vis-a-vis what this nation is supposed

to represent theoretically as a nation with liberty and justice for all."

Mr. Saalakhan said 9/11 exposed deep, "ever-present" contradictions in America's well-crafted image as a bastion of freedom.

The U.S. government moved swiftly to attach blame for the deadly act. Officials said the enemies were Arabs, Muslims, who acted out of hatred for America's freedoms.

The U.S. blamed Osama Bin-Laden, a Saudi businessman, onetime U.S. ally in a war against the Soviet Union, and founder

of the militant organization Al-Qaeda. The U.S. blamed Al-Qaeda and its leader for the act of "terrorism," and accused the Taliban government ruling Afghanistan of harboring him. America demanded that the Taliban turn him over. The Taliban refused to do so without evidence of his guilt. U.S. bombs quickly followed the request, and the Taliban government fell as President Bush declared a "global war on terror" divided into those with America and those

Beyond indictments, cop convictions needed in quest and cry for justice for Elijah McClain

When Lindsay Minter heard about the officers and paramedics being charged for Elijah McClain's death, her first thought was, "Yes, we did a great job."

But then she saw the charges.

"I was like, oh, well they were just charged with something. They were just charged with something to pacify us," she expressed to The Final Call.

A grand jury indicted two Aurora, Colo., police officers, one former officer and two paramedics on 32 counts. Colorado Attorney General Phil Weiser announced the charges on Sept. 1. The charges came two years after Elijah McClain's death.

On Aug. 24, 2019, 23-year-old Elijah was walking home after getting off work and stopping at a corner store to buy iced tea. He had on a ski mask because he had anemia, which caused him to get cold easily. He was reported as "suspicious," and three Aurora police officers—Nathan Woodyard, Randy Roedema and Jason Rosenblatt—responded to the report. When the officers pulled up, they asked him to stop walking, accused him of resisting, tackled him to the ground and handcuffed him. Throughout the encounter, the young Black man can be heard saying, "I was just going home," and "I can't breathe."

Officers eventually used a carotid chokehold on Mr. McClain, which restricts blood to the brain. Paramedics were called to the scene, and after officers decided Elijah was suffering from "excited delirium," paramedics injected him with ketamine. According to medicalnewstoday.com, Ketamine is a medication that is used to induce loss of consciousness, or anesthesia. As he was being transported to the hospital, he went into cardiac arrest and was later declared brain dead and taken off of life support.

Officers Randy Roedema and Nathan Woodyard, former officer Jason Rosenblatt and paramedics Jeremy Cooper and Peter Cichuniec were all charged with manslaughter and criminally negligent homicide. Officers Roedema and Rosenblatt face a charge of second-degree assault with intent to cause bodily injury and a related count of a crime of violence. The paramedics face additional charges of second-degree assault with intent

to cause bodily injury, second-degree assault for recklessly causing serious bodily injury by means of a deadly weapon (ketamine), second-degree assault for a purpose other than lawful medical or therapeutic treatment and one count for a crime of violence.

The officers and paramedics have been suspended without pay.

Sheneen McClain told the Black News Channel that she was surprised at the outcome.

"I was praying for a good outcome. I was praying for one that would allow my son's soul to be at peace," she said.

She said she didn't expect that level of le-

gal response, especially in the state of Colorado.

Civil rights attorney Mari Newman told The Final Call that Elijah McClain's father, Lawayne Mosley, is relieved and thankful.

"When we spoke with the attorney general, Elijah's dad actually broke down in tears because he was so both happy and relieved that there was going to finally be some measure of accountability for the people who had killed his son," said Ms. Newman, who represents Mr. Mosley.

She helped file a lawsuit on behalf of the family and Elijah McClain's estate in Aug. 2020.

A first step, but more work needs to be done

Aurora activists say the charges are a first step, but they're not satisfied.

"I think that the charges are one of the things that we asked for, one of the things that we had advocated for that is a measurement of accountability. This by no stretch of the imagination is justice," said Candice Bailey, an "actionist" who is fighting to run for the Aurora City Council. "We can never ever bring young Elijah McClain back from the grave. White supremacy carried out the

Black woman attacked by Chicago cop

Nikkita Brown was harassed and assaulted by a Chicago police officer while walking her dog at the North Avenue Beach.

CHICAGO—Nikkita Brown was simply walking her dog on the North Avenue Beach when a police officer proceeded to harass and assault her for being at the park 10 minutes after closing time.

Video footage shows Ms. Brown walking away, obeying the officer's command yet still being harassed by the officer who has yet to be identified. The video shows Ms. Brown and the officer talking then after Ms. Brown stops walking she then looks down at her phone. The officer then grabs Ms. Brown's arm trying to restrain her. Ms. Brown can be heard screaming as the cop then tries turning her around.

A statement released by Ms. Brown's legal representatives, Saulter Law P.C. stated that what transpired was an "obvious case of racial profiling" and that Ms. Brown suffers from emotional trauma due to the incident.

"She had heeded the command and was moving towards the exit. She was in motion. This sister was not standing her ground adamantly. This is a sister that was not only compliant, but respectful. But in the eyes of a racist, bigoted cop, he did not see the dignity of her humility. We have to ask ourselves, 'what we saw, how did this escalate to this?' We don't know if this officer is dealing with more than racism. Where is his history?" activist Eric Russell told The Final Call.

The police officer in question has had more than two dozen complaints against him, reported local news. Some of the complaints categorize his behavior as "unbecoming" and a "neglect of duty." Why is he still on the police force then?

The Chicago Police Department said



they were "aware" of the Aug. 28 incident and Chicago Mayor Lori Lightfoot was said to be "deeply concerned" and that an investigation was pending. The officer was placed on desk duty but as of Final Call presstime, had not been charged.

The Final Call contacted the mayor's office but received no response.

Mr. Russell noted that Black women have been targeted by law enforcement for decades and that it stems from White supremacy. "Black women have become more of a target because they have access to them now. They put Black women out there because they can control them to some degree. When they raped our women

in slavery, what they did, when they put the bullwhip to Black men as part of the Willie-

Lynch Syndrome, they wanted to tell Black women that 'your Black men cannot protect you, we are a superior race and if you hope to survive, you need to acquiesce through the chains and servitude of White supremacy,'" Mr. Russell continued.

According to a 2017 study by the UF Law Scholarship Repository, Black women are at highest risk than any other group to experience sexual assault by law enforcement. There are also many cases that have not been recorded because Black women encountering police does not receive much media attention, reports FiveThirtyEights.

Longtime Chicago activist Carolyn Ruff has organized protests in support of Ms. Brown. "To me, I was attacked by four White cops and a female while I was protesting in 2019. What it means to me is that the higher-up needs to take a look at these police," she said.

"Right now, we don't trust the police so I don't know if we would be able to find protection. ... My demands were to fire the police (officer) but what they did was put him on desk duty. What we would like to see, and everyone who is fighting for justice for this young lady, is this officer fired," said Ms. Ruff.

"Til' our men come forward and protect our women I don't think it's going to get any better. I agree with the Minister wholeheartedly," she said, referring to the Honorable Minister Louis Farrakhan of the Nation of Islam.

During a 2015 interview on WVON 1690-AM with host Cliff Kelley, Min. Farrakhan spoke on the history of policing in America. "They used Irish people on what they call 'the watchdog' (surveillance); these were the beginnings of 'the police,' to catch Black slaves, runaway slaves, and return them to their master. You have never been no 'good' person to us! That's why the patrol wagon was called the 'paddy wagon,' because the Irish were the 'top cops,' and as 'top cops,' you did not treat Black people fairly," the Minister explained.

Chicago police are no strangers to disturbing incidents toward Black women. What happened to Anjanette Young who was handcuffed naked during a botched police raid? The 50-year-old social worker was coming from a day's work Feb. 21, 2019 when police barged into her apartment, handcuffed her naked and rummaged through her belongings.

Rekia Boyd was shot and killed by off-duty Chicago cop Dante Servin in 2012 when he fired his gun into a crowd, killing the 22-year old. He was found not guilty of involuntary manslaughter. Last year during the height of protests against

police brutality local youth activist Miracle Boyd, 18, had her front teeth knocked out by a police officer during a protest at Grant Park.

Chicago-based activist Ja'Mal Green told The Final Call, that Black women are the most mistreated people in America. "If a White woman was walking her dog minutes after the park was closed, the officer would've been kind and even played with the dog but when you're a Black woman, you're looked at as a third-class citizen and must obey commands or be dealt with," he said.

"We've been dealing with this treatment for hundreds of years from authoritative systems they put in place, and it needs to come a time when we stop begging for equality and start demanding it or else. He is a White supremacist in a blue uniform, and we must zero in on policies that tear down White supremacy because you cannot reform White supremacy," said Mr. Green.

Father Michael Pfleger of St. Sabina Church on the South Side of Chicago told The Final Call, "There's obviously a complete distrust and that comes from behavior. We continue to see this disrespect and oppressive behavior on Black women and on African Americans in general." What is it going to take to stop? questioned the activist priest. "We keep hearing the police department and the mayor saying it's unacceptable but it keeps happening. I just think that the culture and DNA of the police department gives freedom to those who are racist and sexist, it gives them the free pass, if you will, to continue this kind of behavior," added Father Pfleger.

"When we don't take immediate discipline, and if you had done that or I had done that, we would have been arrested and in jail. But a police [officer] can do it and still get paid. When the police department does not take strong and aggressive actions against these behaviors, they are consciously or unconsciously allowing it. ... I think we've got to continue to demand systematic change; this culture is just not acceptable. The culture doesn't seem to be changing," Father Pfleger continued.

"You can't train a racist mind that has an attitude that we are 'animals,' that the Black community is a 'jungle' ('Let's go down to the jungle'). No—hell no! In the future, we will ask you to step out of our community," Min. Farrakhan told Mr. Kelley on the WVON broadcast.

"Because if that's the way you think, you can't come in here! We will police our own community, teach and train Black men how to love and respect each other—and you should back us up in that."

Vicious Media Attack on Overwhelmingly Successful COVID-19 Treatment Is Pure Desperation

The genocidal plot to rid the world of 3 billion humans via vaccines has been dealt a near-fatal blow. The safe and effective drug Ivermectin has been in common use *in human beings* for decades. It is so valuable to humanity that its discoverers won a Nobel Prize in Medicine. Here in the United States, a group of brilliant doctors seeking a remedy for COVID-19 found that Ivermectin had a near miraculous effect on COVID-19 patients.

Just as doctors withheld Penicillin, the cure for syphilis, from those poor, Black Tuskegee victims, the corporate-controlled media, Dr. Fauci, Bill Gates and other genocidal demons depend on the people’s ignorance of treatments and cures for COVID-19 in order to hoax them into voluntarily taking a Pfizer/Moderna/J&J “vaccine,” now known to us as the ‘KMS’ shot—Kill, Maim, & Sterilize. So, they attempted to suppress knowledge of Ivermectin. Instead, the news of Ivermectin’s dramatic impact on hospitalization and death rates in countries like India and Mexico; its history of safety and effectiveness; the mountain of scientific studies that back it; has spread worldwide and demand for the prescription has skyrocketed.

The now desperate Food & Drug Administration (FDA) led by Dr. **Janet Woodcock** even resorted to a form of blackface minstrelsy—the kind of racist insult that used to draw a rebuke from the NAACP—to try to slow the growing popularity of the drug and mass rejection of the killer KMS “vaccine.” In a strange and condescending Tweet, obviously intended to scold the plantation slaves, the FDA’s top doctor wrote: *“You are not a horse. You are not a cow. Seriously, y’all. Stop it.”*

She was referring to Ivermectin’s use in veterinary medicine to stem parasitic infections in animals. It was a desperate ploy to make people think that using Ivermectin for COVID-19 is akin to humans eating Alpo or Purina Dog Chow. But this has backfired. Well-known drugs like penicillin, tetracycline, aspirin, and even opioids are also used to treat animals.

Further, the FDA, Fauci, Media, et.al., have tried to conceal a near miraculous decline in cases and deaths in India earlier this year, following a sharp spike attributed to the Delta variant, which originated there. The decline was immediately after that nation of 1 billion people introduced Ivermectin and Hydroxychloroquine to protect and treat its citizens for COVID-19. On July 30, 2021, the New York Times reported that the sharp plunge in COVID-19 cases was a “mystery with no clear explanation.” Wrong. The explanation is quite clear! Groups fighting the US opioid epidemic have called on Joe Biden to appoint a new head of the Food and Drug Administration (FDA) after describing the acting





... And I’m here to tell you...that we have a solution to this crisis. There is a drug that is proving to be of miraculous impact. When I say miracle, I do not use that term lightly and I don’t want to be sensationalized. That’s a scientific recommendation based on mountains of data that’s emerged in the last three months. ...

Mountains of data have emerged from... many centers and countries around the world, showing the miraculous effectiveness of Ivermectin. It basically obliterates transmission of this virus. If you take it, you will not get sick.

It’s proving to be a wonder drug. It has already won the Nobel Prize in medicine in 2015 for impacts on global health in the eradication of parasitic diseases. It is proving to be an immensely powerful anti-viral and anti-inflammatory agent.

Please recognize, peer review takes time. It takes months, we do not have months. We have 100,000 patients in the hospital right now dying. I’m a lung specialist. I’m an ICU (intensive care unit) specialist. I’ve cared for more dying COVID patients than anyone can imagine. They’re dying because they can’t breathe. They’re on high-oxygen delivery devices, non-invasive ventilators or sedated and paralyzed and attached to mechanical ventilators that breathe for them. And I watch them every day. They die. By the time they get to me in the ICU, they’re already dying, almost impossible to recover.

Early treatment is key. We need to offload the hospitals. We are tired. I can’t keep doing this. ...Any further deaths are going to be needless deaths, and I cannot be traumatized by that. I cannot keep caring for patients when I know that they could have been saved with earlier treatment and that drug that will treat them and prevent the hospitalization is Ivermectin. This is—I am here today, I am calling to action, the NIH...

I want to be clear. I am not here as a politician, or the dramatist, or sensationalizing what I am recommending..... We have almost 30 studies, every one is reliably and reproducibly positive, showing the dramatic impacts of Ivermectin. Please, I am just asking that they review our manuscript. It’s serious, and by serious highly experienced physicians and researchers. We have —I cannot call on more credibility than we have, we’re not just a random doctor who’s saying we have a cure. I don’t want to say I have a cure. I’m just asking, review our data. We have immense amounts of data to show that it must be implemented and implemented now.

Senator, the last thing I want to say is, you know who’s dying here? It’s our African-American and Latino and elderly. It’s some of the most disadvantaged and impoverished members of our society. They are dying at higher rates than anyone else. It’s the most—severe discrepancy I have seen in my medical career and we are responsible to protect those disadvantaged members. We have a special duty to provide countermeasures. The amount of evidence to show that Ivermectin is life-saving and protective is so immense and the drug is so safe, my colleagues have talked about it, it must be instituted and implemented. I am asking the NIH to review our data and come up with the recommendations for society. Thank you.

EXPOSED! FDA and CDC Hiding Data On Severe Covid “Vaccine” Side Effects in Children Under 12

Over 40 children under 12 have died and over 4,200 more experienced a dangerous side effect known as Multi System Inflammatory Syndrome that has never existed before in children under 12 but surfaced in those injected with mRNA Covid “vaccines.” The U.S. Food and Drug Administration (FDA) and the Centers for Disease Control (CDC) have been hiding this from the American public, according to Dr. Bryan Ardis. He is the CEO of ArdisLabs.com, known for treating acne and various health conditions with natural-ingredient-based products.

Multi System Inflammatory Syndrome in Children, abbreviated as MIS-C, is a brand-new disease. It was unknown before 2020 and is the only disease created and given a diagnostic code since 2020, stated Dr. Ardis. Healthcare systems use diagnostic codes to describe and classify diseases, illnesses and injuries.

Dr. Ardis discussed this bombshell during an August 1 presentation with a panel of doctors in Germany. He explained that MIS-C is now classified as a known side effect because the mRNA “vaccine,” the spike proteins it tells the body to produce and anything else that might be in those shots have led to a debilitating, horrible inflammatory reaction in multiple organs all at once, when injected in children.

Stanford University in California has already prepped for a study to allow vaccinations of children as young as babies and toddlers, six months and two-years-old, he noted.

The syndrome isn’t contracted solely through the Covid “vaccines,” it can also be contracted from vaccinated persons through “shedding”—when components of the vaccine are released from the vaccinated person into the body of others or the environment.

This further confirms the science that those who are vaccinated can pose a serious health threat to those who are not.

“There are toddlers, two-year-olds, who are already menstruating blood clots, a few hours within their parents being vaccinated,” stated Dr. Ardis. “This is already being reported in two-year-olds, four-year-olds, six-year-old daughters and girls. This is the attempt of those female bodies to remove the toxic effects they’re being exposed to by their vaccinated parents, or whoever they’re around,” stated Dr. Ardis.

It was already known that SARS CoV-2 has very little threat to children or pregnant women, and that in rare cases the spike proteins of the coronavirus could create Multi Inflammatory Syndrome in Children. And now, it’s actually listed as a known side effect of the “vaccine,” he emphasized. “The FDA knew it.”

Multi Inflammatory Syndrome in Children, as defined by the Mayo Clinic of Academic Medical Researchers, is a severe inflammation of multiple organs in the body, including the brain, the kidneys, the spleen, the gastrointestinal tract, the eyes, the skin. But as deadly as it is, Dr. Ardis pointed out that he hasn’t seen a single incident reported on the Vaccine Adverse Event Reporting System

(VAERS), which tracks vaccine safety and efficacy. However, the CDC has already reported over 4,200 occurrences and 40 deaths of children reported to the agency.

“And this is what you want to push on all the masses of children, and Americans across the world, to allow them to go to school? I find this just atrocious, and disgusting, and everyone needs to know,” stated Dr. Ardis. “...I couldn’t stand the fact that the FDA had an internal discussion and a meeting in October 2020,” said Dr. Ardis. During that meeting by the Center for Biologics Experiments and Research, top FDA officials were informed, in a 25-slide presentation, of the side effects and serious adverse events they *knew* would happen once the shots began to roll out. That was two months before distribution began in December. Slide 16, he observed, was passed over quickly, however the actual entire presentation remained on the FDA’s website.

He immediately took a copy of the presentation to media to sound the alarm that the FDA was already aware that the Covid “vaccines” would cause over 110 diseases.

This is not the only things that were on the document, there were also five different blood clotting disorders the FDA knew in October would happen when the Covid shots started to be administered to all Americans.

“These have now come, May and June of this year, we’re talking five to six months later that the shots came out, now you’re seeing they’re putting a blackbox warning on the label for Johnson and Johnson for blood clots - Myocarditis? The FDA already knew this in October, two months before the shots ever came out,” Dr. Ardis stated.

“I’ve got five kids and I would never want any possible serious side effects that are permanent and lifelong to ever occur to my child, and no one should ever push something so experimental, ever, on any human being ever. It’s by far crimes against all humanity, but my goal is to try to preserve as much as possible the health of child[ren], period.”

“Now what are you hearing reported in all the teenagers that are now being given the shots?! You’re hearing hundreds and thousands of reports of myocarditis, and some of these athletes and teenagers are dying in high schools, high school ages, but the FDA already knew this!”

He found it incredible that the FDA recently announced it literally wants Pfizer to expand how many children they will put in their clinical trial.

“Why would you want to give them—any more children—a shot that’s already causing myocarditis, whether it’s in a trial of any kind, or to the masses? Why would you encourage any more children, or risk their life or health over an experimental shot? It makes no sense to me. I find it deplorable,” stated Dr. Ardis.

Since then, he’s been on a non-stop mission to sound the alarm about the coming dangers through these so-called vaccines. In October, before the shots ever came out, he stated, he immediately went into the media to let everybody know, these are the things the FDA know is coming.

Not only are those who control the FDA and CDC responsible for concealing this from the masses in America, so are the media entities that Dr. Ardis said he informed, but have refused to report this crucial, life-threatening data.

Multiple lawsuits have been filed in federal court in Northern Alabama to stop the Emergency Use Authorization primarily around the vaccines, exaggerated cases and deaths, according to Dr. Ardis. Medical doctors, legal professionals and child advocates, who filed the lawsuits targeted Alabama’s District Court did because if their cases are heard there, that will have an impact and spread throughout all 50 states nationwide.

“All of this is very disturbing and we’ve got a group of lawyers at the America’s Frontline Doctors. We also have lawyers that are with myfreedoctor.com, who are all together working to defend as many people as possible against the onslaught of really senseless murder, to me, in my mind,” he concluded.

UN marks first International Day for People of African Descent

The UN celebrated the enormous contributions the African diaspora has made in every field of human endeavor, marking the first-ever International Day for People of African Descent.

UN Secretary-General António Guterres called for a greater commitment to advance the promise of equality, justice and dignity for all, in his inaugural message on Aug. 31.

Long overdue

"It is a long overdue recognition of the profound injustices and systemic discrimination that people of African descent have endured for centuries, and continue to confront today," the secretary-general said. "And it is an urgent call to action for everyone, everywhere, to commit to rooting out the evil of racism."

More than 200 million people in the Americas alone identify as being of African descent. Millions more are located worldwide outside the African continent.

Whether as descendants of the victims of the Transatlantic Slave Trade, or as more recent migrants, they are among some of the poorest and most marginalized groups, the UN said.

Last December, the UN General Assembly adopted a resolution establishing the International Day.

The objective was "to promote greater recognition and respect for the diverse heritage, culture and contribution of people of African descent to the development of societies, and to promote respect for human rights and fundamental freedoms of people of African descent."

Now is the moment

The resolution also recalled two related UN initiatives: the 2001 World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance, held in

Durban, South Africa, and the declaration of the International Decade for People of African Descent, which runs through 2024.

"Twenty years after the Durban Declaration and Program of Action, and more than halfway into the International Decade for People of African Descent, we are experiencing unprecedented momentum towards ending the global scourge of racism," said the secretary-general. "We must not squander this opportunity."

Costa Rica spearheaded efforts to create the International Day. The Central American country changed its political constitution in 2015, defining itself as a multiethnic and multicultural nation.

Jan André Solano is a university student and activist from Limón, a city on the Caribbean coast of Costa Rica, who admires the late civil rights icon, Dr. Martin Luther King, Jr.

He recently participated in a UN initiative that collects the stories of various people of African descent in his homeland, who also share their accomplishments, challenges, hopes and life lessons.

Still dreaming of change

Despite his achievements, Jan said he does not understand why some people cross the street when they see him, or why he is subjected to other indignities, including being closely watched in supermarkets or being singled out for police searches while in public.

Latin America is home to nearly 134 million people of African heritage and a recent report by the UN economic commission for the region, ECLAC, reveals how they suffer poverty, lack of access to basic services and inequality.

For example, in Brazil, the overall poverty rate is 11.5 percent, but among people of African descent, it is 25.5 percent. The story

is repeated in other countries such as Ecuador and Colombia.

Like Dr. King, Jan said he also has a dream: "That exclusion, inequality, racism and discrimination be banished forever from the world, and that I may have the same opportunities to develop, lead a prosperous life and thus dedicate myself to serving, and helping, all other people regardless of the color of their skin."

Acknowledge legacy, redress wrongs

The Secretary-General pointed to the UN's work to dismantle racism.

The Slave Route Project, run by the UN Education, Scientific and Cultural Organization (UNESCO), encourages open and honest conversation around the horror and greed of slavery.

Another initiative by the UN Population Fund, UNFPA, focuses on expanding opportunities for young people of African descent, while the UN human rights office, OHCHR, has launched the Agenda Towards Transformative Change for Racial Justice and Equality in efforts to tackle systemic racism, ensure accountability, and deliver reparatory justice.

Earlier this month, the UN General Assembly established the UN Permanent Forum of People of African Descent, a 10-member advisory body that will work closely with the UN Human Rights Council in Geneva.

"Acknowledging the entrenched legacy of enslavement, redressing the wrongs of history, and shattering the evil lie of supremacy, demands persistence and action every day, at every level, in every society," the UN chief said.

"Together, let us commit to do our part and advance the promise of equality, justice and dignity for all." (UN News)

Migrant death toll increases on Atlantic route to Europe

MADRID—At least 11 people are feared dead after another boat crossing the Atlantic Ocean to get from North Africa to Spain's Canary Islands became a trap for migrants trying to reach European territory, Spanish authorities and activists reported Aug. 31.

The Spanish government's delegation in the Canary Islands said rescuers retrieved 32 survivors and one body overnight from a rubber boat in waters south of Fuerteventura, the closest of the archipelago's islands to the African coast. One of the survivors died on the rescue boat.

Some of the survivors told authorities that some 60 people were on board when the boat set off four days earlier from a beach near the southern Moroccan town of Tantan, the delegation said.

Walking Borders, a non-profit group that works with migrants in peril and provides assistance to their relatives, said that its research indicated the boat had carried only 42 people when it departed Morocco, leaving up to 11 victims.

The organization, which has become one of the first contact points for African families trying to locate their relatives on the other end of the migration route, claims that some 2,000 people have died so far this year on their way to the Canary Islands. The Atlantic route is one of the most dangerous sea crossings to Europe.

"The human rights crisis at the border needs an urgent political response," Walking Borders founder Helena Maleno said in a tweet addressed to Spanish Prime Minister Pedro Sanchez.

Despite the initial discrepancies involving the August 31 rescue, the International Organization for Migration said it counted nine people as missing and two confirmed casualties from the vessel.

The UN agency has confirmed the deaths this year of 529 migrants who were attempting to reach the Spanish island chain, but the agency says the number does not reflect the actual death toll since people disappear at sea without ever being reported missing or having their bodies found.

Survivors of other failed crossings also have reported that bodies of fellow passengers were thrown into the sea before rescuers arrived.

Walking Borders said August 30 that at least 29 Africans, including seven children, had died on a boat that was the focus of an Aug. 27 rescue. A total of 25 adults and one minor survived. (AP)

Resistance leader's death deepens Kashmir strife

NEW DELHI—The death of a top separatist leader in disputed Kashmir and the ensuing crackdown on public movement and communications by Indian authorities have highlighted the turmoil seething just below the surface in the region.

Here's a closer look at what Syed Ali Geelani meant to Kashmir and why problems still roil the region two years after India revoked its semi-autonomy and declared it a federal territory.

Why has this death struck a raw nerve?

For many in the region, Mr. Geelani was the face of Kashmiri resistance against India. To his detractors, he was a hard-liner responsible for stoking tensions in the region, a charge he had denied.

Mr. Geelani was part of the All Parties Hurriyat Conference, a conglomerate of various Kashmiri political and religious groups that was formed in 1993 to spearhead a movement for the region's right to self-determination.

He never wavered from his position as a devoted proponent of the merger of Kashmir with Pakistan. This stance put him at odds with other moderate separatists who wanted to engage with New Delhi and local politicians who favored Indian rule in the region with internal autonomy.

Soon after the 92-year-old's death late Sept. 1, authorities quickly clamped down, blocking internet and mobile phone services and restricting public movement out of fear of anti-India protests. Mr. Geelani's family said his body was snatched away by authorities

and discreetly buried without their consent.

Mr. Geelani's death is expected to be a potential setback to the larger separatist movement in Kashmir, as his supporters may find it hard to find a successor with such towering popularity.

What is the status of Kashmir?

A flashpoint between India and neighboring Pakistan, both of which claim the region in full but rule only parts, Kashmir has been wracked with tensions for years.

In 1989, Kashmiri activists launched an armed revolt against Indian rule. Most Muslim Kashmiris support the rebel goal that the territory be united either under Pakistani rule or as an independent country.

New Delhi accuses Pakistan of sponsoring Kashmiri militants, a charge Pakistan denies. Tens of thousands of civilians, rebels and government forces have been killed in the conflict.

In 2019, hostilities peaked when Prime Min-

ister Narendra Modi's government stripped the region of its semi-autonomy and took direct control of the region amid a harsh security clampdown and communications blackout.

Anticipating a massive backlash and protests, authorities flooded the region—already among the world's most militarized—with soldiers, and arrested thousands of young people, activists and pro-freedom Kashmiri leaders. Even pro-India politicians who favored Kashmir's semi-autonomous status within the framework of the Indian constitution were also detained for opposing the decision but were later released.


By scrapping its statehood and separate constitution, India also removed inherited protections on land and jobs and opened up the region to Indians from outside to permanently settle, buy land and hold government jobs there.

The government said such a move would spur investment and bring more development to Kashmir. But critics and many Kashmiris fear this could dilute the region's demographics.

What has happened in the last two years?

The situation on the ground remains tense. India's August 2019 move deepened anti-India sentiment in the region. Armed militancy has continued to grow and gunfights between Indian forces and rebels have become more frequent. Even though many of those arrested two years ago have since been released, some remain in detention.

The move also dealt a blow to Kashmir's economy, which was then hit once again by lockdowns to curb the spread of the pandemic.



The region has since remained without an elected government and under the direct control of New Delhi.

Last year, India held local elections, calling it a vital grassroots exercise to boost development and uproot corruption. An alliance of pro-India politicians who favor self-governance in Kashmir but oppose New Delhi's recent policies won the election. They have since reiterated their demand that the 2019 decision be reversed.

Later in June, in an effort to counter criticism, Mr. Modi held a meeting with pro-India politicians from the region. The government dubbed it as an opening "to strengthen the democratic process" in the region, but the alliance leaders said they did not get any concrete assurances from Mr. Modi.

The region's separatist movement has also been impacted in the last two years.

Among those detained in 2019 were numerous top separatist leaders. With many of them still behind bars, the movement's presence on the ground has taken a hit. (AP)

UK food, hospitality firms hit by shortages, shoppers warned to brace for price hikes

Stock shortages have impacted over a quarter of food and hospitality businesses in the United Kingdom in recent weeks and shoppers were told to expect higher prices as the country's supply chain crisis gets worse.

Twenty-seven percent of food services and accommodation companies have experienced low stock levels and other sectors are also beginning to experience the same problems, according to a survey by the Office for National Statistics (ONS).

While a quarter of retail and whole-



salers reported problems, 23 percent of manufacturers cited similar issues, the survey shows.

The mounting disruption to supply chains have resulted in empty shelves in supermarkets and forced some restaurant chains to close.

A severe shortage of lorry drivers, which has been deepened by both the pandemic and Brexit, has affected several businesses, including meat processors and fruit farms and McDonald's that ran out of milkshakes recently.

Meanwhile, Haulage industry bosses issued warnings, telling shoppers to brace themselves for higher prices, while retailers have raised wages for lorry drivers.

"Certainly, drivers' pay is increasing, often by quite substantial amounts," Rod McKenzie, the managing director of the Road Haulage Association (RHA), told the PA news agency.

"This, in turn, is a cost that will need to be passed on, and given the tight profit margins of most haul-

age operators, that means their rates to customers will have to go up.

"In turn, this may mean more of us paying higher prices for goods, services and shopping—including food prices—going forward."

The RHA also said the situation is "not getting better," warning it would take a long time to train new drivers and that means government action is needed.

The Covid-19 pandemic has caused disruption to supplies of manufactured goods, and shipping rates have spiked this year as economies have reopened, causing demand to rise dramatically.

In plumbing industry, for instance, plumbers have been forced to delay work because vital parts are out of stock, with long lead times.

Kevin Wellman, CEO of the Chartered Institute of Plumbing and Heating Engineering, said the industry had been experiencing growing disruption for 18 months, and the situation has deteriorated by ad-

ditional red tape after Brexit.

"Manufacturers are doing all they can but they can't just increase supplies overnight. It's just been one thing after another for the poor, unsuspecting tradesperson who has just been trying to get things up and running."

Shortages of raw materials and skilled workers have badly affected builders too, with over one in seven construction companies reporting they have been unable to get their needed materials in recent weeks. (PressTVir)



Brazil's Indigenous march to pressure court on land ruling

BRASILIA, Brazil—Thousands of Indigenous people marched toward Brazil's Supreme Court in late August to pressure justices expected to issue a ruling with far-reaching implications for land rights.

Wearing feather headdresses and with their bodies painted, they sang and danced along their three-mile route. The group, which had been camping in the capital behind the National Theater, is comprised of some 6,000 people from 173 ethnic groups across the country, according to Association of Brazil's Indigenous Peoples, a rights group and one of the organizers.

Justices will be evaluating a lower court's ruling that invalidated a claim by some Indigenous people in Santa Catarina state to what they say is their ancestral territory. The lower court based its decision on allegations the group wasn't occupying the land in October 1988, when Brazil's constitution was signed after the nation's return to democracy, which the group denies.

The Indigenous people were frustrated that the court didn't start discussing the case August 22. The majority of justices have yet to vote on another contentious debate, regarding the constitutionality of the Brazilian central bank's autonomy.

Protest organizers say the court's decision could be "the ruling of the century," because negating the 1988 benchmark would force judges across the country to impose that understanding on similar pending cases, and also affect the fate of a related, controversial bill advancing in Congress.

President Jair Bolsonaro suggested that overturning the lower court's ruling would prompt new requests to officially recognize hundreds of Indigenous territories.

His attorney general filed a request to the

country's top court seeking to stop the Indigenous people from gathering, citing pandemic protocols that the president himself has repeatedly ignored. Justice Luis Roberto Barroso denied the request, saying he believed demonstrators were taking precautions.

Farming groups argue the 1988 cutoff date provides certainty regarding property law, but rights defenders say it ignores the fact many Indigenous people had been forcibly expelled from their lands, particularly during the military dictatorship, or may not have formal means to prove possession.

Pi Surui, from the 7 de Setembro village in the Amazon rainforest state of Rondonia, said he had come to the capital to make clear that Indigenous territory is more than just land.

"It is sacred, our history, our life," Surui, 23, said at the encampment. "We have the right to

grow our crops and sell our livestock, our fish, live sustainably. We are also adapting to the new times, balancing our needs and advances as human beings, but without losing our culture."

The Santa Catarina state government says the Indigenous people involved in the current court case "invaded" the land in 2009. The Xokleng people say the original extent of their territory was progressively diminished by encroaching agribusiness and that they never left the area.

Mr. Bolsonaro has repeatedly said Indigenous people control far too much land relative to their population—their territories cover 14 percent of Brazil, most in the Amazon—and has been outspoken about his desire to promote rural development.

Together with farm interests, he has argued that the 1988 cutoff had already been established by an earlier court ruling. Changing it now

would create "chaos," he said in a television interview.

Some of the people marching on August 22 held banners that read "Bolsonaro Out" and "Indigenous territory is life."

Jose Miguel Vivanco, executive secretary of Human Rights Watch for the Americas, took to Twitter to oppose the cutoff date, which he said large landholders and Bolsonaro allies are supporting in order to expel Indigenous people.

Separately, the lower house of Congress's Constitution and Justice Committee in June approved a bill that would officially establish Oct., 1988 as the reference date for Indigenous people seeking full protection of their territories to have been occupying the land. There are more than 200 such pending requests, mostly for small territories located outside the Amazon rainforest. The bill is awaiting a floor vote.

A court ruling upholding the 1988 date would add legal backing to that bill in Congress, said Pataxo, the lawyer. If the court strikes down the prior ruling, that would weaken the bill's momentum by providing justification to challenge its constitutionality in the future.

Brazil has 421 officially recognized Indigenous territories that are home to 466,000 people, according to the nonprofit Socioenvironmental Institute.

At a night vigil ahead of the August 22 march, Indigenous people held lights and carried banners, one of which read: "Our history doesn't begin in 1988. We have resisted for more than 12,000 years." Associated Press writer Debora Alvares reported this story in Brasilia and AP writer David Biller reported from Rio de Janeiro.

'America is surrounded with the Judgement of Allah (God)'

Record rainfall, deadly flooding as aftermath of hurricane strikes Northeast

Historic, biblical proportions, catastrophic and apocalyptic. These are just a few of the words being used to describe the aftermath of Hurricane Ida which ripped through the Gulf Coast before heading up the Northeast portion of the country, leaving behind a path of destruction and death.

Federal, state and local officials and millions of American citizens are still reeling and trying to recover in the aftermath of one of the most powerful hurricanes to hit the Gulf Coast in years.

Days after hitting the Gulf Coast, remnants of Hurricane Ida struck the Northeastern states bringing historic floods in New York, New Jersey, Pennsylvania, Maryland, and Connecticut. For the first time in New York's history, the National Weather Service issued a flash flood emergency, urging residents to move to higher ground.

Dangerous floods, record rains and tornadoes resulted in the deaths of at least 60 people, including a two-year-old, at Final Call press time.

The National Weather Service reported, rainfall in Central Park broke a 94-year-old record dropping 3.1 inches of rain in one hour; while Newark, N.J. broke a 62-year-old record.

The Port of Authority of New York and

New Jersey, which operates the major airports in the region, said that all flights had been suspended.

"The storm had caused 59,519 power outages statewide and these numbers are climbing," Gov. Phil Murphy of New Jersey said on Twitter. "That of the 23 victims in the state of New Jersey, most of the deaths were people who got caught in their vehicles by flooding and were overtaken by the water. Our prayers are with their family members," he added.

The remnants of Hurricane Ida triggered thunderstorms that also spawned at least seven tornadoes that struck parts of New Jersey and Pennsylvania. Princeton in Mercer County and Upper Makefield Township in Bucks County, Pa., and other areas reported twisters that damaged multiple homes. New Jersey gets an average of two tornadoes per year but in 2021 has already been hit by 13.

"We're moving into a world we've never seen. When people say, 'flooding in New York City,' what is our reference for that? I don't think anyone could imagine subways flooding that dramatically. I think it's a matter of getting people to take warnings more seriously, because now we've seen what can happen," Tripti Bhattacharya, an assistant professor of earth and environmental sciences at Syracuse University, told NPR in a Sept. 3 interview.

Hurricane Ida made landfall August 29, off the Louisiana coastline. The Category 4 hurricane sustained winds of 150 miles per hour, damaging vehicles, ripping roofs off buildings and homes, uprooting trees, cutting water off to 600,000 homes and knocking out power to over one million homes in southern Louisiana. Power to New Orleans' 911 emergency response system was temporarily disabled during the hurricane.

An estimated total damage and economic loss from the hurricane, calculated by AccuWeather, could reach \$70 to \$80 billion. This tally includes both insured and uninsured losses; damage to structures and their contents and to cars; job and wage losses; business losses; travel disruption; and medical expenses. The estimate also includes long term impact on affected industries, including tourism and oil and gas production.

"We've been monitoring this hurricane closely and the devastation it's caused. To date, six deaths, about a million homes without power in Louisiana and Mississippi. While the catastrophic flooding wasn't as severe as it was during Hurricane Katrina 16 years ago, Ida was so powerful that it caused the Mississippi River literally to change direction, change the flow, temporarily," said President Joe Biden.

A few days after the hurricane, power was restored to some of the French Quarter in New

Orleans, but over a million people are still without electricity in the area. New Orleans-based power company Entergy is sending out a crew of at least 20,000 workers, which it expects will still take several days to assess the damage in New Orleans and southeast Louisiana. The storm took out all eight power transmission lines in the area along with some generating stations, and customers in that area could face extended power outages lasting for weeks.

President Biden approved Louisiana's request for a major disaster declaration, allowing federal funding to reach residents and business owners.

The Federal Emergency Management Administration (FEMA) sent 3,600 of its personnel and 3.4 million meals to the storm devastated areas. People have endured waiting in long lines in sweltering heat and humidity for gas, food and supplies.

President Biden visited Louisiana almost a week after the storm to get a firsthand look at the destruction. "This storm has been incredible, not only here but all over the East Coast. I know you've got to be frustrated about the restoration of power. We're working 24-7 with electric companies and supplying generators," President Biden said in a meeting with officials.

Meanwhile out West, The Caldor Fire had calmed significantly Sept. 3 but remained just a few miles from the California resort town of South Lake Tahoe, reported AP. On Aug. 30 flames raced so quickly toward the city that officials ordered a mass evacuation of all 22,000 residents, the agency noted.

"More than 15,000 firefighters were battling dozens of California blazes that have destroyed at least 1,500 homes. One blaze, the Dixie Fire, was about 65 miles north of the Caldor Fire. It is the second-largest wildfire in state history at about 1,350 square miles and is 55% contained," added AP.

Student Minister Rodney Muhammad of Mosque No. 12 in Philadelphia extended condolences to the families who have lost loved ones as a result of the impact of Hurricane Ida. "We noticed that this storm Ida, came on the date, 16 years ago of Hurricane Katrina. There has never been a flood like this in the city of Philadelphia, according to authorities and this water came up substantially high. This city was devastated in terms of its ability to operate and perform at normal capacities," Student Min. Rodney Muhammad told, The Final Call.

"This is unusual weather, the storms are different now. The authorities have to rethink how to prepare for these storms. These were predictions by the Most Honorable Elijah Muhammad in his writings, that Allah always uses that which is with you, as instruments of destruction," he added.

"The Honorable Minister Louis Farrakhan said in a 2017 address that 'the forces of nature were going to intensify.' We're seeing that now, it's been increasingly intensifying throughout the country. Within the last 50 years there's been a tremendous increase of hurricanes," said Student Min. Rodney Muhammad.

Meteorologists, climate observers and politicians warn that drought, fires and hurricanes will intensify and blame climate change due to global warming. However, the Most Honorable Elijah Muhammad, Eternal Leader of the Nation of Islam, warned America that due to its over 400-year abuse and mistreatment of Black and Indigenous people, God Himself would punish her.

America is surrounded with the Judgement of Allah (God), Mr. Muhammad wrote in his prophetic and illuminating book, "The Fall of America."

"Why should these things hit America? The Revelations teach you why. It is because America is filled with devils and has such unclean persons living in America. That is true under the symbolism of a hateful bird. His top student, the Honorable Minister Louis Farrakhan, has warned America for decades to "watch the weather." The scientists of this world do not cause rain, hail, snow and earthquakes, the Minister has stated.



Greetings to you. I am Minister Louis Farrakhan, National Representative of the Honorable Elijah Muhammad, The Eternal Leader of The Nation of Islam, and that Great Preacher of Freedom, Justice and Equality to the Black people of America, the Western Hemisphere, and The Aboriginal People of the Earth.

The Great Preacher, Elijah Muhammad, has given us this subject: "The Time and What Must Be Done"—and this subject will be with us until Allah says "stop."

'The Uphill Road' a Messenger of God must travel to deliver 'salvation' and 'warning'

It is written in the **Holy Qur'an**, in the **5th Chapter**, the **67th verse**: "*O Messenger, deliver that which has been revealed to thee from thy Lord. And if thou do it not, thou hast not delivered his message. And Allah will protect thee from men. Surely Allah guides not the disbelieving people.*" To "deliver" a message like the one that we are delivering demands The Protection of God for *The Messenger* and *The Message*.

For 44 long years, the Honorable Elijah Muhammad preached this Message of "Salvation" and "Warning." No matter what consequences he faced, no matter what threats came against his life, no matter who opposed what he said, he kept, before the world, The Message that Master Fard Muhammad, The Great Mahdi, gave him to give to us, to America, and the world.

(It is) to free a slave, or to feed in a day of hunger an orphan nearly related, or the poor man lying in the dust.*"



Elijah Muhammad had that “mountain,” that “uphill road” to climb for 40 long years; going to prison ... Not because he was a “wicked” man, but because America did not want him preaching The Word that he was given while America was prosecuting a war with Japan. And after 40 years of suffering, 40 years of rejection, 40 years of being misunderstood, and mislabeled by The Wicked as a “hate teacher”; as “a man that Black people,” and White people as well, “should not listen to”—at that “40th year” he Departed from us.

But, he had already said to me: “*Brother, you may sit as ‘The Father over The House’ in my absence,*” and he would send people to me from time to time, telling me, “Remember, brother, Aaron had a hard job when Moses left. ...” And so when he left, I did start having a “hard time”—and it continues to this very moment. But as my Spiritual Father, Elijah Muhammad, was *faithful* in delivering that Message *without fear* of The Enemy’s evil plans against him, **I, too, am delivering that Message.**

I am sorry that it’s preaching “the doom of a world” and “the salvation of a people.” Nevertheless, it is what *must* be taught in order that you know and understand “The Time and What Must Be Done”! Again, if I don’t do this job of speaking truth to power, even if it *costs me my life, or imprisonment, or being rejected and despised, and cast aside*, nevertheless, I must do what I am commanded: “*O Messenger! Deliver the message that has been revealed to thee from thy lord. And if thou do it not, thou hast not delivered His message, and Allah will protect thee from men.*” So far, The Protection of Almighty God Allah was with the Honorable Elijah Muhammad, who told me, “*Brother, there’ll be Two of Us backing you up: Allah and myself.*”

So regardless to how “hard” The Truth may be, it is not my intentions to hurt your feelings, or to preach “gloom” to you that would become “frightened”—unless it frightens you into making The Change that will cause you not to continue to suffer the loss that you are now suffering, which is going to increase.

The Duty of ‘The Watchman over The House of Israel’

I would like for you to study what is written in the **Book of Ezekiel, Chapter 3, verses 16-19**. As God is talking to the “Son of Man,” He

says to him: “*Son of Man, I have made you a watchman unto the House of Israel. Therefore, hear the word at My mouth, and give them warning from Me. When I say unto the wicked thou shalt surely die, and thou givest him not warning, nor speakest to warn the wicked of his wicked way to save his life, the same wicked man will die in his iniquity, but his blood will I require at thine hand. Yet, if you warn the wicked and he turn not from his wickedness, nor from his wicked way, he shall die in his iniquity, but you have delivered your soul.*”

I have “heard The Word” from His Mouth, and I am giving Warning to you! I am trying my best to save your life because The Terrible God that was to come is *present*, and the things that He’s prophesied, and given Jesus The Warning to give to you of “The Signs of The End”: God is making fulfillment of His Promise!

So by my warning you, even at the cost of my life: If you don’t do it—if you don’t change, if you don’t get away from your wicked way, God says you will “die in your iniquity.” But if I warn you, and you still persist in wickedness, *your blood is not on my hand.*

And to all of you “spiritual teachers,” you “religious scientists”: Stop preaching “gospel” that does not include “The Judgment of the world” which we are now facing! What kind of “spiritual leaders” are we if we won’t warn the people?

If you are not going to prepare your people to escape The Judgment, then the scriptures teach us, “*Woe to the shepherd who’s feeding himself, and not the flock*”: Don’t you think that the people want to know what is going on around them? Don’t you think they want to lift their head up from the “slop trough,” and understand what God is doing to America and the world? Why is the economy failing? Why are the people confused? Why is the government unable to solve its economic dilemma? Why are “the clouds of war” forming? Why are there wars, and rumors of wars? Why is there drought in 29 states? Why is pestilence coming? Why are

earthquakes on the horizon? Don’t you want to know?

Well, “*Son of Man,*” God said, “*I’m setting you as a watchman over Israel ...*”: My Father, Elijah Muhammad, was a “watchman” over this condition, this world, this people, this Time! And he has prepared me the same: To be a “watchman” over you!

‘God’s Promise’ to The Kingdom’s Rightful Heirs renders powerless ‘Satan’s Pledge’

My dear and beloved brothers and sisters, in **Part 9** of this Lecture Series on “**The Time and What Must Be Done**,” I mentioned exegesis given by the Honorable Elijah Muhammad on **four Parables of Jesus** that are, literally, about “The Black Man and Woman of America and the Western Hemisphere” (“The Lost Sheep,” “The Prodigal Son,” “The Stone that The Builders Rejected” and “The Wicked Husbandmen”).


If you remember in the parable of “**The Wicked Husbandmen**” found in the **Book of Matthew, Chapter 21**, and the **Book of Luke, Chapter 20**, it is talking about a “vineyard.” After the owner of the vineyard let it out in the hands of some wicked husbandmen, he would send people into the vineyard to check on the fruit of that vineyard. And if you recall, the definition of a “**husband/husbandman**” is a *master* of a house; or, a *tiller* and a *cultivator* of the soil.

Well, when God puts a “ruler” over the vineyard—or, in *clearer* terms, when He made the Caucasian people a “ruler/vice-gerent” over the peoples and societies of the Earth, and their institutions: *God sent prophets into the world.* And The Mission of those prophets was to see “**What was the fruit of your work in His Vineyard?**”: Did you cultivate the people?

Did you bring them into their humanity, and expose to them their *latent* (“hidden,” “dormant,” “unexpressed”) Divinity?

Or, did you kill the prophets? Imprison them? Beat them? Lie on them? And destroy the righteousness of their work?

So the scripture teaches us that when *the heir* to the vineyard—the owner’s son—was sent into the vineyard, The Wicked Husbandmen *seized him and killed him*. After this happened, then Jesus,

talking to the Jewish people of that time, asked the question, “*What will the owner of that vineyard do when he comes?*” which is the same as saying: “What will God do when He makes His Appearance in the world?” After they gave their answer, Jesus said to them: “*Have not you read in the scriptures, that the stone that the builders rejected has become the headstone of the corner...*”; and I want you to focus on these words that follow, which tells us what God’s Promise is to The Heirs of His Kingdom. Jesus said:

“Therefore I say unto you that The Kingdom of God shall be taken from you, and given to a nation bringing forth the fruits thereof. And whosoever will fall on this stone shall be broken, but on whomsoever it shall fall, it will grind him to powder.”

Well, here we are—The Prophets have come, and some you beat, some you killed, some you cast into prison.

Did you know that we, the Black people of America in particular, and those in the Western Hemisphere—who are the victims of the worst slavery in the annals of history, who were brought into the Western Hemisphere in this *crime against humanity* called “The International and Trans-Atlantic Slave Trade”: We are The Heirs of that Promise! We were seized! We were beaten! We were imprisoned! And, we were put to death “mentally,” and also put to death physically!

So when Jesus of 2,000 years ago made this Parable, and asked, “*What will the owner of the vineyard do on his coming?*”—he’s literally saying to the people to whom he was speaking: What will God do when He comes into the world *after* your 6,000 years of mis-rule is up? And they gave “the right answer”:

“He will miserably destroy those wicked men. And he will let out his vineyard unto other husbandmen which will render him the fruits in their seasons.”

You have done a pitiful job in cultivating The Human Being. Every prophet that came was teaching people into a spiritual




Hurricane Ida seen from the International Space Station. Photo: MGN Online

civilization; and every prophet that came: Satan destroyed his work. The “Pledge,” or “Aim” of Satan can be found in the **Holy Qur'an, Surah 7 Al-A'raf (“The Elevated Places”)**, verses 11-18, where Satan and Allah (God) are having a conversation. Satan is asking God for a “respite” (a short delay permitted before an unpleasant obligation is met or a punishment is carried out): “*Respite me till the day when they are raised*”; and God said to Satan, “*Surely you are of the respite ones.*”

Satan’s Pledge to God is this: “*Because you have judged me to be erring, and caused me to remain disappointed, I’m going to lie in wait for them; right in your Straight Path. I’m going to come to them from before them, from behind them, from their left side and from their right side. I am going to make all of them deviate. And You won’t find most of them thankful ...*”—and Satan made good on his “pledge”! And then Allah (God) said, “Whosoever follows you, I will certainly fill hell with you all.”

So to my dear Christian and Muslim Family: Have we deviated? Dear *Children of Israel*: Have we deviated? Dear *Family of Abraham*: Have we deviated? Are we showing that we are “grateful to God” for the prophets that He gave, one after another, to this



world? No, you are not “grateful”. ... You have taken this people, The Black People of America and the Western Hemisphere, and stripped us of our connection to Africa, to our own religion and God, and to our own culture and name.

You have had sway over the Earth and its people. You have had power to set up your institutions of governance, your institutions of religion, your institutions of jurisprudence, your institutions of education and your institutions of economics. This is your world! In the Bible, the **Book of Daniel** and the **Book of Revelation**, the scriptures mention a “4th Beast,” which is “more terrible than any other”—this is referring to America! And another Beast is described as having “*the ribs of a man in his mouth.*” ... Well, we are that people that you have “torn to pieces”; and because we are “The Heirs” of that Promise: As you have destroyed us, The God Who is Present is now destroying you. Today, The God of Our Salvation has appeared, and there is no “power” that you have that can stop Him from Redeeming The Black Man and Woman of America and the Western Hemisphere, and fulfilling His Promise to us.

And what is that “Promise”? Again, it is The Promise that was given to Moses, that God was going to take “The Children of Is-

rael” and separate them from Pharaoh and the Egyptian people of that time; also, God was going to send them into a land; and that He would give them a land “flowing with milk and honey.” That same Promise is extended to The Black Man and Woman of America: He Promises us *land*.

In the **Book of Isaiah, Chapter 28, verse 16**, God says: “*Behold, I lay in Zion for a foundation a stone, a tried stone, a precious cornerstone, a sure foundation ...*”—the Black Man and Woman of America and the Western Hemisphere are *rejected* in all societies; but that “*rejected stone*” would become “*The Head Stone of The Corner.*” And in the **Book of Romans, Chapter 9, verse 33** God says, “*Behold, I lay in Zion a stone of stumbling and a rock of offense. ...*” Well, you have “stumbled” on us, and now you are “breaking into pieces.”

The interesting part about the prophecy found in both the Bible and the Holy Qur'an, “*I am going to take the kingdom from you, and give it to another,*” is that “**The Power of God**” is being expressed, in that God says 1) “*He takes the kingdom from whom He pleases*” and 2) “*He gives it to whom He pleases.*”

When God says He will take the kingdom from you, and He will give it to “*a nation that will bring forth the fruits thereof ...*”—what “nation” is that? This nation is talked about in the **2nd Surah** of

the **Holy Qur'an** when Abraham and Ishmael had laid the foundation of The Spiritual House that is “The Spiritual Center” for all Muslims, The Holy Ka'abah at Mecca. When Abraham and his son Ishmael finished that building, they prayed: “*O Allah! Accept this from us. And make us Muslims, and raise from our offspring a nation in submission to Thee. And raise from among them a messenger, and teach him and purify him, that through him he might purify this people.*”

So, here we are: Do we need purification? Yes we do! And the scripture teaches in the **Book of Malachi, Chapter 3, verses 1-3** that when that *Son of Righteousness* comes, he would be like “fullers soap,” like a “refiner’s fire,” and he would be “the purifier of his people.” And all those who submit to do The Will of God: Their *conduct*, their *language*, their *life* will be “purified.”

The scriptures are clear: A nation is going to be given “The Kingdom,” and that “nation” is a nation carved out by God for Himself of The Black Man and Woman of America.

God has asked you: “*Let them go*,” because God has something for them to do for His Glory. If you *let them go*, The Calamities that you are suffering will decrease. But if, as you are doing now, you plan to fight against God, and plan to deceive the Black man and woman that they may go down into hell with you, then God will still separate them because He has The Power to do so—and you will go to hell by yourself.

The Signs of distress, confusion plaguing men and nations

Jesus told us of a lot of “signs” that would be *spoken*, and that would be *fulfilled*; and these signs would tell us “The Time.” Let us study what is written in the **Book of Matthew, Chapter 24, verse 34**: “*Verily, I say unto you: This generation shall not pass till all these things be fulfilled.*”

Question: How many generations have passed since Jesus preached those words? It has been 2,000 years, so how many “generations” have come and gone since those words were uttered?

Surely this prophecy could not have been talking about “the time of Jesus The Prophet,” that “this generation shall not pass till all these things are fulfilled.” Well, when you check what a “generation” is, according to the dictionary it is a span of “30 years”; and if we calculate how many times “30” goes into “2,000” the answer is “**66.666**” times. Does that number “ring a bell”? It is **The Number of The Beast**—and The Hour of His Destruction has come.

So I can say in The Name of “The Great Mahdi,” *Master Fard Muhammad*, and in The Name of His Christ, “The Great Messiah,” the Honorable Elijah Muhammad: This generation shall not pass until every word that Jesus of 2,000 years ago spoke, and every word that Elijah Muhammad has spoken to us, shall be fulfilled.

White and Black and Brown, Asian: All of this affects us all. Every one of you “scholars” should get this book. All of you who preach The Gospel, whether you are an *imam*, whether you are a *rabbi*, whether you are a “leader” of religious groups: **Get this book, and study it, because the Honorable Elijah Muhammad gives you the clearest exegesis of the scriptures that foretell “The Fall of America” and “The Destruction of this Present World.”**

In the **Book of Luke, Chapter 21, verses 25-26** teach: “*There shall be signs in the sun and in the moon and in the stars; and upon the earth, distress of nations with perplexity. The sea and waves roaring, and men’s hearts failing them for fear and for looking after those things which are coming on the Earth for The Powers of*

And yes, the sea and the waves are “roaring,” for the Honorable Elijah Muhammad is talking about “the seas” and what is happening; and the effect that The Moon is having on the waters. *It will get worse.* And when the scripture mentions “men’s hearts failing them for fear”: What is the “No. 1 killer” of people in America? I have read that it is “heart failure.” What are you “afraid” of, America? *Look up above your head:* Look at the storms! Look at the tornadoes! Look at the hurricanes! Look at the water! Look at the fire! Look at the wind! Look at freezing cold! God is after us. Men’s hearts are failing them with fear for what they see coming upon the Earth.

And if you’ll read, or look at the news, “Are the nations in distress?” My God! There are *17 nations in Europe* that are now taking *austerity* measures to address their debt crisis—they are “in distress” because their economies are collapsing! I even read in a news article that France’s Labor Minister, *Michel Sapin*, was telling the French people that the country is, quote, “totally bankrupt.” And there are scholars of economics in Amer-

ica that are warning that America is nearly “completely bankrupt,” because when the “Gross Domestic Product” (GDP) is under the “debt ceiling,” here you have over \$16 trillion in debt that is swamping, drowning the GDP. **Those are not “good” signs! Those are the signs of distress and affliction.**

The nations of the Earth are in distress—with *perplexity*, which means “confusion.” Are the heads of our government confused? You mean you can’t sit down in a room and agree on “a way forward” to solve the problems of the American people? Yes. ... The confusion that you wanted to produce, and have produced, among us: Now God is taking it off of us, and putting it on you. **These are the signs of the end.**

Study *The Fall of America, Chapter 35, “America Surrounded with The Judgment of Allah”* (page 154) and *Chapter 36, “Four Great Judgments of America”* (page 157).

In **Chapter 35**, he writes: “*The four great judgments that Almighty [God] Allah is bringing upon America are rain, hail, snow and earthquakes. We see them now covering all sides of America, as the Holy Qur'an prophesies, ‘curtailing her on all her sides’. And these judgments would push the people into the center of the country, and there they would realize that it is Allah (God) Who is bringing them and their country to a naught.’*

What do you mean “pushing the people into the center of the country”? He told me to tell you, and he wrote it himself, that *the coastlines—all of them—will be destroyed*. And some of your own scientists are talking about “global warming” and the “melting of the glaciers”: This is not an “accident”!

You want to say that it’s what “we are doing to the environment, etc.,” and we have some responsibility, however *The God of*

Heaven is doing this! And as these glaciers melt, the waters of The Pacific and The Atlantic Oceans are going to rise! And as they rise, they will overspread, and destroy your borders in the East with The Atlantic Coast; in the West with The Pacific Coast, and in The South with The Gulf Coast. It’s happening now. But it will get worse as you continue your rebellion against God, and His Call that you *must* do in order to escape “loss.”

And in **Chapter 36**, he writes: “*To be plagued with too much rain will destroy property and lives. It swells the rivers and creeks. Too much rain floods cities and towns. ... Rain makes the atmosphere too heavy with moisture causing sickness. Wind with rain can bring destruction to towns and cities, bringing various germs, causing sickness to the people. It produces unclean water by the swelling of streams and destroying reservoirs of pure drinking water used for the health of the people. Rain is a destructive army within itself. Hail stones are also a property and life destroyer.*”

The Honorable Elijah Muhammad wrote these words 40 years ago. And it is even greater today—showing you that a Man of God and His Word is never “outdated,” it is **always “on time,”** for in **Chapter 35** he writes: “*These are not the days of Noah, Lot and Abraham, nor are these the days of Moses. These are new times. The enemy does not get away in punishing the righteous just because he hates them. Allah, the God of Righteousness, is with us and He just Laughs at those who try to fight against Him. He has destroyed whole nations with less than the power of rain, hail, snow and earthquakes. The Holy Qur'an has the record of people even being destroyed by gnats.*

That’s how disrespectful Allah is of The Wicked: He will take something as small as a “gnat” and multiply it into the millions, and drive you

to destruction! He does not have to “go to work,” as in get a “block of iron” or “a mountain,” and throw it on them! He just causes that which is with you to turn against you!

“*The forces of nature,*” he continues, “*are great weapons as we see them in play upon America. Storms after storms of snow and ice are rolling in from the North and are pushing great drifts that are just covering up everything.*” Well, the Holy Qur'an says that Allah (God) destroyed people with just cold wind. *He froze them.* ... No wonder in the **2nd Chapter of the Book of Psalms** God says that He will “sit in the heavens, and laugh at those” who are trying to fight against Him.

And I, too, laugh: **Do you think that you can “get away” with fighting Allah (God)?**

What will be your course of action?

Well, after hearing these things, the question I have to ask: **“What are you going to do, America?”**

The Honorable Elijah Muhammad is asking that you:

“Separate The Black Man and Woman,” because God wants to make a great nation out of us; and **“Give us a good send-off.”**

Black Man and Woman: What should you do? Get busy! Let’s unite! Let us stop this wanton killing of each other!

The learned of our people; the professional people: Why don’t you look at The Program of The Honorable Elijah Muhammad, and unite with that Program to put *the hands* of our people to work, and *the feet* of our people moving in a *free* direction? murder, the felonization of Elijah McClain because of the skin that he was born in. Aurora and Aurora Police Department has continued to enforce Jim Crow laws to continue to murder Black men and women.”

She said in order to get a conviction, it will take the same thing it took to get the indictment.

“It will take the people. This has been a journey and a pathway of a multilayered defense mechanism. And if we look back in time, it’s the art of war. If you look back at the ways that movements were successful throughout our history, it would take layers,” she said. “It wasn’t just someone going out and speaking and having a rally and a march. It wasn’t just a sit-in. It wasn’t just someone breaking windows and burning things down and looting. It wasn’t just someone in the back room talking politics and how to change things. It wasn’t just someone in the back room who was making economic power moves. It was not a singular narrative. It was all of those things combined, and it will continue to take all of those things, but we must become unified in those things.”

Ms. Newman said there is ample evidence that Elijah’s civil rights were violated. “As part of the civil case, of course I engaged experts, medical experts, law enforcement experts, all of whom came to the conclusion that these officers and medics killed Elijah,” she said. “Certainly, the attorney general has similar experts that will say the exact same thing.”

Shareef Aleem, an activist, community organizer and founder of Aurora Cop Watch who was involved in many of the early protests regarding Elijah’s death, said he’s “optimistically cautious” about the case. He said he’s a good friend of Elijah’s father and was told about the young man’s death by a family member. He explained that there was a “mad community rush” to get justice, and it intensified after the death of George Floyd in May 2020. Six protesters walked away with felony charges that summer.

“I think these indictments were put out there to kind of quell a lot of the public protests, but we’ll just have to see what’s going to happen in the months or years to come,” he said.

He described getting the conviction as the real hurdle and said one or two may be convicted, but he doesn’t know about all five.

Ms. Minter has also been fighting for justice for Elijah for two years and has seen many of her friends arrested and charged for protesting.

“If protesters have to spend weeks in jail and pay \$75,000 bonds and face up to 36 years to 70 years in jail and in prison, us having this whitewashed process that the police officers go through to get arrested and not be held and be out on bond, I think it’s atrocious. And it slaps us right back in the face,” she said. “It shows us how the system was not built for us, but it also does not care about us. And we can fight, and yes this is a great step for a change, but I just don’t think it’s enough.

“But I’ll never be satisfied because I know that you can never give Elijah back to his mom or his dad or his community. He doesn’t get to make those impacts that he would have made. He doesn’t get to play his violin to the cats anymore. He doesn’t get to work in massage anymore, healing people,” she continued. “And that beautiful soul is gone, and who knows what he could have done while he was on this earth.”

She and Ms. Bailey said it took so long to get charges because of coverups, corruption and collusions between counties, former Colorado District Attorney Dave Young and the Adams County coroner. She also explained that the only officers who were fired were the ones who posed with a picture that reenacted Elijah’s death, one of them being Jason Rosenblatt.

Last month, Phil Weiser announced that his department is investigating the practices of the city’s police and fire departments.

Other police brutality incidents that happened in Aurora include Kyle Vinson, a 29-year-old Black man who was pistol-whipped and choked by an officer on July 23, and a Aug. 2020 encounter where officers held a Black woman, Brittney Gilliam, and four Black girls ranging from six to 17 at gunpoint and handcuffed them in 100-degree heat.

Getting rid of poisonous police forces

After the charges were announced, the Aurora Police Association released a statement saying the “officers did nothing wrong,” that Elijah died because he violently resisted arrest and had a pre-existing heart condition and that the “hysterical overreaction to this case has severely damaged the police department.”

Ms. Minter called the police union’s response bold and callous.

“They blamed the victim. They said if he hadn’t violently resisted, he’d be here. Saying ‘I don’t do guns, I’m a vegetarian, I don’t eat meat, I wouldn’t kill a fly,’ that doesn’t sound

like a violent resistor to me. When you watch that video, violent resistance is not what you see,” she said.

In a message delivered on July 4, 2020, titled “The Criterion,” the Honorable Minister Louis Farrakhan of the Nation of Islam warned about the evil actions of police unions. “They sure are not bringing in good fruit in their policing efforts. Vicious men and you in the police union, you are the worst ones. You are worse than the killers in blue,” he said. “You sit behind a desk and find a way to absolve them of the guilt that you know they’re guilty of. You are no good at all. So, we’re not going to get rid of bad police and leave a no-good police union in place.”

As calls for police reform have intensified across the country, both Ms. Minter and Ms. Bailey say the institution of policing is broken at its very source, as police were created to be slave catchers.

“Who are they here to protect and serve? You started as a slave catcher. You are here to protect White supremacy and serve White supremacy, therefore you will never equate to anyone that protects and serves me and mine,” Ms. Bailey said.

She described policing as a tree rooted in contaminated soil. “Not only must we chop it at the root, remove the root, but we must do a land evaluation and see what will grow in that soil, what will get rid of the poison of White supremacy. Because until someone comes and assesses the soil, everything that grows in that dirt will be contaminated as well,” she said.

Ms. Minter said in the future, she would like to work with legislators to create a Colorado revised statute for police murder.

“Charge them based on the crimes they committed because things are going to happen in that course of work where they’re going to make split decisions, but

they’ve been trained. We hold them to a higher standard, and we should hold them to a higher standard in the law,” she said.

She said the law would include a sentence of a minimum of 10-15 years for every charge.


“That way it’s consistent across the board, and it would actually serve as a deterrent to these cops when they just recklessly take these Black and Brown bodies for granted and just wipe us off the planet,” she said. “We need something to actually deter that, and I know that two to six years doesn’t tell any other cop, ‘Oh hey, I don’t want to do that. Let me use a taser, or not use a taser 47 times. Let me just use it once. Or how about I use the first contact, the first use of force which is my implied authority and use my ability to talk and to communicate and to de-escalate.’”

Mr. Aleem said justice means police officers being terminated, being indicted and being convicted.

“And real convictions and not little slaps on the wrist or 18 months in jail and then you get out and all of this kind of stuff, but real convictions,” he said.

Nation of Islam Student Minister Herman Muhammad of Denver, Colo., said the atrocities speak to the Honorable Elijah Muhammad and Minister Farrakhan’s words for Black people to separate.

“Separation is the best and only solution to the problems between Black and White,” he said. “And with the Honorable Minister Louis Farrakhan and his divine leadership, we have the solution in the sense that we have a 10,000 Fearless in our communities to stand between the police, now, and other warring parties and really to begin the process of policing ourselves, which is ultimately what we’re going to have to do anyway.”



The growing ‘enormity’ of the Minister’s vision-like experience

In 1977 the Honorable Minister Louis Farrakhan determined that he would, by Allah's help, lift the name and rebuild the work of his teacher, and fifty-five months after he announced that the Honorable Elijah Muhammad was physically alive, Minister Farrakhan had a very unusual experience.

In a little mountain village, in the country of Mexico, during the night of September 17, 1985, he had a vision-like experience that was far more than a vision. He didn't realize that he had this experience until two days later when an earthquake took place.

Then, on the 19th he told his experience to his wife, Mother Khadijah, and to Mother Tynetta Muhammad. His vision-like experience took place between two significant speaking engagements. The first was in Los Angeles, California, where he spoke to about 19,000 people, on September 13, 1985.

Up to that time, it was the largest live gathering ever to hear the teachings of the Honorable Elijah Muhammad in the history of the Nation of Islam, west of the Mississippi River. Minister Farrakhan left Los Angeles and went to Mexico, where he experienced his vision.

The next event was to take place in New York City, October 7th, where he would speak to an audience approaching 50,000 people inside two of the buildings of Madison Square Garden and on the outside. Minister Farrakhan used Phoenix for most of the time he spent in preparation for his speech in Los Angeles. He now returned to Phoenix to prepare for his next speech, which was to come in New York City. Mother Tynetta Muhammad and I were with Minister Farrakhan, on the first day of his preparation for his New York speech.

This discussion took place at a lake called Lake Pleasant, in Phoenix.

Then as we were gathering our books and papers to return to Scottsdale (a city adjoining Phoenix), Minister Farrakhan informed me of his vision-like experience.

I was at the same time both immensely gratified and profoundly moved by it and struck by what seemed to me to be the casual manner in which he told me what he did. I regarded what he told me as momentous, wondrous or spectacular, or even more than that. He did not seem to realize the weight and

significance of what he was telling me.

It was a few days later, while he and I were on a jet, on our way on a route that would take us to New York City, that I asked him to please go over his vision-like experience again with me. I wanted him to put his experience on tape because I wanted his every word of his experience carefully preserved. To me what he experienced was something that would powerfully reverberate around the earth.

As he spoke into the tape recorder, he began to break down. He said he was realizing that something very unusual had happened to him, which he could not explain. Tears began to roll down his cheeks as he spoke to me. It was evident to me that he was experiencing more fully the reality of his vision-like experience, even as he spoke. He said he felt as if he had been inoculated with something and now he was feeling the effects.

To me, his reaction accounted for the way he seemed to me when he first told me of his more than a vision. When he first told me of his experience, he did not seem to recognize the enormity of what he was telling me, which he had experienced. I was

to later learn that this was also the view of Mother Tynetta Muhammad. She told me of her impression of him when he first told her of his vision in her home in Mexico.

Now, on the jet, he was going through a stage in which the fuller dimensions of his astounding experience were dawning upon his mind. After we finally arrived in the hotel, in New York City, we received some very fascinating information from some of his family members, including his wife, Mother Khadijah. During that same night as we were flying from Phoenix to the East Coast, which is a Northeast direction, we learned that sixty “baby” planes were seen moving above the city of Tucson, Arizona.

They were seen traveling on the same Northeast course we had traveled. Another factor making this event so striking was that there was a heavy cloud cover over the city. Therefore, there was no way that these flying objects could be mistaken for 60 moving stars, all going in the same direction.

As we all know, clouds block one's view of the stars. A total cloud cover blocks out all of one's ability to see stars, if you are on the ground. These were not flying objects with which the authorities could cope. These were, according to trained observers, “UFOs,” and they were obviously flying under the clouds. These “UFOs” generated excitement. Later I learned that there were local (in Tucson) radio interviews and several news programs, which were generated by this awesome event. However, it seemed that this startling display of intelligence and power was generally kept from the country as a whole.

We wondered if we were being escorted by the “baby” planes. Remember, there was a lot of evil and loud talk—especially from the Jewish community, and from the very highest government officials of the United States—about Minister Farrakhan. I took these planes to be Allah's way of showing them that the Minister had plenty of backup (support.)

As I continue writing on my journey to Hawaii, I wish to thank my two traveling companions, Sister Callie Muhammad and Dr. Darnita Muhammad, who will share some of their impressions of the journey. There are a few observations I wish to make about the topography of the Island of Maui. The island contains two dormant volcanoes, a plush rainforest of diverse vegetation and flowering fruit trees. There are many organic farming communities and ranches spread throughout the land, interspersed with sacred waterfalls and pools and picturesque seascapes with sandy beaches of finely ground volcanic rock.

It is also a rendezvous place for wind surfers and boatmen and is a spawning place for the great humpback whales and other marine creatures.

There are miles and miles of backpack hiking trails for walking and bicycling and other recreational activity—everything to make a heaven on earth. The traditional philosophy of the native Hawaiians is contained in the word, "Kuleana" or "Responsibility" as stewards of the land which defines the inter-relationships between people and resources, both spiritual and physical, and implies the natural care of the land and all that grows on it. This implies that through generational knowledge and natural cultural resources, the care with appropriate respect and behavior must be practiced by all who enter the Hawaiian chain of islands. Maui has two extant volcanoes, the main one is Haleakala, meaning "House of the Sun," with 12 observatories and telescopes and a state-of-the-art research center in advanced astronomy.

The smaller volcano is named "Haleahina" meaning "House of the Moon." The Hawaiian Islands are a series of volcanoes rising from the ocean floor 20,000 feet below the ocean surface. When looking at a map of the island of Maui, we will note that its shape appears like a baby fetus in the Mother's womb, prostrating in prayer with its head touching

the face of the ground at Makena Bay, with its body stretching toward Hana on the other side of the island.

The following words about Maui were submitted by Sister Callie Muhammad from Columbus, Ohio:

"I would like to thank Mother Tynetta for asking me to be a traveling companion on this journey of healing, I am so grateful. Our journey began in Los Angeles, California, in a meeting with Dr. Jolie Harris, the food prophet, who shared some healing secrets that were magnificent. The next part of our journey was to Maui, Hawaii. The Island of Hawaii is called paradise because it truly is a place of restoration and healing.

"We were a part of a divine ceremony for Mother Tynetta's sister, Karlotta Muhammad. Our healing and restoration began where we were able to touch the great Pacific Ocean which is 68,634,000 square miles and is the deepest ocean in the world.

"We felt the gentle winds blowing through the trees, the warmth of the sun, and the softness of the white beach, all that nature has offered to us. From there the road to Hana, which is 52 miles long, it takes three or four hours to travel the road because you have to cross 59 bridges, 46 of them are one lane and you have 620 winding curves. We now entered a lush tropical rainforest and the healing frequency of the trees, the mist off the ocean, the sound of the winds, the sun, the waterfalls, touched our souls and acquainted us with all the different elements of nature and their different modes of interaction. Our goal was to reach the seven sacred pools.

"The sacred pools in the Hawaiian language are called, "The O'HE O Gulch. As the waterfalls cascade down into the seven pools, it was very healing. We were truly communing with nature. We realized that being in the proper environment had set into motion a true healing from Allah.

"After visiting the seven pools, we needed a place to stay overnight; we were lead to the Aloha Cottages. We met Mrs. NaKamura, who is a third generation Japanese lady, who offered for us to stay at

her cottages that were very nice and clean. Nature continued to amaze us in that special place. On the grounds of her cottages were orange trees, lime trees, banana trees, guava trees, papaya trees and a beautiful view of the ocean. We all slept very well.

"Upon leaving the next morning, she presented us with some of the best bananas that one could eat; we were happy and felt invigorated. We continued our journey down into Haiku, Maui, to the Temple of Peace and Healing Spa where we were received by Rev. Kedar and his wife, Shelly St. John. We were treated with advanced state-of-the-art technology and treatments for healing. After the treatments, we had a good night's sleep in Maui before our departure to Los Angeles.

"Upon our arrival in Los Angeles, our receiving party said, "We looked like pure light," and we felt like pure light. Thank you again, Mother Tynetta Muhammad."

"And those who are faithful to their trusts and their covenant, And those who are upright in their testimonies, And those who keep a guard on their prayer. These are in Gardens, honoured."



Surely one meal a day and eating the right kind of food at that meal will do away with much sickness and add many years to our lives. Try it for yourself.


Do not eat everything you see

The hateful behavior toward Black folks is seen everyday in not only official misconduct, but in everyday behavior by Whites of all ages from school children to experienced political leaders.

Individual, random White people now openly display their hatred. Dylan Roof, whose death penalty conviction for murdering nine Black worshipers in a historic Charleston, S.C., church in 2015 was upheld in federal court Aug. 25, admitted that he plotted the attack for months in order to spark a race war.

Republican Ohio U.S. Senate candidate J.D. Vance discarded all pretense of civility when he suggested that he has an advantage in the race because “our people hate the right people.” Mr. Vance, the author of “Hillbilly Elegy,” made the comment during an interview with “The American Conservative” magazine in late July.

There may be a scientific explanation of the behavior of White folks. In 1970 in her book “The Cress Theory of Color Confrontation,” psychiatrist Frances Cress Welsing says that White people fear “genetic annihilation” (some now call it “replacement”) by non-Whites, and that drives their conduct.

“Whites are afflicted with the genetic recessive and deficiency condition of skin albinism,” Dr. Welsing writes. “Because they are genetic recessive to all people of color, they feel themselves to be inferior to people and

vulnerable to genetic annihilation.”

That means that White traits such as blue eyes, blond hair, and fair skin color, all recede to brown eyes, darker hair and darker skin color when Whites mate with non-Whites. This, Dr. Welsing insists, is what Whites fear, and what drives their need to “control and destroy people of color.”

“In the collective White psyche, Black males represent the greatest threat to White genetic survival because only males can impose sexual intercourse, and Black males have the greatest genetic potential to cause White genetic annihilation,” says Dr. Welsing.

The election of Donald J. Trump, the son of a man arrested after a 1927 Queens, New York Ku Klux Klan rally, exposed the tide of race hatred which had been mostly politely disguised until Mr. Trump’s racial “dog whistle” campaigns turned to open sirens.

Recently, in Salinas, California, White children collectively behaved as badly as adults. A student there said she’s heard racial slurs since elementary school. Now, as a freshman, she fears walking down the hallways of Alisal High School, she told USA Today.

Parents, students, educators, and community members attended the Salinas Union High School District (SUHSD) board meeting Aug. 24 to voice their concern regarding a group of students who allegedly defaced a Black doll during a school jamboree event.

The school children created an Instagram account for the doll that the students had named “Shaniqua.” Photos show markings on the doll that appear to be an ankle monitor bracelet drawn around the doll’s ankle and scribble

marks on the face. In a video posted on TikTok, several students are seen stomping on the doll.

“I don’t want this to be minimized as just a joke or silly kids,” said Jordana Henry, a parent, teacher, and leader in the school’s Black Girl Magic Club, according to the newspaper. “This is White supremacy.”

The education arena has become a battleground in the racial “cold war”—that is a war with no shooting. The battleground is over what is called “critical race theory,” a body of legal scholarship and an academic movement among civil-rights scholars and activists who seek to critically examine race and law and to challenge mainstream American liberal approaches to racial justice.

More than 25 Republican-led states have passed or proposed restrictions on how teachers can discuss racism and sexism in a movement that started under Mr. Trump after The New York Times Magazine published its “1619 Project” in 2019.

“America is losing friendship throughout the world,” the Honorable Minister Louis Farrakhan advised in The Final Call newspaper Aug. 24. “The Government of America is losing control of the country’s institutions and losing power of her own mind,” the Minister stated.

“America is losing control of her world. In desperation, she feels that her guns, rockets, bombs and technology will keep her kingdom in power. However, more powerful kingdoms than America had to lay their burden down when the time came and America is no different. Neither her bombs, guns or technology will sustain this country. Time is declaring


that America had better change or the end is upon her,” the Muslim leader continued.

“America’s loss of control is a sign of the decline of her world. This fall can be checked, if America would believe in the warnings given by the Honorable Elijah Muhammad, coming through me, warnings that I am not saying of anything that is not written in the Bible that we should expect in this time,” said Minister Farrakhan.


Another theory nervous Whites are arguing is that non-Whites are out to “replace” them, genetically. Pennsylvania Republican Rep. Scott Perry used a House Foreign Affairs Committee meeting in April to spread the theory that “native-born” (read: White) Americans are being purposely replaced by immigrants as a way to alter the culture of the country. “For many Americans, what seems to be happening or what they believe right now is happening is what appears to them is we’re replacing national-born American—native-born Americans to permanently transform the landscape of this very nation,” said Mr. Perry in reference to the number of people trying to enter the country at the United States’ southern border.

Again, there is a simple academic discussion of this subject: Read Dr. Frances Cress Welsing, “Cress Theory of Color Confrontation,” and/or “The Isis Papers: The Keys to the Colors” for that academic conversation. Read “Message to the Blackman in America,” by the Honorable Elijah Muhammad for a plain language discussion.



Loss of freedom and an erosion of civil liberties

As America remembers the loss of life on 9/11, many have forgotten that the country responded with mass surveillance, indefinite detention at Guantanamo Bay, religious discrimination, governmental policies of torture, and targeted drone killings.

"The greatest infringement on civil liberties is Americans' right to privacy," Dr. Wilmer Leon, author and syndicated columnist, told The Final Call. "America has developed into a surveillance state, whether it's through closed circuit television, whether it is through the monitoring of telephone conversations, or spying on Americans by the intelligence apparatus in this country. It's the Fourth Amendment that says people have the right to be protected from unreasonable searches and seizures," he said.

"It is very, very serious. It is very detrimental. It is something that a lot of people don't pay attention to. People have no idea that this continues to happen."

Soon after 9/11 a scared Congress rushed through the Patriot Act.

It increases the government's surveillance powers in four areas:

1. Records searches. It expands the government's ability to look at records on an individual's activity being held by a third parties. (Section 215)

2. Secret searches. It expands the government's ability to search private property without notice to the owner. (Section 213)

3. Intelligence searches. It expands a narrow exception to the Fourth Amendment that had been created for the collection of foreign intelligence information (Section 218).

4. "Trap and trace" searches. It expands another Fourth Amendment exception for spying that collects "addressing" information about the origin and destination of communications, as opposed to the content (Section 214).

It gave unbeknown power to the government. "When you look at the history, the motivations behind creating the country in the first place, in terms of breaking from England and uniting the 13 colonies into a country, it was because, according to the Declaration of Independence, the overreach by the king," said Dr. Leon. "We have now been convinced through this trope of national security and terrorism that we have to relinquish our personal liberties in order for us to be safe. This phrase is attributed to Benjamin Franklin, 'Those who will sacrifice liberty for security deserve neither.'"

Terry Albury is a perfect example of the Patriot Act gone very wrong. He was so disillusioned by what he was forced to do as an FBI agent in the so-called war on terror that he was willing to leak government documents to the press and go to jail when he was caught.

The reporter in his case was not named, however the dates in his plea agreement coincide with a series of articles published by The Intercept that detail how the FBI surveils both informants and suspected terrorists.

Day in and day out Mr. Albury confronted Muslims and terrorized them under the guise of surveillance. He would knock on their doors requesting to interview them and follow and harass them.

According to a sentencing memo filed by Mr. Albury's attorneys, "This was an every-day encounter for Mr. Albury. He comported himself in this setting as a model FBI agent. But the conflict and depression generated by these routine but soul-destroying events took its toll."

When it got to be too much for Mr. Albury he sent at least 25 documents, 16 of which were classified according to court documents, to the press.

"I did it because it got to a point where the reality of what I was a part of hit me in a way that just shattered my existence," he said. "There is this mythology surrounding the war on terrorism, and the F.B.I., that has given agents the power to ruin the lives of completely innocent people based solely on what part of the world they came from, or what religion they practice, or the color of their skin. And I did that," he adds. "I helped destroy people. For 17 years."

"I apologize to everyone I have hurt as a result of my actions, especially my family, my co-workers in California and Minneapolis, and my colleagues in the law enforcement community," Mr. Albury wrote in a letter to the court. He was sentenced to 48 months in prison in 2018.

"These documents confirmed what American communities—primarily Muslims and communities of color—and rights groups had long known or thought to be true," explained Hina Shamsi, director of the National Security Project at the American Civil Liberties Union, to the media.

"For years we've been hearing from people who were surveilled or investigated, or watched listed with no apparent basis for the F.B.I. to suspect wrongdoing but based primarily on their race or religion or political organizing and beliefs. And here's someone who was trying to do the right things from inside government and ended up either participating or being a witness or adjacent to a range of abuses that defined, and continue to define, the post-9/11 era. What are you supposed to do as a person of conscience when you see what your country is doing?"

Twenty years after the first detainees arrived

at Guantanamo Bay Detention Center in Cuba, the United States is still holding 40 detainees, indefinitely, most without charge and none having received a fair trial.

"After 9/11 happened, I was kidnapped from Mauritania to Jordan, from there to Afghanistan and from there to Guantanamo Bay where I was tortured," Mohamedou Ould Slahi told the virtual audience at the Rights or Rightlessness Event, January 11, to commemorate the 20th Anniversary of the first detainees arriving at Guantanamo Bay.

"I stayed there for 15 years and was released in 2016. I was never convicted or charged with any crimes," he said. "Muslim dictators rounded up so many young men just because of suspicion. I understand suspicion but I don't understand kidnap and torture. The U.S. twisted the arms of the leaders of so many countries, but we expected better from the U.S."

Amnesty International released a new report January 11, that highlighted historic and continuing human rights violations at the Guantánamo Bay.

"This is about more than just the 40 people still held at Guantánamo—it is also about the crimes under international law committed over the past 19 years and the continuing lack of accountability for them. It is about the future, too, as we move towards the 20th anniversary of the 9/11 attacks and strive for enduring justice," said Daphne Eviatar, director of the Security with Human Rights Program at Amnesty International USA.

The report documents a catalogue of human rights violations perpetrated against those detained at the camp, where victims of torture

are held with inadequate medical care indefinitely and in the absence of fair trials. Transfers out of the facility have stalled, and even those cleared for release have remained incarcerated for years on end.

Religious persecution became a hallmark of the war on terror after 9/11. The war on terror became the war on Islam.

"There was a heightened surveillance. The government started sending agents into masjids to see what they were up to. For the immigrant communities, the South Asians, African Americans, Chinese Americans, Muslims come from so many places they were not surveilled in the same way. I think that they were just coming into view as Muslims," Dr. Aminah Al Deen, chair of the Islamic Studies Department Emeritus at DePaul University, told The Final Call.

"When African American women, especially, started trying to look like Arab American women who are Muslim, they came under the same kind of surveillance and it was a cyber surveillance, just seeing who went to which masjid. Who was coming in and out of their houses, which houses they were coming in and out of," she added.

"We definitely were not protected. You're talking about a huge community of people from over 87 countries. Some were here undocumented; they were more at risk and many of them were deported. It was an interesting phenomenon, for Bangladeshis and some South Asians, they didn't deport the wives and children, but they deported the men."

El-Hajj Mauri' Saalakhan is president of the Aafia Foundation. He told The Final Call, "The list is long of cases of young and old but primarily young Muslims who were preemptively prosecuted by the fear of the American government."

Mohammed Hossain, a respected member of his community, was targeted in a fictional FBI sting in 2004. He was convicted of material support for terrorism in 2006 and sentenced to 15 years. He was subjected to "preemptive prosecution," which is a law enforcement strategy to target and prosecute individuals or organizations whose beliefs, ideology or religious affiliations raise security concerns for the government. Just in case the targets might become terrorists, the government concocts a sting. He was finally released in 2020 and returned to his community.

In another case the Liberty City 7, poor men from a Black neighborhood in Miami, were arrested by the FBI in June 2006 on charges of attempting to wage war on America. Then Attorney General Alberto Gonzales claimed they were plotting to blow up Chicago's Sears Tower, to launch a "full ground war against the United States," and to support al-Qaeda.

The men, members of an unknown religious group called the Seas of David, had no actual connection to al-Qaeda, no weapons,

no explosives, no reconnaissance on the Sears Tower, no consistent ideology of violence.

The little if any evidence against them was based on a dialogue encouraged by a paid informant in a grand scheme of make believe. Their story became the making of a film directed by Dan Reed.

"These are all poor Black men," said Mr. Reed in an article published in The Guardian. "Had they not been from that background, had they been well-off white kids, none of this would've happened probably, because the circumstances would've been totally different," the outlet reported.

In 2004, Abu Ghraib was the worst example of U.S. secret military torture facilities around the world. The administration of then-president George W. Bush justified torture as necessary during the war on terror. Abu Ghraib housed several thousand prisoners, including women, teenagers, civilians, many of whom had been picked up in random military sweeps and at highway checkpoints.

They fell into three loosely defined categories: common criminals; security detainees suspected of "crimes against the coalition"; and a small number of suspected "high-value" leaders of the insurgency against the coalition forces.

It would have continued until pictures of the degrading, dehumanizing actions by the soldiers leaked out and numerous charges were filed against the leadership and it was shut down.

The Middle East Times summed up what Arab papers around the world said about the Abu Ghraib and Guantanamo situations; London based, Palestinian owned daily Al Quds Al Arabi on Abu Ghraib:

"President Saddam never presented himself as a leader of the free Western world and messenger of democracy for the Arabs and Third World, like President George W. Bush who invaded and occupied Iraq, killed 100,000 of its people under the pretext of spreading the culture of human rights and democratic freedoms.

"U.S. official justifications that these violations were carried out by a small number of soldiers was totally unacceptable because these troops represent the American government and because 'it doesn't need 150,000 troops to torture prisoners.'"

"Since 9/11, Muslims in America have been the victims of FBI watching Muslims, arresting

Muslims, breaking into Muslim homes. Muslims have suffered in the airports; being stopped because of their names. Searched once, searched twice; and sometimes even if they spoke Arabic, something would come up that might even deny them a flight," Nation of Islam Minister Louis Farrakhan noted in a 2010 interview with Al-Jazeera's Abderrahim Foukara.

"Since 9/11, the way the government has acted toward Muslims, many Islamic scholars who would come to the United States to lecture, have found it difficult. And some, even now, do not wish to come because of what they have to go through to enter the United States. So the climate is getting increasingly more difficult," the Minister stated.

Drone strikes used to target ISIS and other targets were used as late as August 27 in Kabul ahead of the U.S. withdrawal from Afghanistan after two decades. The strike killed 10 civilians, including seven children of a family looking forward to evacuating to America. Capt. Bill Urban, spokesman for U.S. Central Command, said that the U.S. was "aware of reports of civilian casualties."

The government's increasing erosion of civil liberties over the past 20 years can be seen in many ways. Luci Murphy is a D.C. community activist. "After 9/11 people were so afraid about significant buildings being attacked that they closed the streets around the White House. We were used to being able to go to the White House to demonstrate," she told The Final Call.

"Now there are barricades on Pennsylvania avenue, the White House side is closed to all vehicular traffic and sometimes to foot traffic. Lafayette park, which is close to the White House, across the street where a lot of people also demonstrate too is often fenced off and people are kicked out."

It's not just the barricades and lack of access

to facilities that concerns Ms. Murphy.

"We had a celebration for Leonard Peltier, who is a Native American and has been falsely convicted of killing some FBI agents. Even though there's evidence to show that he was not involved he's been incarcerated almost 50 years now. Our celebration, a few days before 9/11, was to raise money for his defense," she said.

"Since then, the proprietor of the cafe where we held the fundraising cannot get a permit to carry a legal firearm because he offered his space to raise funds for Leonard Peltier. He was visited by the FBI. The proprietor of Brooklyn's Cup of Dreams is a very law-abiding citizen but because of the support he gave to one of our political prisoners cannot get a firearm."

Retired U.S. Marshal Matthew Fogg sees a contradiction in the way America has handled the whole war on terror that has led to a massive erosion in civil liberties. "We promote terrorism on our soil and through our citizens, when we talk about racism. African Americans right up until today continue to face racism. We go to other countries and fight terrorist activity on their fronts while in America we have terrorists when we talk about hate crimes, race crimes and hatred that we've been dealing with for years," he said. "When it comes down to fairness, equality, we're finding a lot of those things changing. What are your civil liberties? What are your rights? It's always that question that comes down to somebody has to make a determination on it. That person does not look like you. That person in Congress or the Senate tends to be White. They don't have to deal with the same issues. They don't see it as a problem where we, people of color, live it and understand it."

against America. The first nations targeted were Afghanistan and Iraq.

"The Taliban just wanted proof," recalled Abdul Akbar Muhammad, International Representative of the Nation of Islam. "And America went after Afghanistan and began to dismantle it as a nation," he said. The war in Afghanistan was underway by October 2001 and, two decades later, on Aug. 31 a defeated America left the country using a resurgent Taliban to help guarantee her safe exit.

Kevin Barrett, of Veterans Today and an author, believes none of the war on terror hype and calls 9/11 a "false flag" operation that triggered years of adverse events and war in Afghanistan and Iraq. A false flag is a covert operation designed to deceive and create the appearance of a particular party, group, or nation being responsible for some activity while disguising the actual source of the action.

"Of course, it was a false pretext," he said, "the whole story of anti-terrorism is a big lie." "It's very interesting and ironic that the liberation of Afghanistan happened almost simultaneous with the 20th anniversary of 9/11," he added.

He said fighting terrorists and going after those the Bush administration deemed responsible for 9/11 put a noble face on a bold lie. The true reasons for invading Afghanistan were planned in July 2001, months before 9/11, and the goals were to protect heroin profits, secure oil pipelines, and establish U.S. military bases, he said.

Mr. Barrett referred back to America's sordid past in Afghanistan during the 1980s when the CIA backed and trained Osama Bin Laden and the mujahideen, Muslim warriors engaged in an armed struggle to drive the Soviet Union out of the country.

The Soviets were initially invited to Afghanistan by the socialist government of Afghan leader Mohammad Najibullah. These were the years of the Cold War between America and the Soviet Union. The U.S. military operation to oust the Soviets was initiated by Zbigniew Brzezinski, national security advisor to President Jimmy Carter.

In the nine-year conflict, an estimated one million civilians were killed as well as 90,000 mujahideen fighters, 18,000 Afghan troops, and 14,500 Soviet soldiers. The Soviets withdrew leading to a long civil war won by the Taliban in 1996.

Outside of that history, there are questions about intelligence failures by the FBI prior to 9/11 and failures of American officials to act. Coleen Rowley, an FBI agent in Minnesota, was chosen as a Time magazine person of the year in 2002.

"Coleen Rowley is the FBI staff attorney who caused a sensation in May with a memo to FBI Director Robert Mueller about how the bureau brushed off pleas from her Minneapolis, Minn., field office that Zacarias Moussaoui, who is now indicted as a Sept. 11 co-conspirator, was a man who must be investigated," said Time. Other questions surfaced about how U.S. intelligence agencies missed tips about foreigners trying to learn to fly planes paying large amounts in cash for classes but uninterested in learning to land and other acts. Later disclosures, including a 2015 Politico piece by researcher and writer Chris Whipple, revealed how pre-attack warnings given to President Bush and the White House officials went unheeded.

"'Bin Laden Determined to Strike in U.S.' The CIA's famous Presidential Daily Brief, presented to George W. Bush on August 6, 2001, has always been Exhibit A in the case that his administration shrugged off warnings of an Al Qaeda attack. But months earlier, starting in the spring of 2001, the CIA repeatedly and urgently began to warn the White House that an attack was coming," wrote Mr. Whipple.

"By May of 2001, says Cofer Black, then chief of the CIA's counterterrorism center, 'it was very evident that we were going to be struck, we were gonna be struck hard and lots of Americans were going to die.' 'There were real plots being manifested,' Cofer's former boss, George Tenet (onetime CIA director), told me in his first interview in eight years. 'The world felt like it was on

the edge of eruption.'

Persistent angry questions about what happened and different connections, especially any links to U.S. ally Saudi Arabia, were so strong that President Biden was disinherited from 2021 commemorations by family members who lost loved ones seeking answers and demanding more secret information be declassified. Mr. Biden, days before the 20-year anniversary, directed that some additional information be made public and was invited back to take part in commemorations. Mr. Biden made the announcement Sept. 3.

Min. Akbar Muhammad said it's also important to understand the spiritual context 9/11 sprang from, the subsequent events, and that it occurred during the prophesied time of America's decline and fall as a power. He referenced the warnings and guidance to America and world nations by the Most Honorable Elijah Muhammad, the Eternal Leader of the Nation of Islam, and his student and National Representative, the Honorable Minister Louis Farrakhan.

"It's all signs," said Min. Akbar Muhammad, referring to America's "unravelling, both domestically and internationally." "When you get a sign and are heedless to that warning, you pay a price," he said.

"You will be foolish not to see the hand of the Almighty in what is happening to the world and America in particular," explained Minister Akbar Muhammad.

The 9/11 remembrance comes while America is beset with manifest loss from a Covid-19 pestilence, weather calamities,

and military defeat. Abdul Akbar Muhammad said people should consult the scriptures of Bible and Holy Qur'an to understand why America is losing.

Elijah Muhammad in his pivotal book "The Fall of America" wrote that the United States would reap what she has sown on the world stage. "She is destined to never win a war again. America is losing control of her world. In desperation, she feels that her guns, rockets, bombs, and technology will keep her kingdom in power," he warned.

"However, more powerful kingdoms than America had to lay their burden down when the time came, and America is no different. Time is declaring that America had better change or the end is upon her. Furthermore, as past empires had to pay for the injustices in their history, America is now in the throes of judgement."

"America's knees are bowing due to her corrupt domestic and foreign policies," said Minister Farrakhan in Part 13 of a 2013 lecture series called "The Time and What Must Be Done."

Minister Farrakhan compared America's predicament to that of Pharaoh in the scriptures, finally bowing down when the last plague struck Egypt. "So will America bow down," he said. At the outset of the Afghan War, Min. Farrakhan warned the president that America would not win and could unite the Muslim World against her and move closer to a final cataclysmic

battle that would destroy her.

The aftermath of 9/11 changed global politics and the faith of 1.6 billion Muslims was attacked and blamed for a horrible killing.

Civil liberties were stripped from American citizens carrying such names as Abdul, Karriem, Ayesha or Muhammad. Anti-Arab xenophobia and blatant Islamophobia were rampant. Being Muslim, Middle Eastern led to being profiled as an enemy with “enemy combatants” arrested, disappeared, or held without charge at Guantanamo Bay detention camp in Cuba or CIA black sites scattered around the world. At Guantanamo Bay two decades later, 39 detainees remain, 27 held as law-of-war detainees without a charge or trial, according to the New York Times.

Mr. Saalakhan is an activist against wrongful detention cases such as Dr. Aafia Siddiqui, a Pakistani neuroscientist jailed on charges related to attempted murder and assault of U.S. officers in Afghanistan in 2008. America, he said, had legislation that was accelerated in the climate of 9/11.

“The process was already begun before 9/11,” said Mr. Saalakhan. “What 9/11 did was basically open the floodgates and justified what was already in the works.”

In the tradition of Communist witch hunts and illegal surveillance of individuals and organizations during the Black liberation struggles of 1960s-1970s America, the Patriot Act was enacted. The act allowed the federal government expanded authority to track and intercept communications for law enforcement and foreign intelligence gathering.

“All of this was to unveil a new Coin-telpro ... that was in the open and on steroids,” Mr. Saalakhan said. He was referring to the FBI’s infamous Counter-intelligence Program aimed at Black and groups calling for change in American society.

While the entire U.S. was affected by these policies, the Muslim community was disproportionately affected, he said. For the military industrial complex, Muslims replaced Communists as the new bogeyman after the fall of the Soviet Union in 1989. 9/11 was used to connect the fear to Islam with a “war on terror” that was really a “war on Islam,” said activists and advocates.

Washington’s war on terror also became a cover for American plans to remake the Middle East in five years. The countries to be overthrown were Iraq, Syria, Lebanon, Libya, Somalia, Sudan and Iran.

The war in Afghanistan shifted to an illegal war on Iraq, only with an added

façade—to root out weapons of mass destruction. History debunked the lie, but not before the U.S. overthrew the government, executed Saddam Hussein, and spilled Iraqi blood.

With 9/11 the U.S. government played the American people through manipulation of their emotions to justify endless war driven by a multi-billion-dollar military industrial complex, not justice for thousands of citizens killed in a heinous act.

The government became too invasive and ratcheted up public fear, said Barry Landendorf of Veterans for Peace. It used constant streams of high alerts through color coded daily reminders of the next imminent threat, he said.

“A lot of the information was coming from prisoners at Guantanamo who were being tortured, who would just say anything not to be tortured,” Mr. Landendorf added. “And they (U.S. officials) would use that information as public propaganda,” he said.

Since 9/11, America paid a hefty price in deaths and treasure and the blood of many worldwide is on her hands. If America remains on the same course, the worse is yet to come.

An annual report released by the Costs of War project at Brown University, the

leading watch group on the toll of war, tells the story. In 20 years of post-9/11 wars in Afghanistan, Iraq, Syria, Yemen, Somalia, and Pakistan, America spent an estimated \$8 trillion and killed more than 929,000 people.

The Afghanistan/Pakistan war zone costs were \$2.3 trillion; Iraq/Syria war zone costs \$2.1 trillion; and \$355 billion in other wars including Libya, Somalia, and elsewhere. These staggering figures were spent based on lies.

“Eight trillion dollars dedicated to the murder of Muslims, and I see no better way to make this sound any better or different,” said Dr. Maha Hilal of Justice for Muslims Collective during a Sept. 1 virtual forum.

She added the true loss was of humanity, citing 2013 congressional testimony by a 13-year-old boy from Pakistan named Zabir whose family was targeted by U.S. drones. He told lawmakers: “I no longer love blue skies. In fact, I now prefer gray skies. The drones do not fly when the skies are gray.”

“This is the cost of war,” stated Dr. Hilal. “That a young boy can never see the sky the same as people who were never bombarded with violence can.”

Catherine Lutz, co-director of Costs of War and a professor of international

and public affairs at Brown University, noted the so-called war on terror has been “long and complex,” “horrific and unsuccessful” but continues in over 80 countries.

Researchers said though the total number of direct deaths caused by wars in Iraq and Afghanistan are less than both World Wars and the Vietnam War, the post-9/11 conflicts are different because of the long-term damage done to societies that suffered years of constant bombings, death, and destruction.

“The twenty-first century was supposed to be the century of America,” said Ajamu Baraka, national organizer with the Black Alliance for Peace. That fantasy was ruined by America, “fueled by colonialist hubris” and belief she could fight two major wars simultaneously in Afghanistan and Iraq.

“What they ended up doing was not only losing those wars, but exposing the U.S. ... as a paper tiger,” said Mr. Baraka. “So instead of the 21st century being the century of U.S. power, it will be the century of U.S. decline, and what we’re seeing is, in just 20 years, the precipitous decline of the U.S.,” said Mr. Baraka. “That to me is what signifies the 20-year anniversary of 9/11.”

THE MUSLIM PROGRAM

What The Muslims Want

This is the question asked most frequently by both the Whites and the Blacks. The answers to this question I shall state as simply as possible.

1. We want freedom. We want a full and complete freedom.

2. We want justice. Equal justice under the law. We want justice applied equally to all, regardless of creed or class or color.

3. We want equality of opportunity. We want equal membership in society with the best in civilized society.

4. We want our people in America whose parents or grandparents were descendants from slaves, to be allowed to establish a separate state or territory of their own—either on this continent or elsewhere. We believe that our former slave masters are obligated to provide such land and that the area must be fertile and mineral rich. We believe that our former slave masters are obligated to maintain and supply our needs in this separate territory for the next 20 to 25 years—until we are able to produce and supply our own needs.

Since we cannot get along with them in peace and equality, after giving them 400 years of our sweat and blood and receiving in return some of the worst treatment human beings have ever experienced, we believe our contributions to this land and the suffering forced upon us by White America, justifies our demand for complete separation in a state or territory of our own.

5. We want freedom for all Believers of Islam now held in federal prisons. We want freedom for all Black men and women now under death sentence in innumerable prisons in the North as well as the South.

We want every Black man and woman to have the freedom to accept or reject being separated from the slave master's children and establish a land of their own.

We know that the above plan for the solution of the Black and White conflict is the best and only answer to the problem between two people.

6. We want an immediate end to the police brutality and mob attacks against the so-called Negro throughout the United States.

We believe that the Federal government should intercede to see that Black men and women tried in White courts receive justice in accordance with the laws of the land—or allow us to build a new nation for ourselves, dedicated to justice, freedom and liberty.

7. As long as we are not allowed to establish a state or territory of our own, we demand not only equal justice under the laws of the United States, but equal employment opportunities—NOW!

We do not believe that after 400 years of free or nearly free labor, sweat and blood, which has helped America become rich and powerful, that so many thousands of Black people should have to subsist on relief, charity or live in poor houses.

8. We want the government of the United States to exempt our people from ALL taxation as long as we are deprived of equal justice under the laws of the land.

9. We want equal education—but separate schools up to 16 for boys and 18 for girls on the condition that the girls be sent to women's colleges and universities. We want all Black children educated, taught and trained by their own teachers.

Under such schooling system we believe we will make a better nation of people. The United States government should provide, free, all necessary textbooks and equipment,

schools and college buildings. The Muslim teachers shall be left free to teach and train their people in the way of righteousness, decency and self-respect.

10. We believe that intermarriage or race mixing should be prohibited. We want the religion of Islam taught without hindrance or suppression.

These are some of the things that we, the Muslims, want for our people in North America.

What The Muslims Believe

1. WE BELIEVE in the One God Whose proper Name is Allah.

2. WE BELIEVE in the Holy Qur'an and in the Scriptures of all the Prophets of God.

3. WE BELIEVE in the truth of the Bible, but we believe that it has been tampered with and must be reinterpreted so that mankind will not be snared by the falsehoods that have been added to it.

4. WE BELIEVE in Allah's Prophets and the Scriptures they brought to the people.

5. WE BELIEVE in the resurrection of the dead—not in physical resurrection—but in mental resurrection. We believe that the so-called Negroes are most in need of mental resurrection, therefore, they will be resurrected first.

Furthermore, we believe we are the people of God's choice, as it has been written, that God would choose the rejected and the despised. We can find no other persons fitting this description in these last days more than the so-called Negroes in America. We believe in the resurrection of the righteous.

6. WE BELIEVE in the judgment; we believe this first judgment will take place as God revealed, in America.

7. WE BELIEVE this is the time in history for the

separation of the so-called Negroes and the so-called White Americans. We believe the Black man should be freed in name as well as in fact. By this we mean that he should be freed from the names imposed upon him by his former slave masters. Names which identified him as being the slave master's slave. We believe that if we are free indeed, we should go in our own people's names—the Black peoples of the Earth.

8. WE BELIEVE in justice for all, whether in God or not; we believe as others, that we are due equal justice as human beings. We believe in equality—as a nation—of equals. We do not believe that we are equal with our slave masters in the status of "freed slaves."

We recognize and respect American citizens as independent peoples and we respect their laws which govern this nation.

9. WE BELIEVE that the offer of integration is hypocritical and is made by those who are trying to deceive the Black peoples into believing that their 400-year-old open enemies of freedom, justice and equality are, all of a sudden, their "friends." Furthermore, we believe that such deception is intended to prevent Black people from realizing that the time in history has arrived for the separation from the Whites of this nation.

If the White people are truthful about their professed friendship toward the so-called Negro, they can prove it by dividing up America with their slaves.

We do not believe that America will ever be able to furnish enough jobs for her own millions of unemployed, in addition to jobs for the 20,000,000 Black people as well.

10. WE BELIEVE that we who declare ourselves to be righteous Muslims, should not participate in wars which take the lives of humans. We do not believe this nation should force us to take part in such wars, for we have nothing to gain from it unless America agrees to give us the necessary territory wherein we may have something to fight for.


11. WE BELIEVE our women should be respected and protected as the women of other nationalities are respected and protected.

12. WE BELIEVE that Allah (God) appeared in the Person of Master W. Fard Muhammad, July, 1930; the long-awaited "Messiah" of the Christians and the "Mahdi" of the Muslims.

We believe further and lastly that Allah is God and besides HIM there is no God and He will bring about a universal government of peace wherein we all can live in peace together.
