Terms of the Purchase and Sale of this Dalmatian:

We, the above-named Buyer and Seller, do hereby agree to the purchase and sale of the above described AKC Dalmatian for the purpose of a pet quality companion dog. This Dalmatian has been bred to enhance the type and quality of the breed. It is the product of appropriate and responsible breeding, handling, rearing, neurological stimulation, socialization, temperament testing, and veterinarian services. All sales are considered final on the date of this contract. No refund of the purchase price shall be made thereafter except as noted below.

Seller's Obligation's:

This puppy is being sold as a companion and family pet. It may never be used for breeding and must be neutered/spayed. If breeding takes place in violation of this contract, no offspring of this dog may be registered with AKC.

As of the date of purchase the puppy is guaranteed to be in good health and free of communicable diseases. Immunizations are current, a veterinarian record, a 3- generation pedigree, and a copy of the Brainstem auditory evoked response (BAER) results will be provided to the Buyer.

All pet puppies will be sold with AKC Limited Registration papers. A dog registered with a limited registration may be shown in all AKC performance events. The Breeder will offer mentorship if the Buyer would like to pursue such sports.

The Seller will be available for advice in all matters concerning this Dalmatian throughout its lifespan.

Buyer's Obligations:

The Buyer agrees to take the puppy to a licensed veterinarian of their choice for their second set of shots, and a complete health examination. Should the dog be determined to be in ill health, the puppy shall be returned to the Seller, with a signed explanatory statement by the veterinarian. The full purchase price will be refunded.

The Buyer agrees to use pawTree products for the first year or two in order to validate the Health Guarantee. This is a highly digestible food. The Buyer is advised NOT to free feed – this food is much richer than Pro Plan and will cause the puppy to have diarrhea. Ordering Gastro Pro Plus will ensure there's no "stress diarrhea". The Buyer must confirm they have purchased the appropriate food and supplements before picking up.

The Buyer is advised to take the puppy to at least one set of obedience classes taught with positive reinforcement training methods.

Buyer agrees to inform the Seller of any significant health or temperament problems during the lifespan of this Dalmatian. Buyer will be solely responsible for any legal actions arising from this

Dalmatian's actions and agrees to hold the Seller completely harmless in the event of any claim, lawsuit, or legal action arising from the actions of this Dalmatian.

Testosterone and estrogen, produced by the sex organs (testes in males and ovaries in females), are absolutely essential to the closure of the growth plates in dogs. Your dog needs the benefit of these hormones to develop strong bones and good joints. It can take as long as seventeen months for canine growth plates to close. This Dalmatian should not be neutered or spayed earlier than the above designated time frame to lessen the chance of this Dalmatian blocking due to urinary crystals due to an immature urinary tract.

Buyer agrees to promote the maintenance of this Dalmatian's health and well-being by providing regular veterinary care, vaccinations as required by law and recommended by the Buyer's veterinarian, pawTree diet, hydration and exercise to promote good health, proper continued growth, and development and lifelong prevention of urinary urate stone formation.

The Buyer agrees that this Dalmatian is a house dog and will not be chained or tethered outside for an unnecessary amount of time. It should never be allowed to run free off the owner's property or beyond the owner's control. It should also not be crated for long periods of time without an opportunity to relieve itself.

The Buyer agrees that this Dalmatian shall NEVER be abandoned to an animal shelter, used as a guard dog or attack protection trained. This is for safety reasons. The Breeder will for the lifetime of the dog, regardless of the reason or circumstances, take back or help to re-home the dog if the Buyer is no longer able to care for them. There will be no refunds of monies or additional charges.

Buyer agrees that neither the Buyer nor the Buyer's estate/executors may sell this Dalmatian or transfer ownership of this Dalmatian. If the Buyer, or their estate can no longer maintain this Dalmatian for any reason it must be returned to the Breeder unless the Buyer otherwise approves in writing of an alternative placement.

In the event of any violation of this contract the Breeder has the option to take this Dalmatian back with no refund to the Buyer. The Buyer agrees that the Breeder may repossess this Dalmatian upon evidence of neglect and/or abuse at no expense to the Breeder and no refund of any monies will be made to the Buyer under these circumstances.

Buyer and Seller agree to notify each other of any change of address and/or contact information throughout this Dalmatian's lifespan.

By affixing their signatures below, Seller and Buyer attest that they have read, understood and agreed to all terms of this contract and that it is a legally binding contract. Buyer and Seller agree to submit to the jurisdiction of any state or federal court in the state of Virginia, if any action arising out of or relating to this contract.
