- No Force dryers are allowed in grooming area only stand and handheld dryers.
- In order for Cluster to do our best in maintaining social distancing in the grooming building, we are asking that you stack your crates and please do not use the building for socializing.
- We ask that you please practice social distancing in all buildings and do not congregate in buildings.
- There is no ringside seating, however, exhibitors can bring their chairs but must maintain social distancing between each other and from the ring.
- When approaching the rings for showing, only the steward will have access to the ringside catalog and armbands and will look up your number, if necessary, and give you your armband. To facilitate this process, please know your armband number(s).
- · Stewards and judges will wear mask and judges will have sanitizer available between each exam.

Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.

Section 2 – Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule. if offered.
- AKC registration number or an AKC litter number will be required for all entries.
- · A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may not personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition. Dogs that are owned or co-owned by the forenamed may compete in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four- to - Six Month (Beginner Puppy) Competition.

Entries will close Wednesday Noon, April 28, 2021 at Superintendent's office.

NATIONAL OWNER-HANDLED SERIES THURSDAY, FRIDAY, SATURDAY & SUNDAY

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not exhibited in the National Owner-Handled Series by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

- If heart disease is noted that requires follow-up/treatment, the dog will be referred to its local cardiologist.
- The 15-minute time slots are needed to give time for imaging and data entry— if more than 5 minutes late, we will not be able to perform the echocardiogram at that time. If time allows during the day, the echocardiogram may be worked in later, but this cannot be guaranteed.


"How fast can my dog run?" Many owners have found themselves wondering that at one time or another. Well, the American Kennel Club has devised an exciting sport to help answer that question! The Fast CAT test is a timed 100 yard dash for dogs. It is a fun and healthy activity for dogs and their owners which will answer the intriguing guestion In the FAST CAT®, dogs chase a lure in a straight line 100-yard dash and the dog's time is converted to give their average speed for the run in miles per hour. Owners can then see how fast their dogs can run!



Dogs can earn titles as well; each dog's speed is converted into points after taking into account their height handicap, and once a dog reaches a specified number of points, titles are awarded to all dogs that are at least twelve months of age and are individually registered or listed with the KC

(registered purebred, FSS, PAL or AKC Canine Partner). Most dogs instinctively chase the lure once it starts moving, the course is straight so no sharp turns are required, and the area is fenced to allow the owner to easily catch dogs who may not recall quickly.



Beagles (not exceeding 13 in. over 13 in. but not exceeding 15 in.). Dachshunds (longhaired, smooth, wirehaired), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard), Collies (rough, smooth),
- 2. The following categories of dogs may be entered and shown in Best of Breed competition; Dogs that are Champions of Record and dogs which, according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC (For complete rules refer to Chapter 11, Section 3).
