To earn the AKC Temperament Test (ATT) title, you and your dog must meet the following criteria:

- 1. Dog must have an AKC number. Must be Registered or Listed by having an AKC, PAL (Purebred Alternative Listing), or AKC Canine Partners number. All dogs, including purebreds and mixed breeds can get a number. AKC records titles by attaching them to a dog's number.
- 2. Must have passed the ATT <u>two</u> times. The test is given by an AKC CGC Evaluator who has been approved to administer the ATT. ATT tests are given in conjunction with AKC licensed events. To find an AKC Temperament Test near you, see: https://webapps.akc.org/event-search/#/search

AKC ATT Title Application Checklist

Have You Included Everything?

In one envelope mail to the address above:

Submit the AKC Temperament Test *Title Application* on the next page.

- Submit both of your "AKC Temperament Test Evaluation Forms" from the two different tests that you took with your dog. These should be sent at the *same time*, in the *same envelope* with the Title Application and fee.
- If you don't have an AKC number (or PAL number or a Canine Partners (CP) number), include the AKC Canine Partners form found online at: www.akc.org/akctemptest
 If you need the Canine Partners number, the fee for the number is \$19.00. This number can be used for all future titles earned.
- Submit the fees for the ATT title. **The title fee is \$25.00.** (Even though you are sending 2 test forms, you pay only one \$25 fee for the title).

Fees

Title only = \$25.00 Title plus Canine Partners number (sent in same envelope) = \$25 + \$19 = \$44.00
