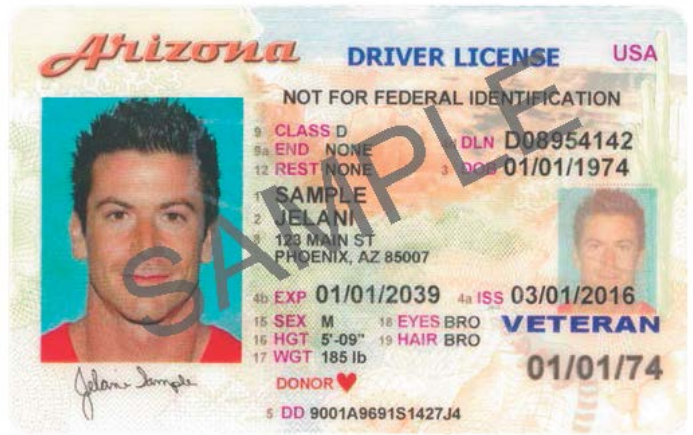



ARIZONA NON TRAVEL DL/ID REQUIREMENTS
