

## Bolivar Sportsman's Club Rules and Regulations

1. Hunting and fishing on farm, and or lease lands shall be held to members and their immediate family, spouse. (children and grandchildren under the age of 19)
2. You must wear you club badge while hunting and fishing on club property or leased land. you must be able to show proof of membership to any member on request at all times.
3. Any members or their family shall not hold the club responsible for any accident, injury, or damages.
4. All hunters shall acquaint themselves with the club land, farm, leased lands, and their boundaries.
5. Members are required to display parking pass while hunting/fishing/shooting on club property or leased land.
6. No one shall cut remove trees/shrubs or alter landscaping without written permission of the trustees.
7. All target practice will be performed on designated ranges: rifle, pistol, bow, and trap. Shooting ranges are closed when the clubhouse is rented. No shooting at steel plates or targets allowed. No one shall be on the pistol/archery range, while the rifle range is in use.
8. All members are required to follow all federal and state game laws while on said property.
9. Motorized vehicles must be kept on designated parking lots and roadways, always with a parking pass visible.
10. All members and their families are responsible for returning the clubhouse and property to original condition of cleanliness.
11. No dumping or refuse or brush of any kind without the written permission of the trustees.
12. No club property shall be loaned without the written permission of the trustees.

13. Clubhouse or property can only be rented to members, no sublets.
14. All tree stands and blinds must display you name and your assigned I.D # at eye level. No tree stands or blinds shall be erected more than 30 days prior to the start of the season, and must be removed no later than 30 days passed deer archer season. Tree stands maybe confiscated if not removed in this period of time, or if no I.D. is attached. Property confiscated will be held for 30 days in order to be claimed. You will be required to have an additional 10 work hours to receive your property back, or items will be sold.
15. All tree stands and blinds must conform to Ohio Hunting Regulations. It is unlawful according the club rules to construct, place or use a permanent tree stand or blind, or to place nails, wire, or other metal objects into a tree. This includes bow hangers, camera hangers, and other metal devices. No more then 2 tree stands and or blinds per member in any combination. This includes any of our leased lands. Members are not allowed to bring or use their own self-feeders.
16. Must have a signed permission slip and waiver in order to bring a guest. This is for shooting and trap ranges only. You cannot bring a guest for hunting or fishing.
17. No trapping without permission.
18. Any use of club equipment requires written permission from the trustees.
19. Any new members are required to work 10 hours per year, for their first 2 years in the club, in order to maintain your membership.
20. No member shall hold or be nominated for an officer position, if they hold an officer position in another sportsman club or gun club.
21. No ATVs my be used on the club property except for designated work parties, or to retrieve a dead deer, after it had been located, and a club trustee has been notified for approval. Designated times for tree stand/blind setup and removal. ATV use is confined to the designated access roads only. You are not permitted to drive through food plots, fields or woods that is off the access lanes. It is necessary to know where you want to put your stand/blind before the time allocated for stand/blind placement. It is permissible to tag the tree with you BSC tree stand/blind I.D (1 week) in advance prior. No vehicles other than ATVs are permitted beyond parking areas for use of transporting deer or tree stands to and from BSC property. In violation of the rules established will result in:

- A. Loss of all hunting privileges for the following season that offense has occurred.
  - B. Second offense will result in the loss of hunting privileges for 2 consecutive years.
22. Do not enter the woods behind the impact zones behind the shoot ranges at club house. If you wish to hunt the club side of the woods, you must enter from opposite side of the woods. Not from the club side. Stay away from the shooting impact zones. Safety bars on the shooting range, are not to be use for hunting purposes.  
The shooting range shall not be closed for hunting behind ranges. Know where you are at all times.
23. Posted Rules Must be Followed, by all Members. Any Violations or Rules may result in Disciplinary Actions.
