Definitions and Interpretation

- 2. In this Privacy Policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this Privacy Policy;

- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this Privacy Policy.

Scope of this Privacy Policy

- 3. This Privacy Policy applies only to the actions of Ian Gould trading as Kraken Driving School and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

Your Rights

- 15. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."  - b. Right to correct the right to have your Data rectified if it is inaccurate or incomplete.
