CLEANSING THE BLOODLINE FROM FREE MASONRY

As you embark on this journey, remember that this guideline will take time, a heart of repentance, and sensitivity to see the personal and generational iniquity and sins through the eyes of the Father. Each person's journey will be different with seasons of rest before continuing. Don't make the mistake of charging through this work without the guidance of the Holy Spirit. With His revelation and insight, there is victory. So many people have said that they have dealt with the bondage of Free Masonry. Yet they still remain in major regions of captivity. One afternoon of renouncing does not complete this work. Remember the Accuser is a legalist.

There is no quick access to freedom from the tentacles of Free Masonry and the occult. It takes a relationship with the Father developed through worship and times of intimacy. Spend time meditating and praying out loud Eph 3:14-21, Ps 91, Ps 121, Ps 23. Get The Passion translation of the Bible. It is a love letter from the Father. Devour the Word of God with a flinty faced decision to obey His Word. As you press for freedom, you will begin to feel a lightness as hope will flood your soul and your spirit man will be strengthened. There is a battle in your mind over the goodness of the Father, over His love for you, and that you truly are accepted n the Beloved. You cannot just do the legal work below without building up your spirit man for the battle.

As you begin this work, make it a practice to seal each session with the Proclamation of Covenant and the Sealing prayers from **Silencing the Accuser**.

 - Destruction of the Inheritance of Darkness

- 4. If you have a tribal bloodline, get **Repentance**: **Cleansing Your Bloodline** by Natasha Gribich to deal with the occult practices of the tribes. Available at www.amazon.com
- 5. After completing the above, go to the Court of Records and ask if there is anything in your Outstanding file. When you are given the file, you will be able to repent for accusations against you. Request the Holy Spirits assistance to deal with these outstanding accusations in the Mercy Court.
- 6. Go back to **Overcoming the Verdicts of Freemasonry** and now renounce each Free Masonry Degree.
- 7. Ask for access to the Court of the Occult to see if there is still anything outstanding in your bloodline that needs additional work. Often there are tentacles of curses that go back into the witchcraft in the generations.
- 8. Ask for permission to access the Court of Times & Seasons and ask for the cleansing of your time based on known cyclical patterns of interruption / destruction in your live and cleanse those years.
- 9. Proclamation of Covenant communion. Meditate on Is. 53 to come into the fullness of understanding regarding the finished work of the cross.
- 10. Ask permission to enter the Court of Ages to view the records from your generations that need specific work. This will often require a seer. Deal with the issues with repentance as the Holy Spirit directs to get a ruling from the Just Judge of Not Guilty.
- 11. Ask permission to enter the Court of Destiny and request the restoration of all the lost years that the locust has consumed in your life.
- 12. Certificate of Betrothal to the Lamb of God from Silencing the Accuser.
