**Important:** The Renovator – Initial course is being offered as a one day, 8 hour course, (8:00 am. to 5:00 PM.) and the 8 hour course can also be offered in the evening over two days, from 6:00 PM to 10:00 PM, each day. Attendance for the entire 8 hour course is mandatory for certification. The refresher course is a 4 hour course, and you must submit your last EPA RRP Class certification. The EPA RRP Class includes two hours of required hands-on exercises. Comfortable work attire should be worn. At the discretion of the Training Manager, classes with less than three participants, may be canceled or moved to a different date. No refund will be issued if student cancel or is a no show, within 4 days of scheduled class date.
