On 11/2/00, Ivan + I argued about something + I questioned him about some of his dealings. He got real upset + ran

AB

to get his pistol. He came into the living/dining area + fired a shot over my head, + then put the gun to my head. He then told me that this was a warning to let me know he was serious. He said that I shouldn't fuck him over or mess with him. I got up + tried to leave + he slammed the door on my hand.

We were supposed to leave the next ^{AB} morning day (11/3/00) + drive to Arkansas as soon as Ivan got in from work. When Ivan got in from working at Soup + Salad, it was about 1030 - 1100 P.

When Ivan got home, he told me that he was going to kill James + Amy. He didn't seem upset or agitated when he told me

the.

He then left & went to the grocery store & returned after about 20 minutes or so.

~~Down~~ While Ivan was gone Melonie (LNU) came over & she was there when he came home. We were going to meet Melonie & her husband later at Club 7. Melonie left a short time after Ivan returned home.

Ivan called James & told him he need to come talk to him. Ivan got off the phone & stated he was going to James' house. I called Melonie while Ivan was gone.

When Ivan left, I wanted to call James & warn him or even run away, but I was afraid to.

Ivan was gone & he returned home at 12:18 by our clock. He had driven Amy's Mercedes back to our house & he had blood on his jeans. He was also wearing James' shirt & shoes. He was also wearing rubber type gloves. Ivan said James had hit him with something, & that it

wasn't pretty. He also told me that Amy had told ~~me~~ ^{him} what he wanted to know. He then told me ~~what~~ ^{to} get ready to go to ~~the~~ ^{the} Club?.

Juan put his jeans, socks, the gloves, & emptied the bullets from ~~the~~ ^{his} gun into a kitchen trash can.

The gun that Juan was unloading into the trash can was the same he always carried & also the one he fired at me. I also noticed there was what appeared to be blood in Juan's hair & on the gun.

Juan had James ~~Smith's~~ ^{AP's} identification, keys & wallet ~~of~~ ^{of} Amy's identification with him.

Juan showered & changed clothes, then ate some ~~fruit~~ ^{fruit}. When Juan was in the shower, he told me to go & park the Mercedes "correctly", so I went down & parked it more straight than it had been.

~~He~~ ^{we} left & went to Smiley's house &

Ivan got about \$1500 from Smiley & we left.

After this we went to the crime scene. I saw the dog in the kennel & James & Amy's bodies were in the bathroom. Amy was on the floor & James was lying on the bed face up. Ivan then told me that this was to show ^{AP} ~~me~~ ^{me} that he was not looking around, & that this is what happens when people screw ^{up} ~~me~~ ^{him}.

He told me he was looking for ^{AP} ~~me~~ ^{me} E King's old car and some money & his cell ^{AP} ~~phone~~ ^{phone}. He also told me to grab his boots.

I looked through the cupboards, the fridge, & the desk drawers in an office.

Ivan asked for a garbage bag to put the bloody clothes in. He got a bag & put his bloody shirt inside as well as James jeans. ^{AP} ~~He~~ ^{He} also put another shirt in the bag.

We were at the house for about 20 minutes before leaving. We left & Ivan was driving the Corvette & I was driving the Honda. We went back to our apartment. We were only there a short while. Ivan asked me if I would marry him & he put a ring on my finger. The ring had a large stone in the center & some smaller stones; the setting was platinum colored.

I remember seeing a black & white pickup truck before we left James' house. Ivan told me that they were there to clean up the house.

We left our apartment & drove to Club 7. Before we got to 7, Ivan threw out the bloody clothes in a dumpster. Located about a block away from the club.

On the way to 7, Ivan threw out a Rolex watch that belonged to James.

We got to Club 7 & Ivan parked the car. He wasn't able to get voted

parking because it was so late. It was probably around 3:00. 315 by now.

We left the club about 3:45 and went to Hollands house. ~~XXXXXXXXXX~~ ~~XXXXXXXXXX~~ we then went to another house & got some dope.

We then went to Smiley's house & Ivan gave him some money. Smiley saw the corvette & Ivan told him it was his (Ivan's) car.

We made one more stop & finally got back to our apartment around 12:00.

We then left & drove to Arkansas & arrived late on 11/4/00. We stayed here until Tuesday 11/7/00. While we were here, Ivan called back to Texas & talked with his relatives & also to a Detective. We left Arkansas on Tuesday & got back to Texas the same night.

We drove to Towny's when we got to Texas. Ivan left & went to our

apartment, & came back later with
the inventory sheet. we stayed at
Tawny's & Ivan went to talk to

NARRATIVE:

On November 10, 2000, Sgt. Mark Hollingsworth with the Arkansas State Police (870-368-4203 / Fax# 870-368-5226) called regarding Amy Boettcher, Ivan Cantu's girlfriend. Sgt. Mark stated that Amy and her stepfather wanted to talk to someone about what her boyfriend, Ivan did in Dallas. * 870-425-2721 888-489-5117 pager

Sgt. Mark stated that Amy was currently staying with her parents not far from police headquarters and had no intentions of leaving. Sgt. Mark assured Reporting Detective that he did not believe Amy was a flight risk. Sgt. Mark stated that he would happy to assist by interviewing Amy and locking her into a statement of the accounts that occurred as she remembered them.

Amy gave the following account to Sgt. Mark:

1. Amy stated that on Thursday, November 3, 2000, she and Ivan where inside their apartment arguing. She stated that Ivan pulled out a gun (semi-auto) and shot a hole in the wall, he then put the gun to her head and told her something to this effect "This is what happens to people who " FUCK" me over."
2. On Friday, November 3, 2000 between 11 and 11:30 p.m., Ivan called the complainant. Amy stated that when he hung up the phone he told her that he was going over there and kill them. She stated that Ivan left and came back at 12:18 a.m. She remembers the time he returned because she looked at the clock.
3. When Ivan cam in he was covered in blood and he was wearing surgical gloves. Amy stated that he took the gloves from the box of surgical gloves setting on their kitchen cabinets. Ivan had the complainant's keys, wallet, I.D. and Rolex watch. He took the gun out and emptied the bullets into the trashcan. He took his bloody pants and socks off and put them in the trashcan along with the

surgical gloves. He was driving the complainant's Mercedes.

4. Amy stated that Ivan made her go back to the complainant's house with him. She stated that when they got to the house he made her look through the cabinets for drugs and money. Amy stated that she did not want to look at the bodies but she saw Amy Kitchen lying on the bedroom floor and the complainant was lying on the bed looking up toward the ceiling. Amy stated that Kitchen was wearing a gray or white top with dark shorts.
5. Ivan took the complainant's corvette when they left and Amy followed him back to their apartment. They were suppose to met some friends at Club 7 in Dallas off of Pacific (2505 Pacific), they got there about 3:00 a.m. Saturday morning. Ivan threw some bloody clothes into a dumpster at or near Club 7. They were clothes that he had taken from the complainant's house. They took the toll road to Club 7. Amy stated that they were on the toll road, had gone through the toll tag side at Frankfort and about a block past the tollbooth, Ivan threw the Rolex out of the driver's window.
6. Ivan gave Amy the diamond ring that he took from Kitchen but later took it back. She stated that she did not know what he did with the ring. Sometime during the evening/early morning hours, Ivan borrowed \$1,500.00 from somebody and paid them back later after he made a drug deal.
7. They left for Arkansas because they had already arranged for Ivan to meet her parents. They were supposed to have left for Arkansas on Friday. Ivan told her to tell her parents that they did leave on Friday but they got tired and spent the night in a motel. They arrived at her parents house about 8:30 p.m. on Saturday, November 4, 2000.
8. Amy's father told Det. Ned that he became worried because they were several hours late. He stated that he called the Arkansas State Police and had a BOLO put out. Sgt. Marks' stated that he could check and see if in fact a BOLO was put out.
9. Amy stated that they returned to Dallas on Tuesday and went to Ivan's old girlfriend's apartment, Tawny. She stated that Ivan left the gun, several hundred dollars and some cocaine at Tawny's apartment.
10. Amy stated that Ivan put the complainant's wallet and i.D. in a Burger King bag and threw it in a dumpster. She stated that the dumpster is located at the apartment complex next to Tawny's complex. She stated that they turned into the first entrances closest to Tawny's complex. The first two dumpster that you come to, he threw the bag into the dumpster closest to the building.

Sgt. Mark stated that he would send Reporting Detective a copy of the notes from the interview with Amy B.

Sgt. Mark suggested that if a Detective goes up to interview Amy B. that they take Big Sky Airlines into Mountain Home. Mountain Home is about 45 minutes from where Amy B. is staying. Little Rock is about 3 or more hours from the location. He also stated that he would pick up the Detective and make the necessary arrangements to meet with Amy.
