1:15am	- My girlfriend and I get to Kevin's apartment. Kevin has several people
	over and has decided not to go out for the evening. Kevin is going to
	stay home and host a little get together at his apartment. My girlfriend
	and I still want to go out, so we make the decision to leave.
1:35am	- My girlfriend and I leave Kevin's apartment, and were heading to
	Club 7 to go dancing.
1:43am	- Tollway records will confirm Im traveling West on the tollway at this
	time. Im still driving the Mercedes.
2:30am	- I call Amy Kitchen on the cell phone. The cell phone I used is not
	the one mounted, the one I was used an extra cell phone James and Amy
	had which was left in the car. When I called I wasn't wanting to
	specifically talk with Amy Kitchen, she just happened to answer the
	phone. I mentioned that one of the Mercedes tires is losing air, and
	since Im heading downtown I cant drive this car and Im coming back to
	pick up the Honda Accord. Amy Kitchen said okay and when I got to the
	house press the garage door opener in the car, and she'll come out
	through the garage once she hears it raising.
2:35am	I arrive at James and Amy's home on Gibbons. When I pull up I press

	the end of the street. She pleads with me to come back and switch cars.
	Amy said that James still wants to portray that they have company
	through the evening, and for me to drive James's Corvette till the
	morning. When Amy called me I could hear James in the background
	telling her what to tell me. (So at this time I know there both still
	alive). I turned around and headed back towards James and Amy's house.
2:39am	Amy Kitchen comes out front of her home through the garage to meet me.
	I again leave the Honda Accord out front and give Amy the spare key
	to the Honda. At this time I only visit with Amy Kitchen, and she
	mentions thanks for taking the Corvette and please bring it back in the
