**Treasurer's Report:** BO provided a hard copy of the Balance Sheet dated October 21, 2025 and the Profit & Loss Statement for the time period of September 24, 2025 through October 21, 2025. - All of the swim platforms and docks have been removed from the lake and positioned onshore. The docks on the right side of the launch ramp have been left in the water and will be available for use until mid-December.

## **New Business:**

- > DL indicated that he, Sam Clark, and Jesse Jones met with the representative from Homer City Redevelopment on October 2, 2025 to discuss the renewal of the lease agreement. The Association's lease renewal proposal which included an introductory letter by JJ and the Association's recommendations including, the 2025 decrease in membership and supporting financial information was favorably received. HCR has indicated that they will do their best to get back to the TLLRA with the new lease agreement before Thanksgiving.
- MS indicated that the annual pumping out of the sewage holding tank has been completed and that the housekeeping activities have been suspended for the year with a deep cleaning occurring the last week of September.
