I agree to release Donner Ski Shop, it's employees, owners, affiliates, agents, officers, directors and the manufacturers of this equipment, collectively "providers, from all liability for injury, death, property loss and damage which results from the equipment user's participation in the sport of skiing, snowboarding, snowblading, cross country skiing, ice skating, snowshoeing use, or is in any way related to the use of this equipment, including all liability which results from negligence of providers, or any other person or cause.
