- Designated number of weekly dumpster service is included in chosen monthly fee.
  - A charge of \$50.00 plus fuel surcharge is charged for any unscheduled dumpster service.
  - Fuel surcharge for unscheduled dumpster service is:  
    0-10 miles \$20 Per Trip    10-20 Miles \$30 Per Trip    Over 20 Miles \$40 Per Trip
  - Billing will be mailed monthly and due by the 25<sup>th</sup> of each month.
  - Customer must notify County if Customer wants services terminated and container removed.
  - Service will be discontinued if payment is not received by due date and container will be removed.
  - Customer is legally responsible for all past due balances and costs of collection.
  - Payments may be mailed (with the exception of cash) or made at the Solid Waste Department.
  - Sanitation drivers are not allowed to accept payments.
  - There is a \$30.00 fee for each payment that is returned dishonored.
  - To reinstate a discontinued/delinquent service the following conditions must be met.
    - a. Delinquent balance must be paid in full.
    - b. Current balance of service must be paid in advance.
    - c. Delivery fee of \$50, plus the fuel surcharge fee above, per container if container(s) has been picked up by the Solid Waste Department due to delinquent account status.
  - Customer is responsible for loss or damage while container(s) on their premise.
  - During warm weather, containers will be sprayed with disinfectant periodically.
  - To relocate container(s) contact the Solid Waste Department. Do not attempt to relocate containers.
  - Container(s) must remain unblocked for easier access or it will not be serviced.
  - Do not burn anything inside the container(s).
  - Container(s) cannot hold items that individually weigh over 50 pounds.
  - Container(s) should not be packed tightly to insure proper removal.
  - Service charges and rates are subject to change.
