

Park Meeting Minutes 9/11/25 – Public Meeting on Rec. Plan

Pledge of Allegiance

Public Comment:

1. Ted Johnson (via e-mail) – Western Great Lakes Pilots Assoc.
 - a. Add WGLPA to list of community partners
 - b. \$5,000 donation
 - c. Able to contribute to volunteers and donors

2. Tracey Laitinen (via e-mail) – Soils & Structures – WGLPA contractor
 - a. Need to mention / include periodic low water levels of the lake as it impacts tourism / local usage of Waitska Bay.
 - b. Motion to include paragraph to Rec Plan referencing these concerns by Lori, Heidi 2nd, unanimous.
3. Dave W. (personal conversation with Jim Busha)
 - a. Dave is prepared to sell property to the local snowmobile association for the construction of a 'groomer shed'.
 - b. The snowmobile association (Jim Busha to obtain group's formal name) would not be able to provide signage for snowmobile groups to navigate through the park.
 - c. Add snowmobile club to list of community partners

 - b. Final count (& deposit) of 'Music in the Park' sales - \$388.50 with a donation of \$1,000 for total of \$1,388.50 for 2025. All remaining product after CPR class donations are to be transferred to the firehall for Halloween distribution.
