The officer in charge of the Department shall have power to assign equipment for response to calls for outside aid in accordance with Article 7, and in other cases only when the absence of such equipment will not jeopardize protection of this Township.

All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

I would recommend as well that article 2 of Section 6 also be deleted. The effect of this provision, in my view, is to cloak the ordinary member of the Department with the powers ordinarily vested in a peace officer for which I find no authority in the law.
