1.	The eligible species is Snapper and Gummy Shark only, capture/release is restricted to waters reached from Port Welshpool - Including Corner Inlet and adjacent offshore waters.			
2.	The competition begins Friday 15th November 2024 at 12pm midday - Ends at 3:00pm Saturday 23rd November 2024. Completed entry forms with full payment must be submitted to SGGFC Event Organizer's prior to fishing.  All entries are to be submitted prior to fishing.			
3.	Entries are online preferably thru the link provided however entry forms are also available on the South Gippsland Game Fishing Club Inc. Website <a href="https://www.sggfc.com.au">www.sggfc.com.au</a> Completed forms can be emailed to SGGFC Social Committee <a href="mailto:sggfc.fishing@gmail.com">sggfc.fishing@gmail.com</a> or posted to: P.O. Box 288 Leongatha, VIC 3953. Entries receive a complimentary 'Snapper + Gummy Challenge' Brag Mat & Fishing shirt			
4.	Minimum size of fish accepted is as per the current Victorian recreational fishing guide.			
5.	Bag Limits per species apply as per above mentioned guidelines.  Fish MUST be measured on the OFFICIAL brag mat provided to competitors by SGGFC, and will be measured as per Victorian Recreational fishing guidelines. For the competition Snapper being a forked tail fish are to be measured to the fork in the tail. Photo's of measured fish, angler name, date, time will be uploaded to Track My Fish App which entrants will download onto their Smart phones. More detail on this will be provided, this app has been used successfully in many Competitions Nationwide and is a great way to track the Leaderboard.  As proof of location and time of capture SGGFC Committee members may request to see photo of fish on competitors phone as proof, Competitors are advised to have location services turned on while photographing fish. Any locations provided will be confidential.			
7.	All photo's must be received prior to 3:00pm Saturday November 23rd, no exceptions. Presentations will follow the event at 5.30pm.			
8.	The SGGFC Event organizing Committee reserves the right, without reason to refuse any application for entry.			
9.	By entering the competition, all competitors acknowledge that they give the SGGFC Event organizing Committee the right to use all; or any photos or video taken during the competition for promotional or advertising purposes.			
10.	The sole adjudicator on all matters shall be the SGGFC Event organizing Committee.  All decisions are final no further discussions or correspondence will be entertained.			
11.	The SGGFC Event organizing Committee reserves the right, without reason to cancel the competition at any time.  All participants will be entitled to a full refund subject to event cancellation, (Weather affected)  At the SGGFC's earliest convenience.			
12.	Disputes and challenges will only be considered by the SGGFC Event Organizer's if made in writing providing all relevant facts are presented to the weigh master no later than 15 minutes after the close of weigh-in on Sunday November 23rd.  Disputes and challenges will not be accepted once the presentation of prizes commences.  Any person found to be in breach of these rules or conditions of entry shall be subject to disqualification from the competition any prizes involved.			
13.	This competition encourages all attempts by anglers to "catch and release" where possible. It would be appreciated that 'non-leader board' fish be considered for release throughout competition.  We also recognize the right of Competitors to take fish within bag limits applicable.
