Purpose of Agreement:

This contract establishes that the Breeder retains ownership and breeding rights to ______while placing him/her in the Guardian's care. The Guardian agrees to provide a loving, stable, and safe home for ______and will collaborate with the Breeder on ______care, health, and breeding activities.

1. Responsibilities of the Guardian

• Daily Care: Guardian agrees to provide ______ with proper food, shelter, regular exercise, and veterinary care.

• Housing: _____ must live indoors and not be left outside for prolonged periods without supervision.

Training & Socialization: The Guardian will ensure

_____ is trained, socialized, and well-behaved in various settings, using positive reinforcement.

• Veterinary Care: The Guardian will cover routine veterinary care (e.g., vaccines, deworming, check-ups). Any breeding-related expenses (e.g., genetic testing, specific health clearances) will be the responsibility of the Breeder.

• Preventative Care: The Guardian will maintain flea/tick/heartworm prevention according to veterinarian recommendations.

2. Breeder's Rights and Responsibilities

• Breeding Rights: The Breeder retains exclusive breeding rights for _____, determining the timing and terms of any breeding activities.

• Access for Breeding: The Guardian agrees to make _____ available for breeding purposes at times specified by the Breeder, with reasonable advance notice.

• Medical Testing: The Breeder will cover costs associated with any breeding-specific tests or genetic health assessments. These tests will be conducted as needed to ensure the health and eligibility of the dog for breeding.

• Emergency Support: The Breeder will provide emergency support if ______ requires medical treatment related to breeding activities.

3. Duration of Guardianship

• This contract will remain in effect until the Breeder determines_____ has completed his role in the breeding program, or as agreed by both parties.

• Upon completion of _____breeding career, full ownership will transfer to the Guardian, provided the terms of this contract have been fulfilled.

4. Health and Safety Requirements

• Injury or Illness: The Guardian must inform the Breeder immediately of any significant illness, injury, or behavioral issues.

• Neutering: _____must not be neutered without the Breeder's explicit written consent. If neutering is required for medical reasons, both parties will discuss and agree on next steps.

• Accidental Breeding: If accidental breeding occurs, the Guardian must notify the Breeder immediately.

5. Financial Terms

• Breeder's Expenses: The Breeder covers costs for any breeding-specific expenses (e.g., stud testing, health clearances).

• Guardian's Expenses: The Guardian is responsible for day-today expenses, including food, general veterinary care, and routine preventative care.

6. Transfer of Ownership

• At the end of ______. breeding career, ownership will transfer to the Guardian without additional fees, provided all terms of this agreement have been met.

7. Termination of Agreement

• This agreement can be terminated under the following conditions:

• Breach of Contract: Either party may terminate the contract if the other fails to fulfill their responsibilities.

• Mutual Agreement: Both parties may agree to terminate the agreement.

• Inability to Fulfill Role: If _____cannot continue in the breeding program for health or behavioral reasons, the Breeder will decide on further steps, which may include neutering and full transfer of ownership to the Guardian.

8. Miscellaneous

• Non-Transferability: This agreement is non-transferable. The Guardian cannot sell, transfer, or rehome ______without written consent from the Breeder.

• Jurisdiction: This agreement is governed by the laws of Georgia
