- a. Neighborhood Security
 - i. Is there a battery backup to the solar system? The camera needs 2.5/hrs of sunlight to charge for full day.
 - ii. If camera or battery malfunctions, FS replaces
 - iii. We are responsible to lost/stolen/damaged Cameras do have GPS
 - iv. Camera mainly focuses on license plates not individuals.
 - v. Installation fees to be waived.
 - vi. VC Sheriff is not set up to receive real time data. We would need to provide information. Our "Under Sheriff" has agreed to look into partnering. Los Lunas PD is set up with FS.
 - vii. Flock to provide info on other areas in VC using system.
 - viii. Infrared camera will illuminate license plate at night regardless if car has light on plate unless reflective coating is removed
 - ix. Advanced search feature helps allow search of unmarked vehicles
 - x. Motion activated Will pick up dirt bikes, ATVs, SXS
 - xi. Kurt's concerns regarding company:
 - 1. 12% of yearly dues
 - 2. Costs have increased 55% in 7 years
 - 3. We have an agreement to contract for 1 year vs 2 years
 - 4. Danny to look into any potential price increases in the next few years
 - 5. Reviews: Not good. Issues with LPRs in general. Mistakes can be made
- b. Kurt is resigning from roads committee. Will continue to end of the year to assist with transition.
- He is also resigning from Website manager. Will help until end of year.
