We intend to accomplish this by looking at precedents, compromising when applicable, and by revising the covenants. 1998 was the year of the new bylaws. I hope 1999 can be the year of the new covenants.


### Runway Setback Moratorium

In December it was discovered that a new structure was finally going to be built in the commercial section by the EAA and Warren Janke. The plans for this structure were approved a year ago by a previous board and architectural committee.

FAA guidelines regarding runway setbacks call for 75' from centerline plus a slope of 7 to 1 (see figure below). As noted in the President's Message, this airpark was not designed with these setbacks in mind. In the interest of safety, your Board is in favor of coming as close to this recommended setback as is reasonable, given airpark layout and precedents.

The closest existing structure to the North-South runway centerline, (not counting the South over run area) is the Los Lunas Bicycle Shop/Hangar. A creative solution to the EAA/Janke hangar placement was proposed by Kurt Winker and accepted by the EAA and Warren. It calls for the combining of two lots and a setback no less than the bicycle shop.

In light of this compromise, your Board and its Architectural Advisory Commit-



tee would like to ask that a morotorium be observed on construction of any structures over 9' tall within 137' from the north/south runway centerline, south of east/west drive. This moratorium is in place until the covenants can be revised by the Architectural Advisory Committee and approved by the membership.
